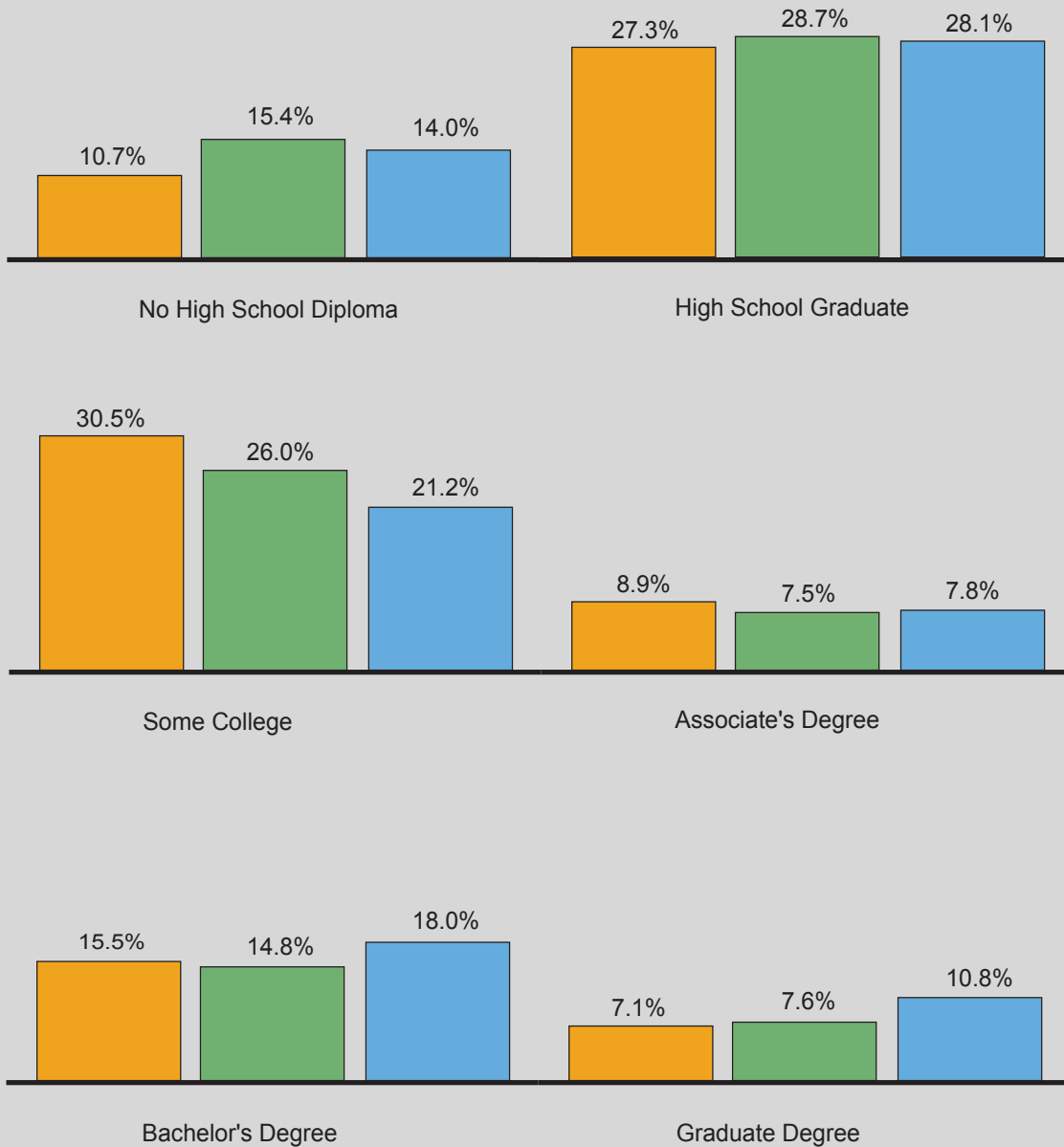

Educational Attainment for Population 25 Years and Over



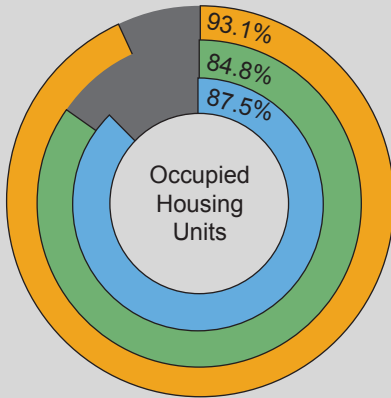

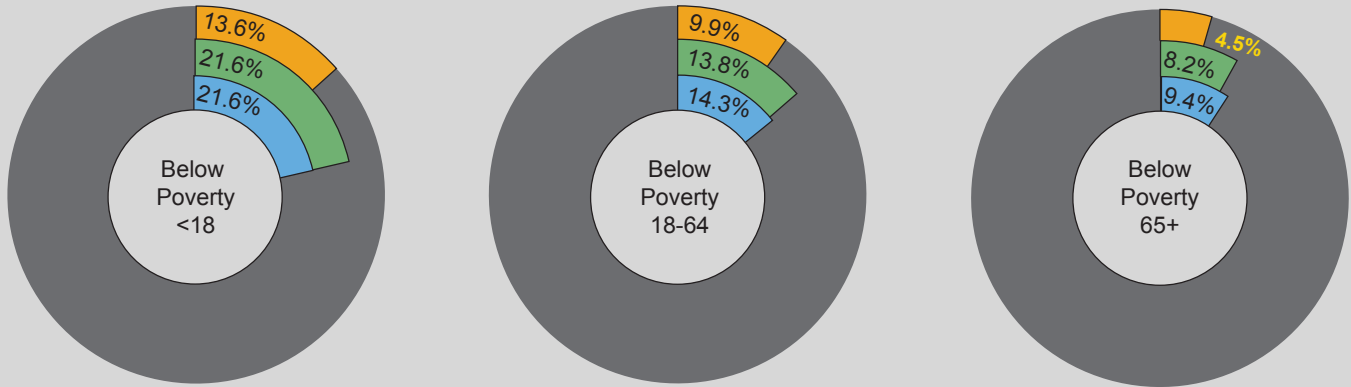

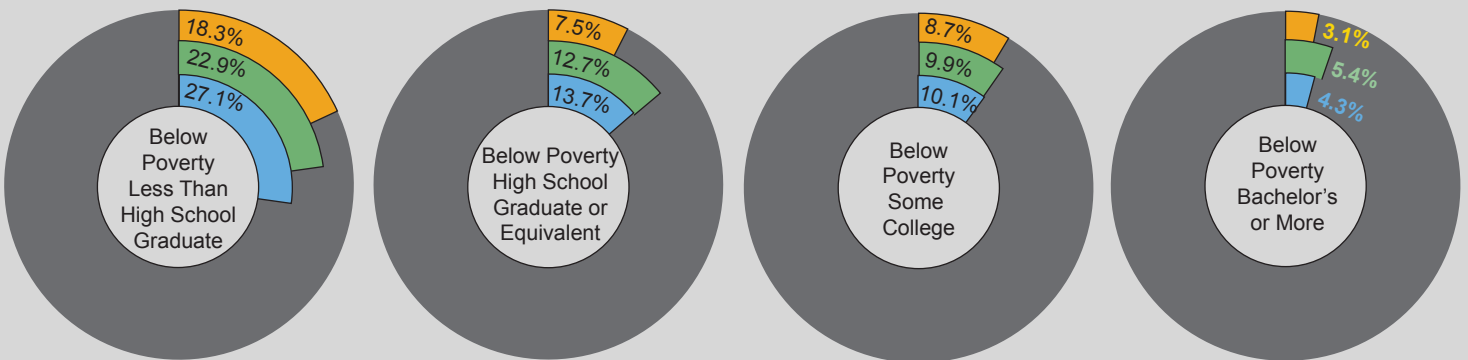
Poverty Level by Age

Poverty Level by Education



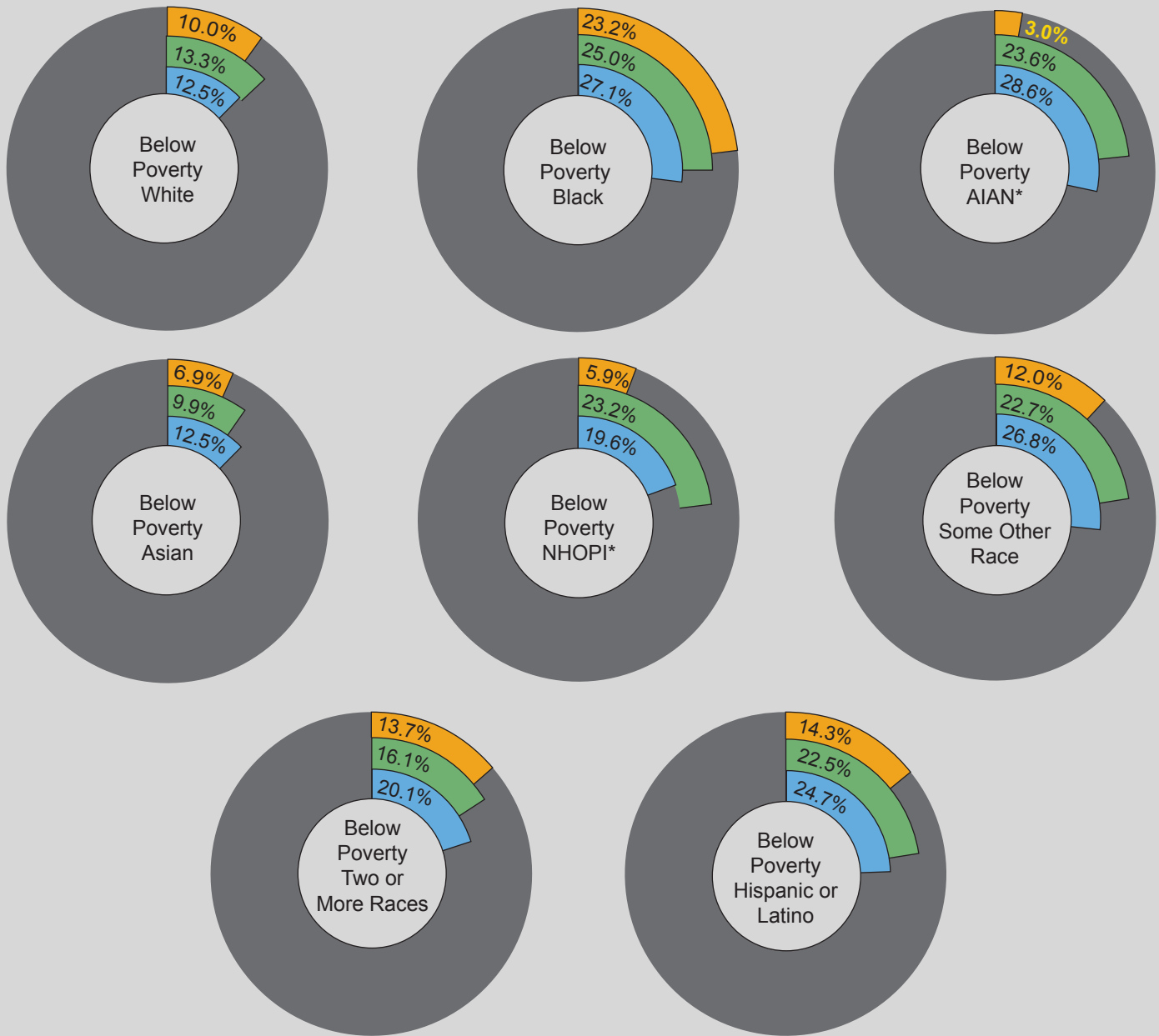

Health Insurance by Age

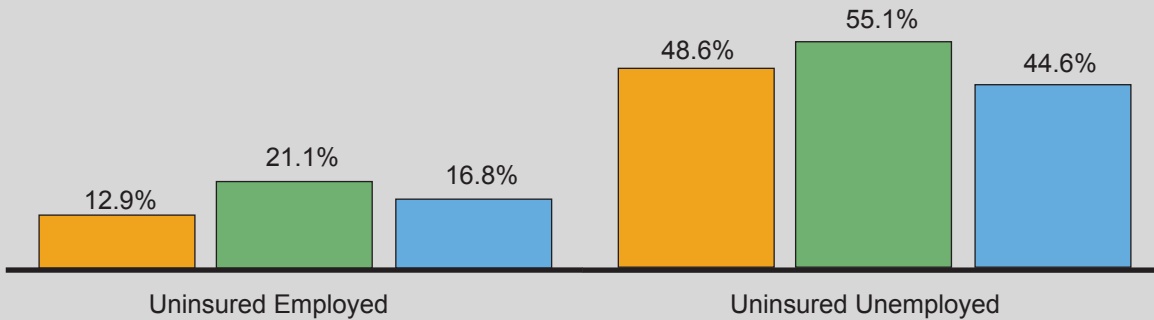

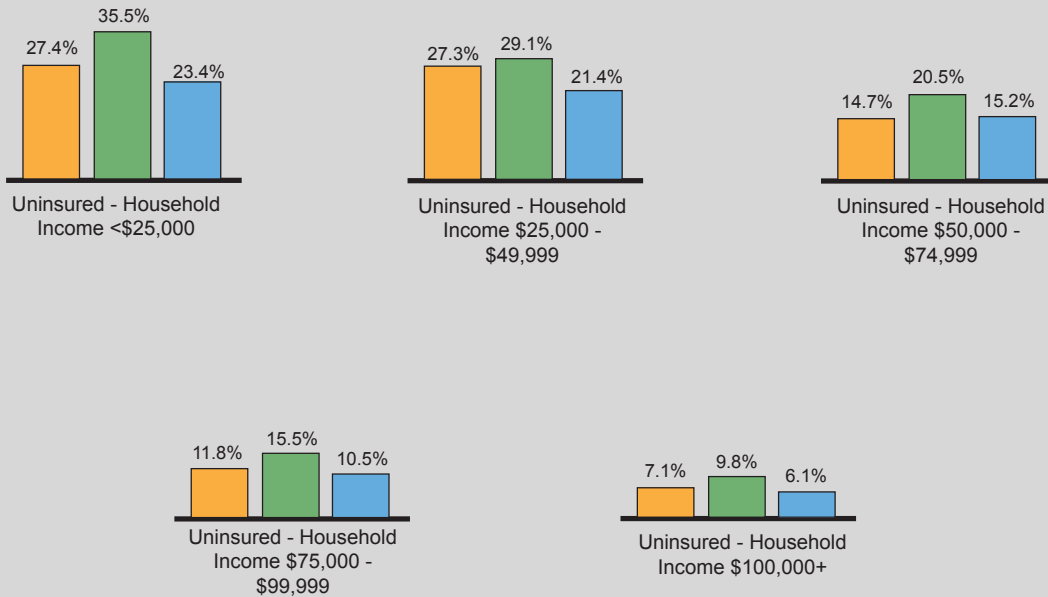
Health Insurance by Employment Status

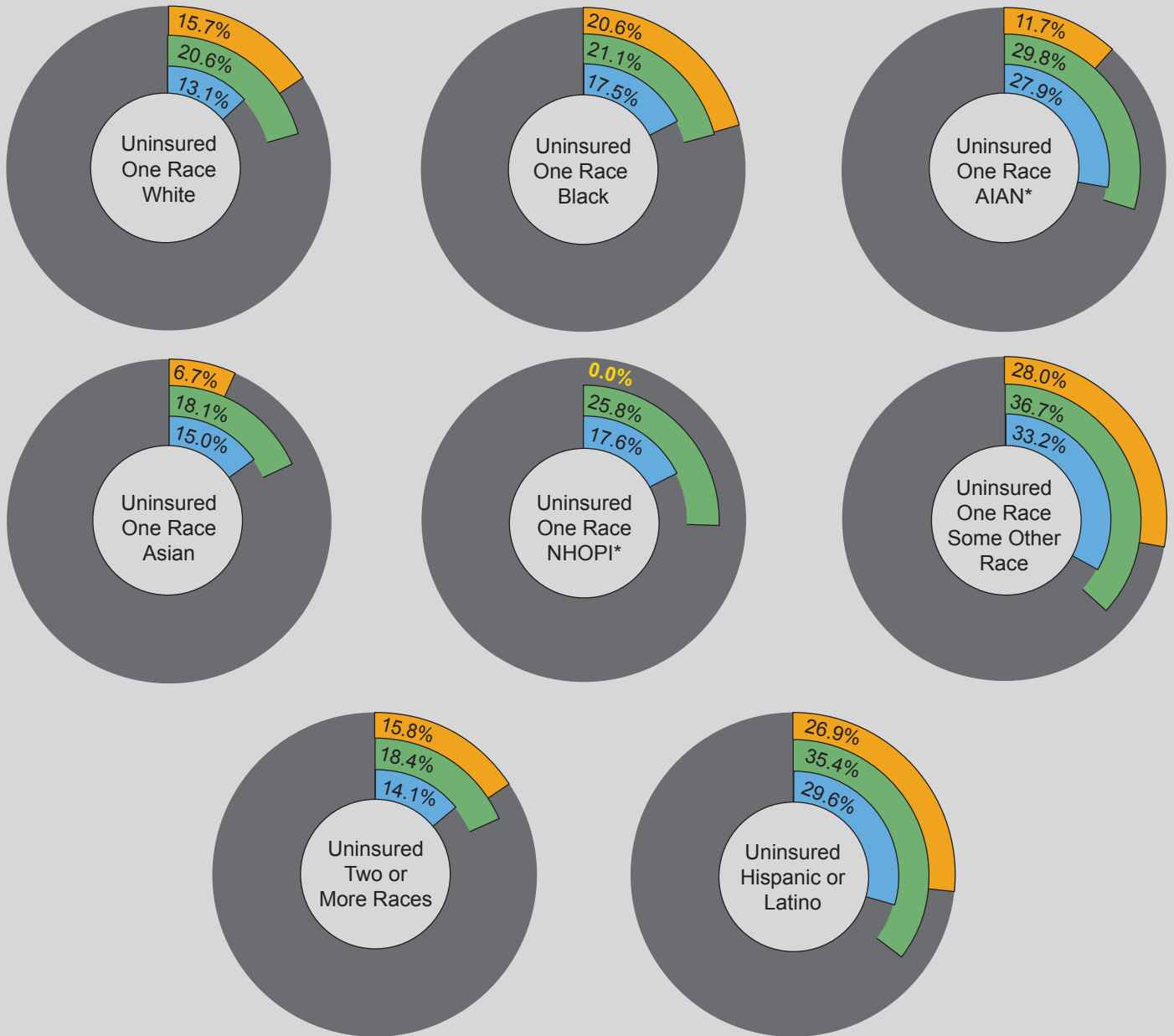

Demographic Profile of Nevada Assembly District No. 31 of the 78th Session (2015)



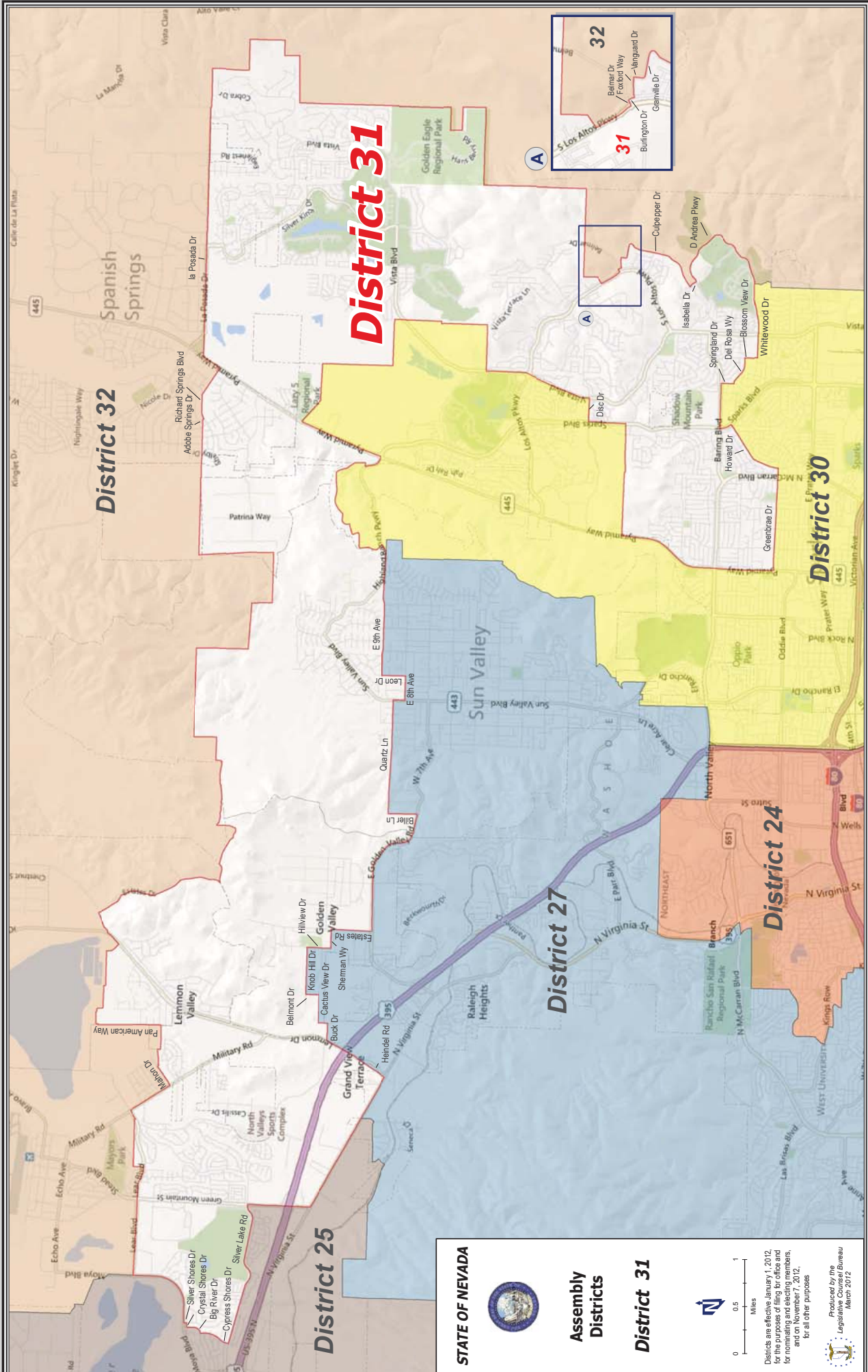

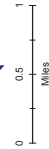
