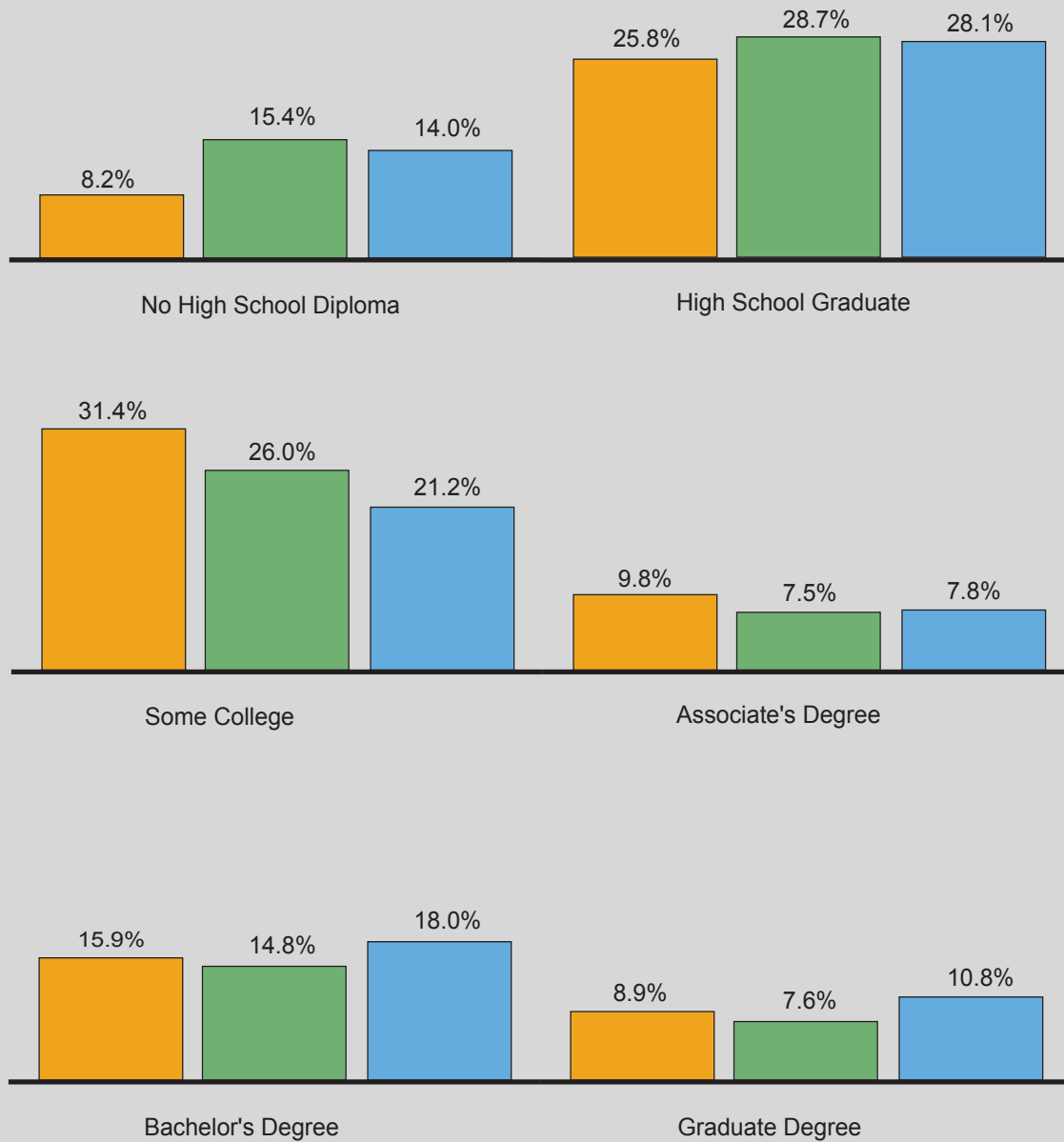

## Educational Attainment for Population 25 Years and Over



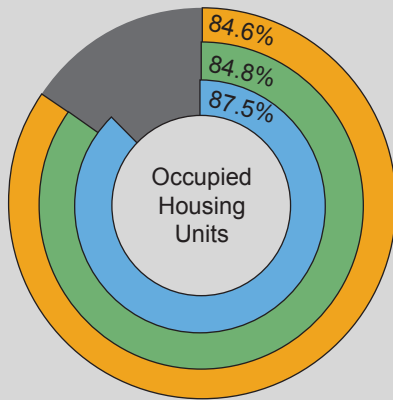

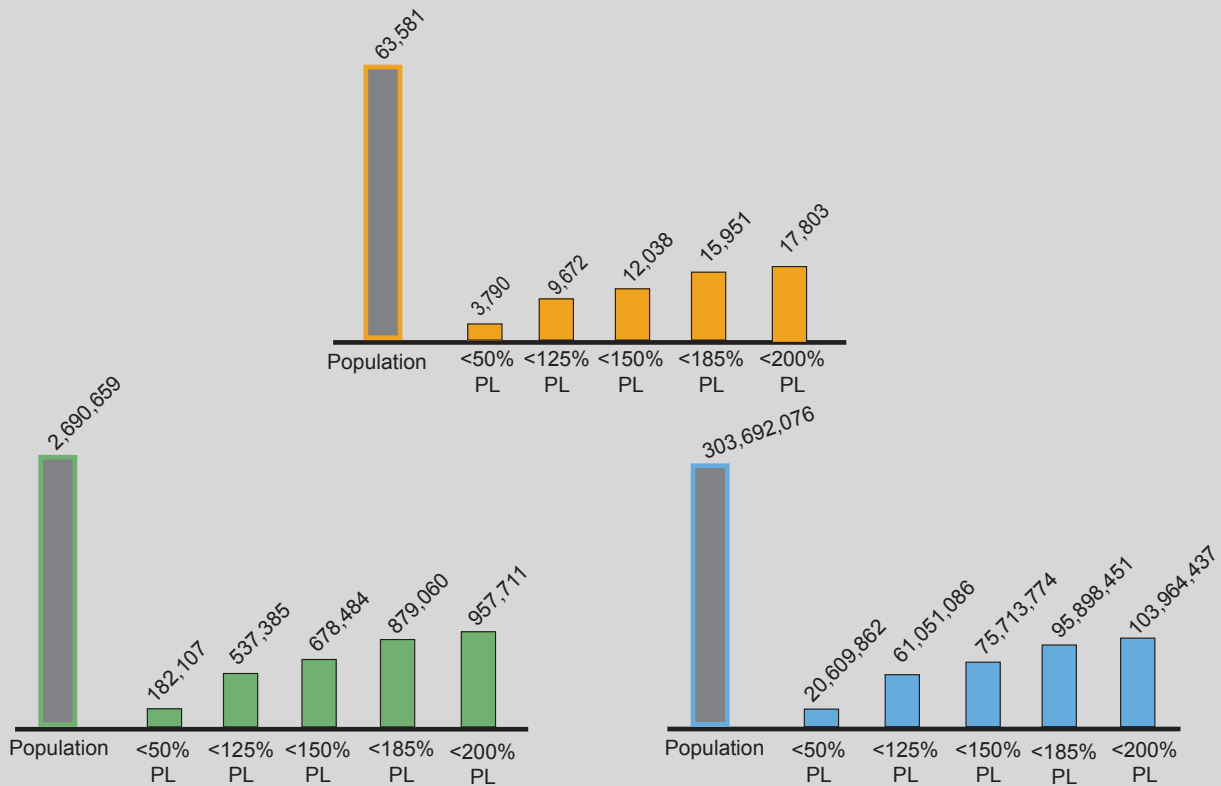

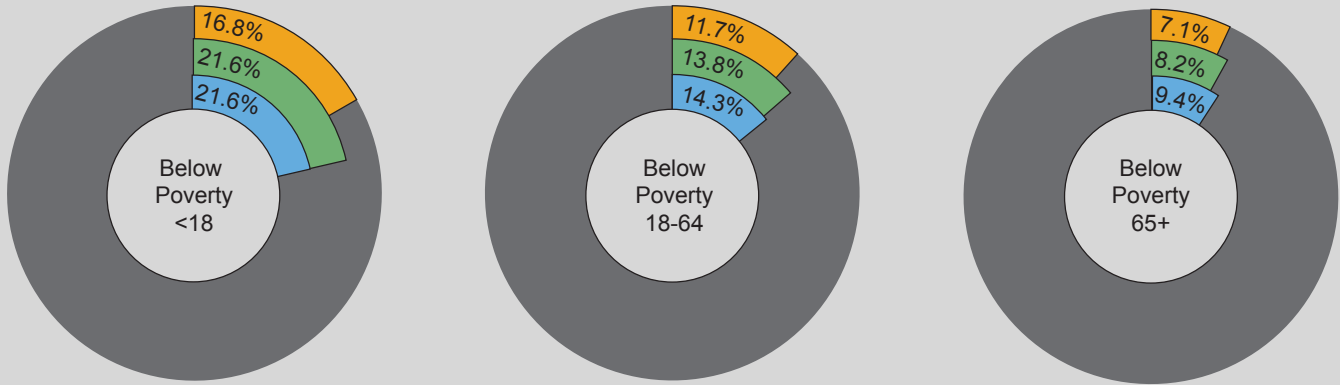

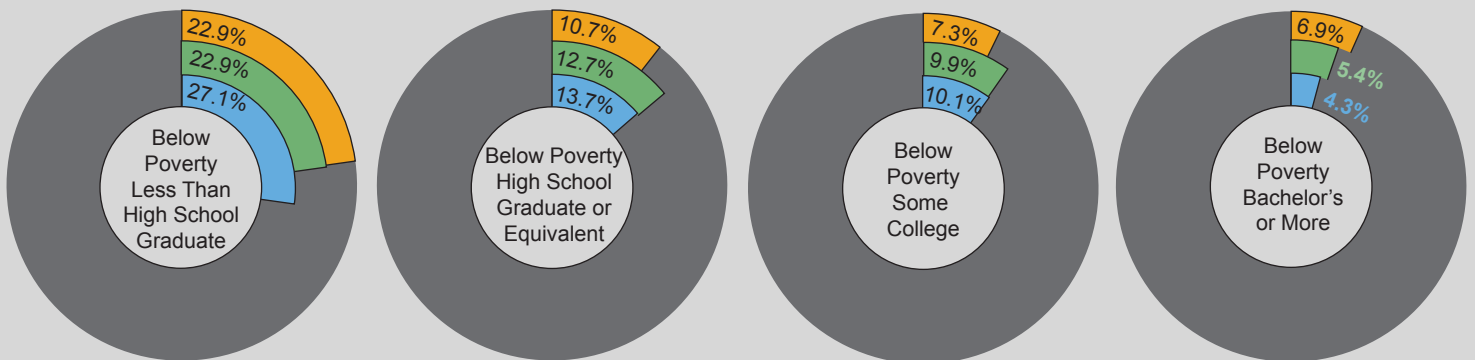
## Poverty Level by Age

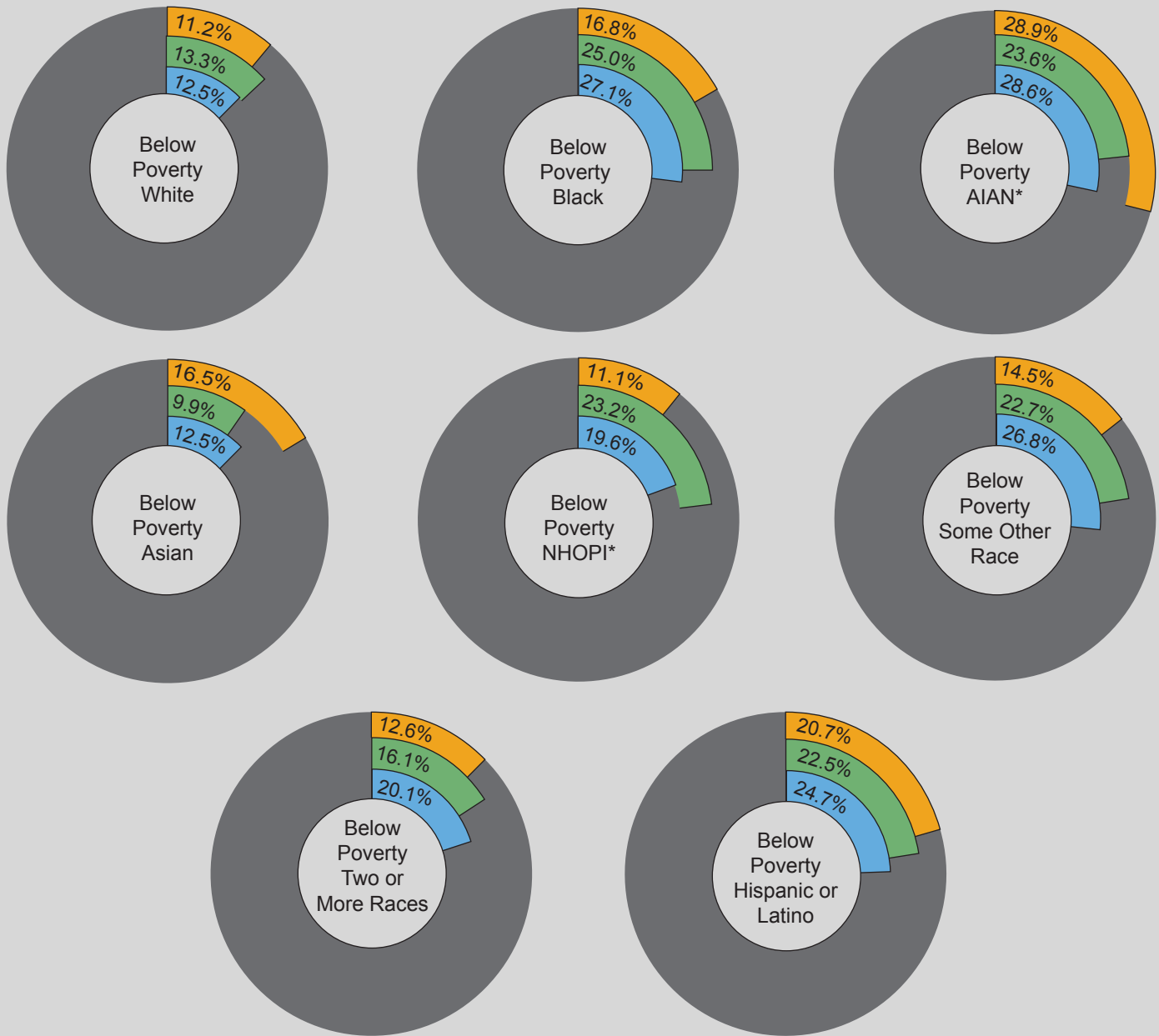

## Health Insurance by Age

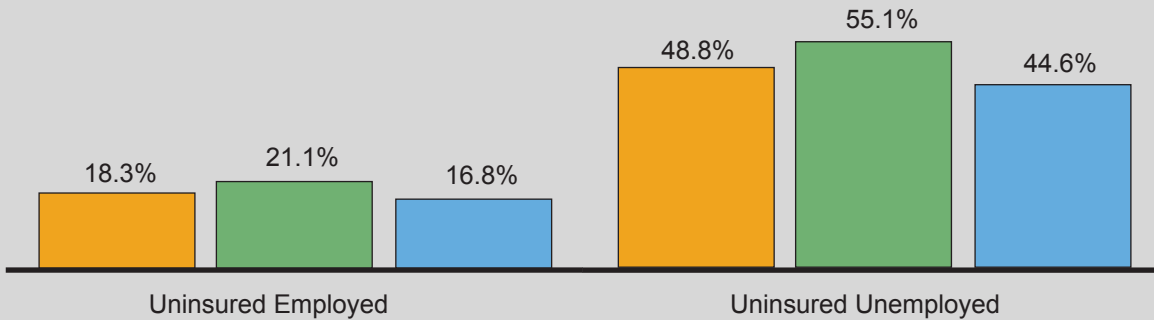

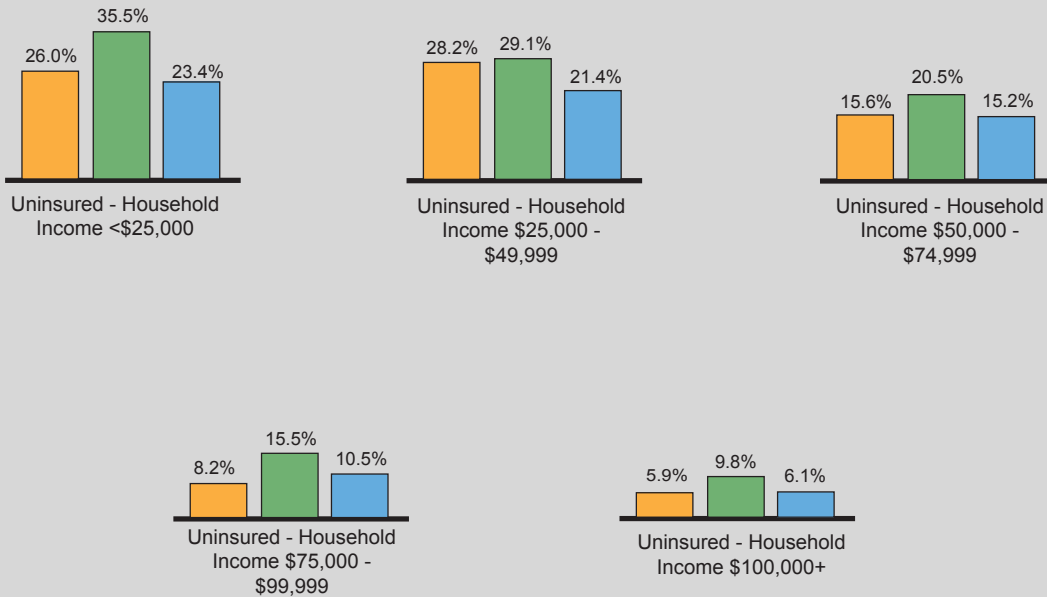
Health Insurance by Employment Status
