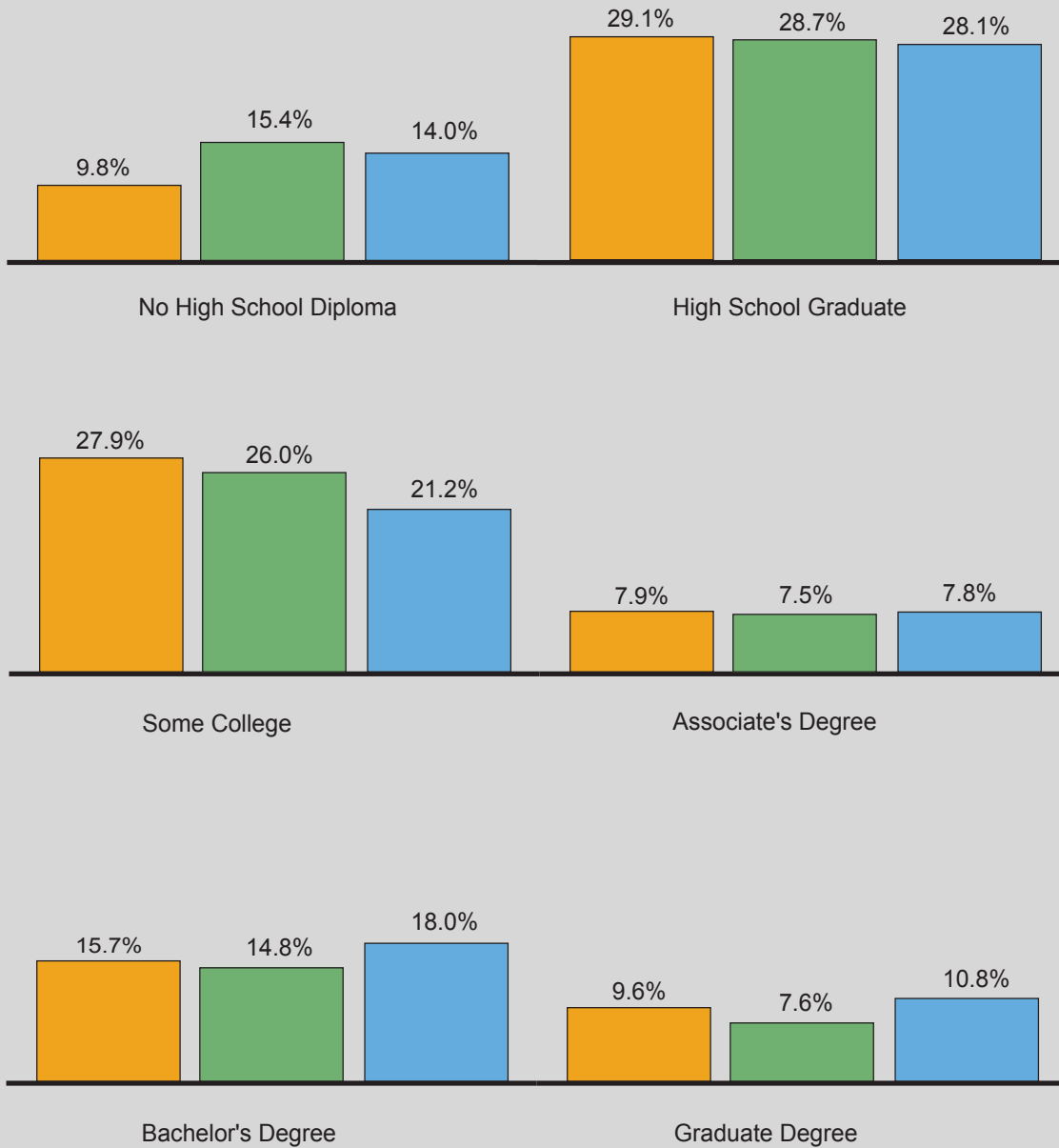

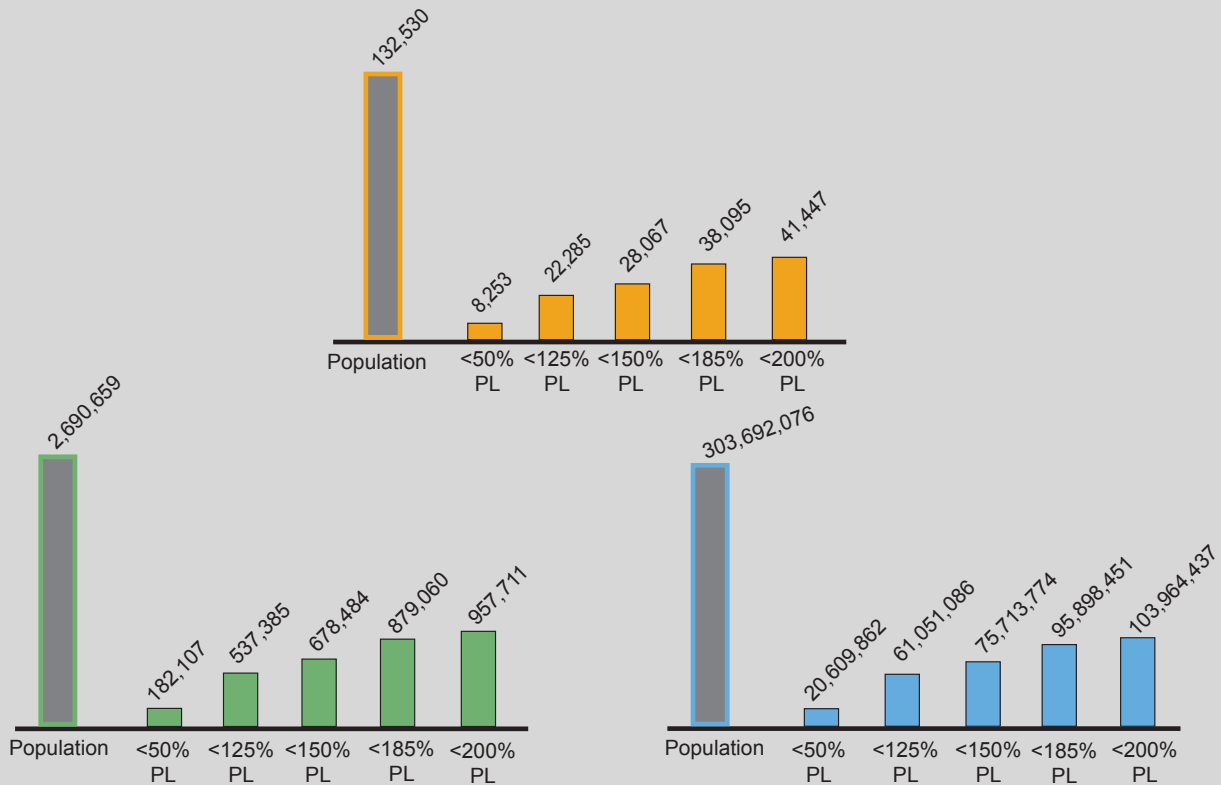

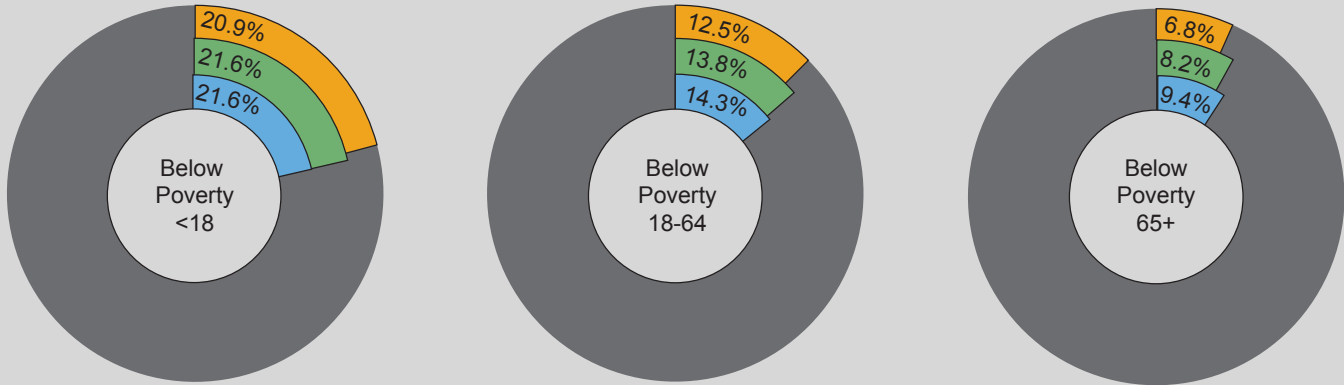

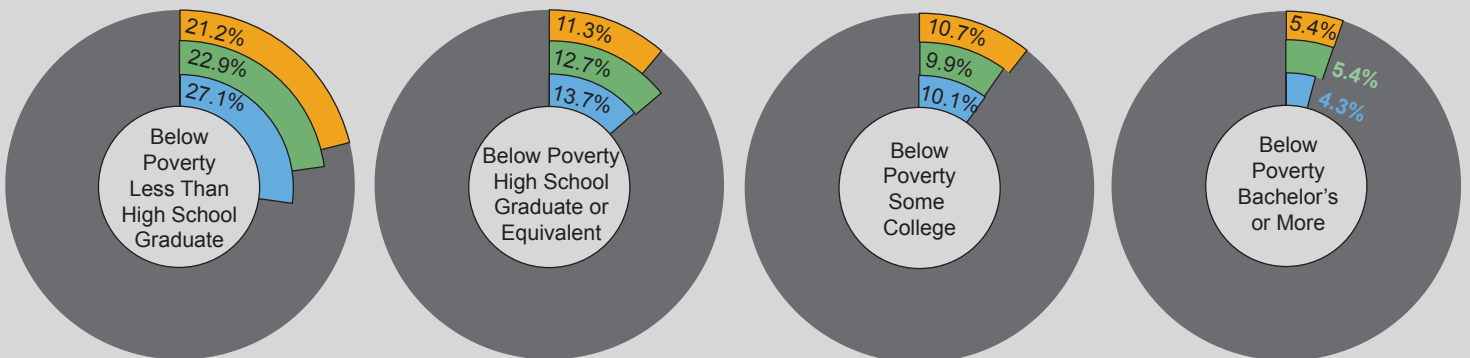

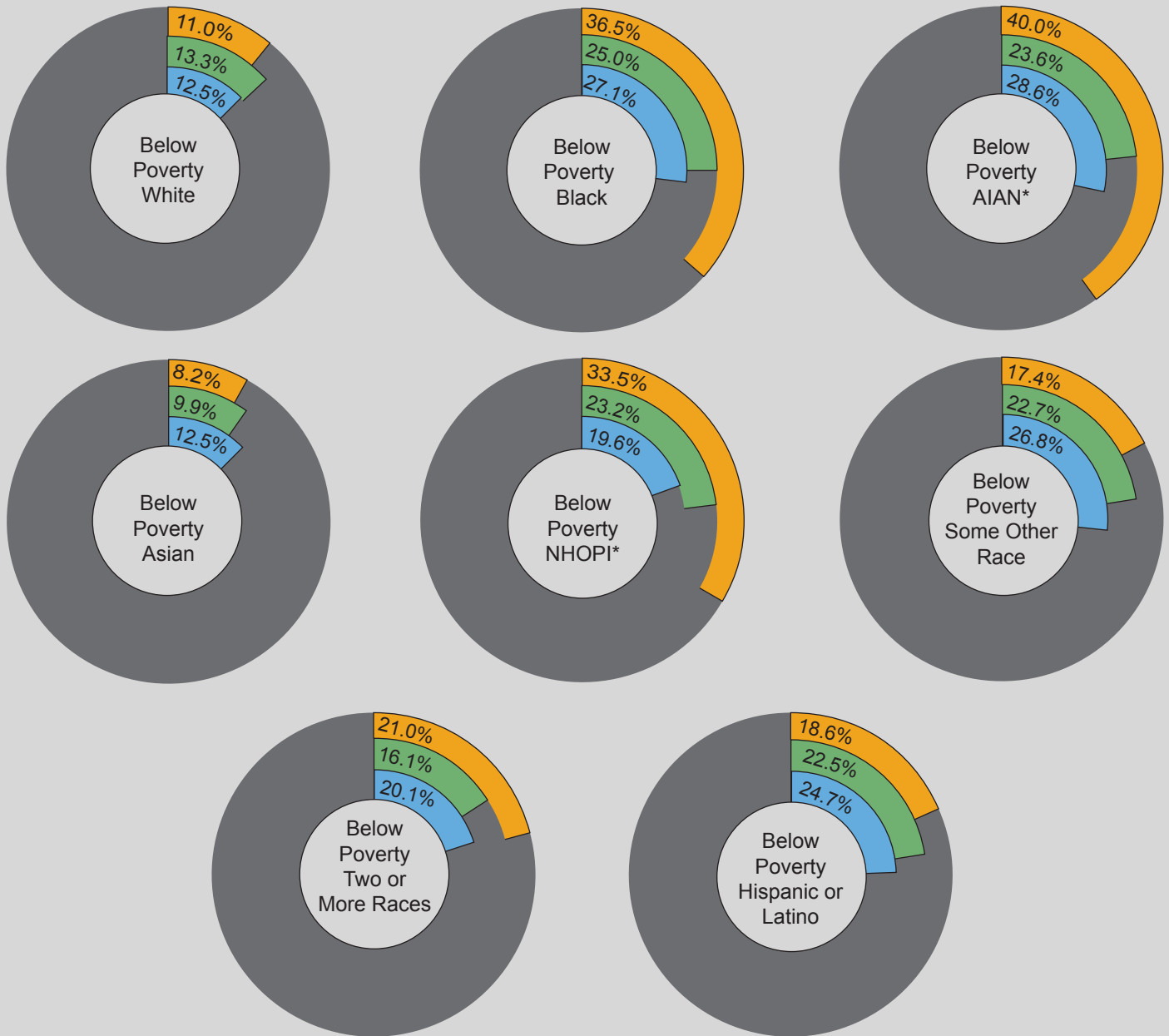

## Health Insurance by Age



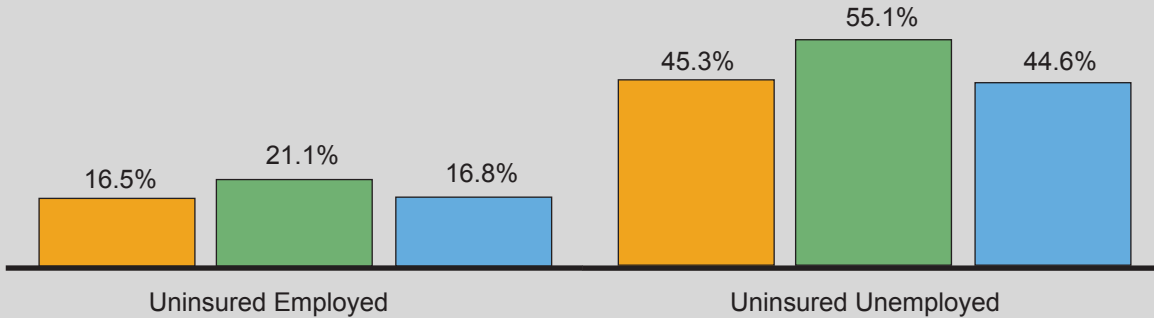

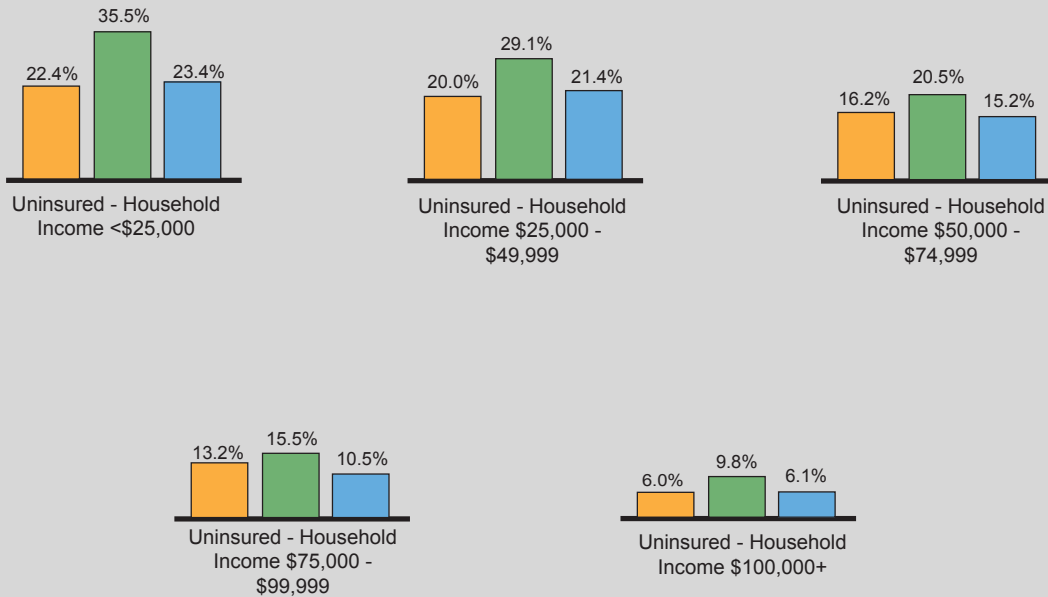
## Health Insurance by Employment Status

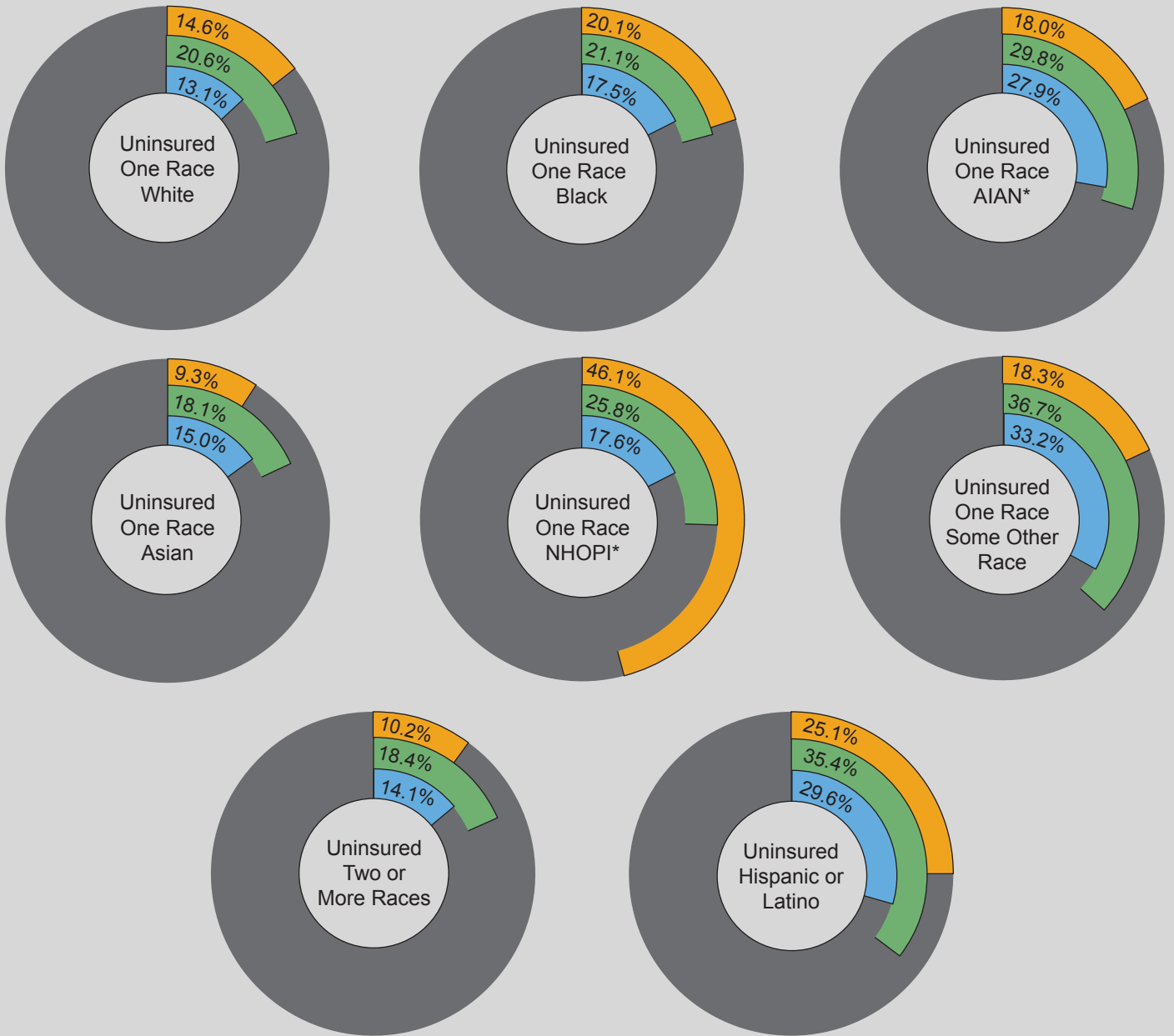

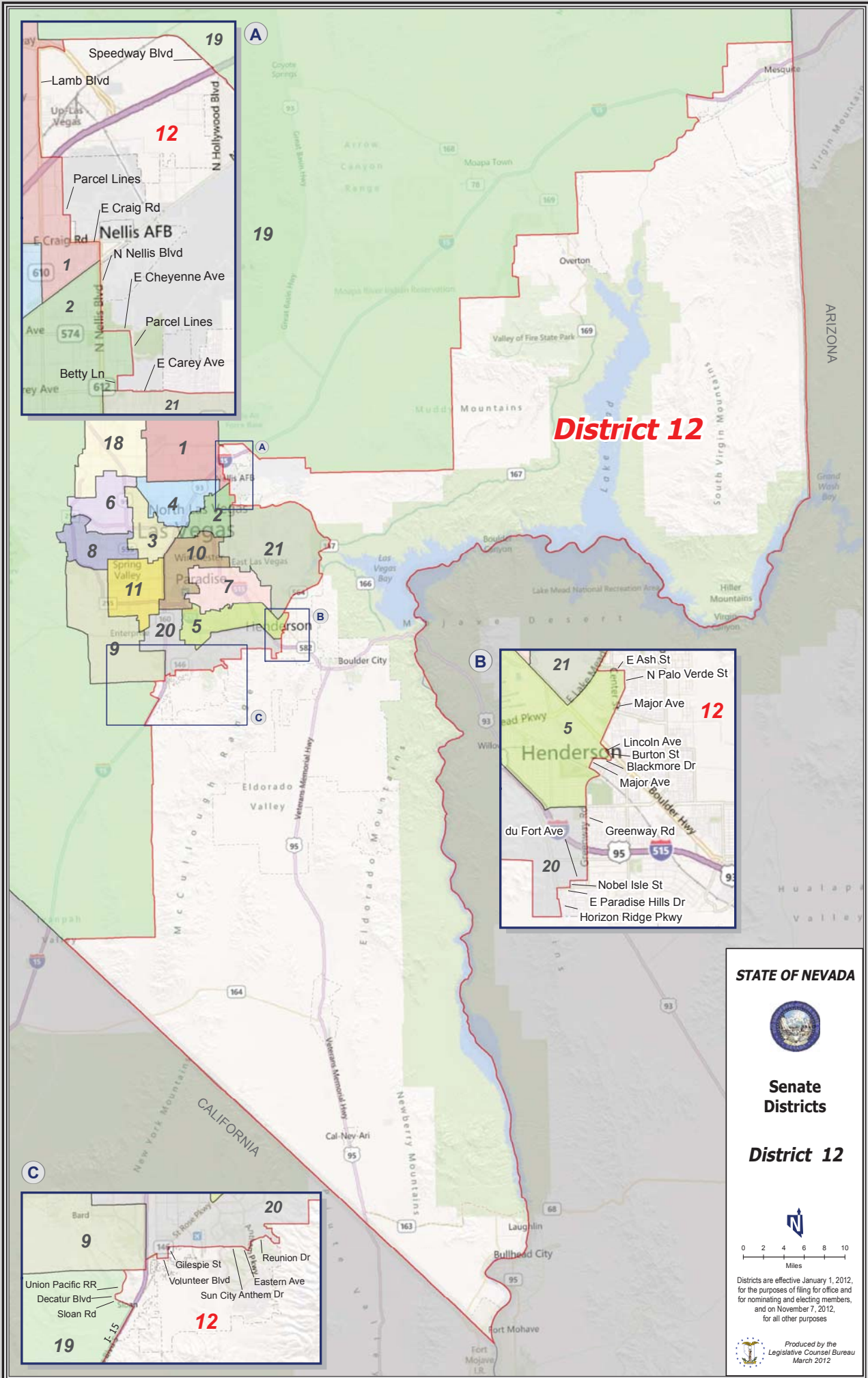
