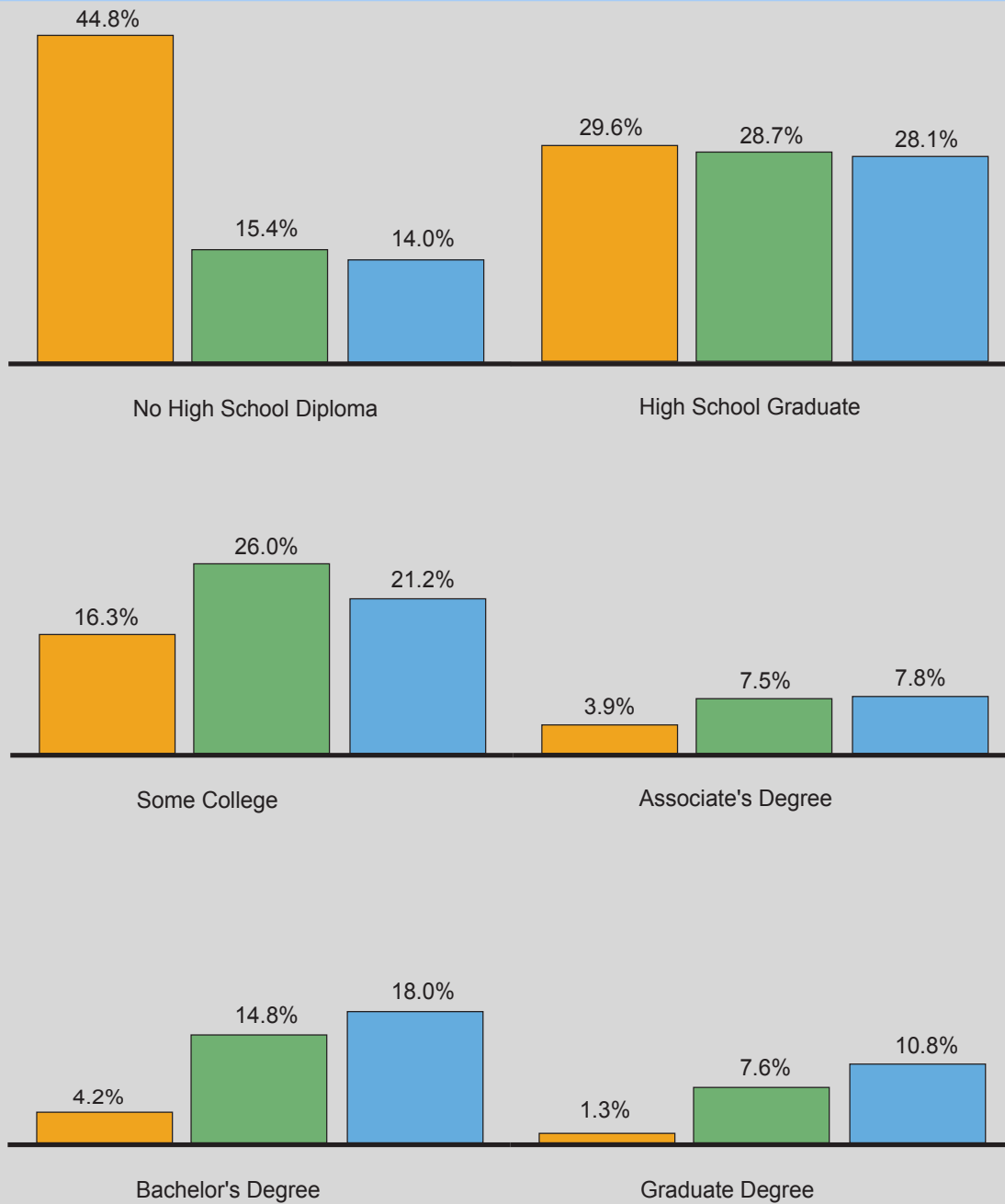

## Educational Attainment for Population 25 Years and Over



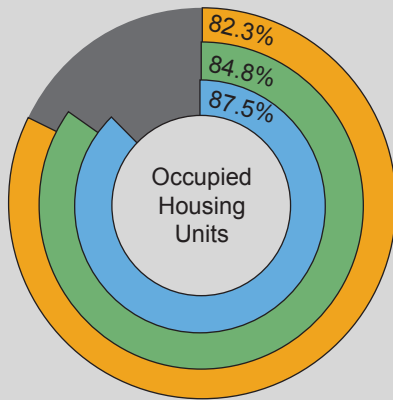

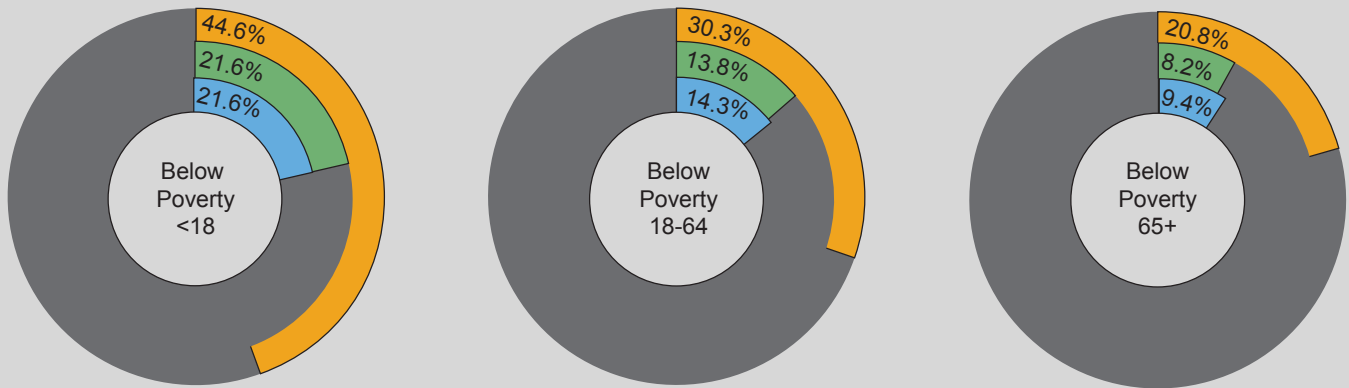

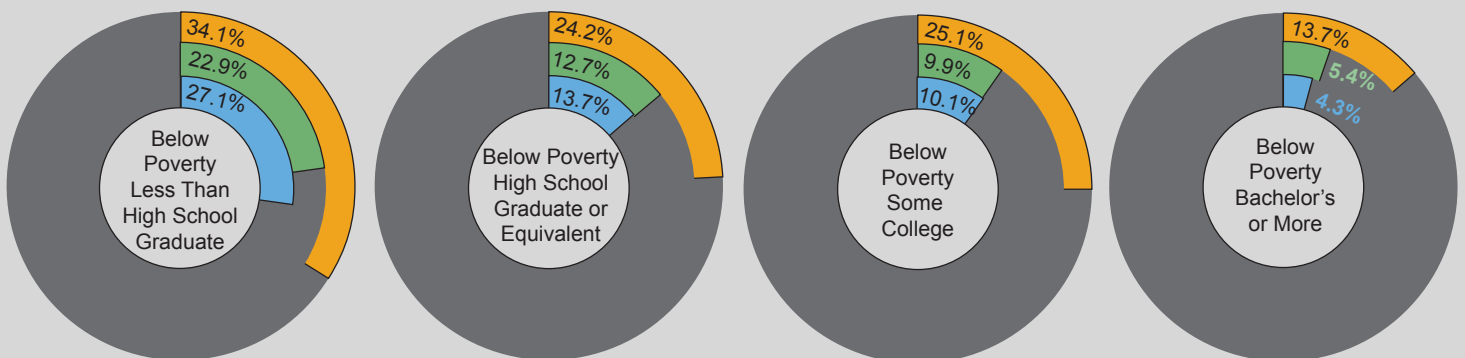

## Poverty Level by Education



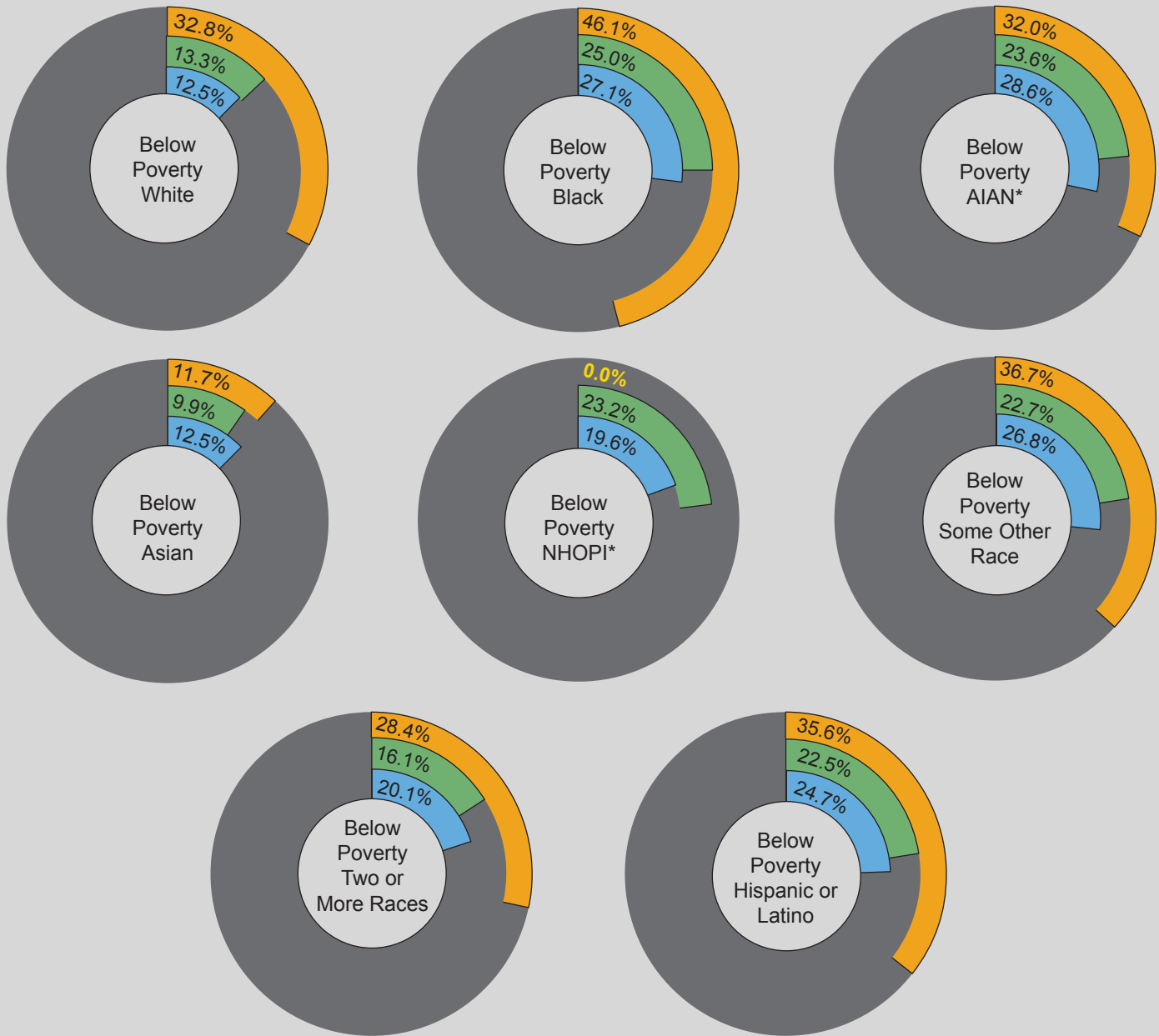

## Health Insurance by Age



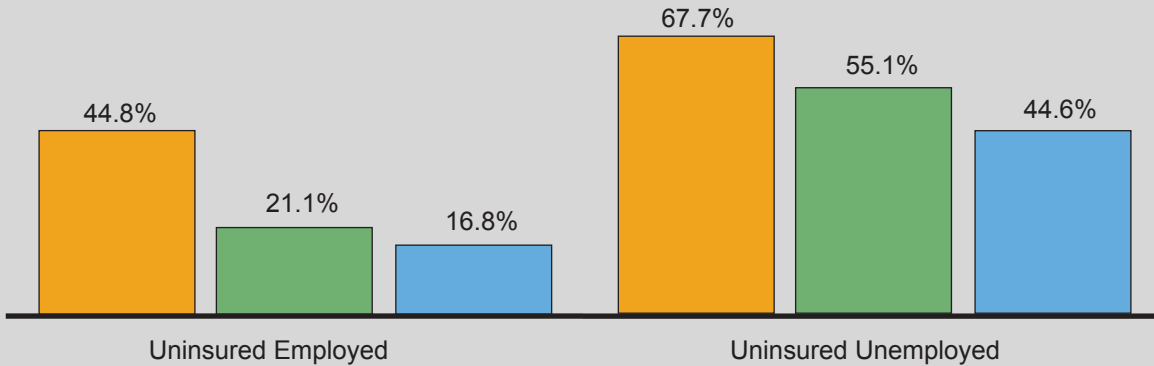

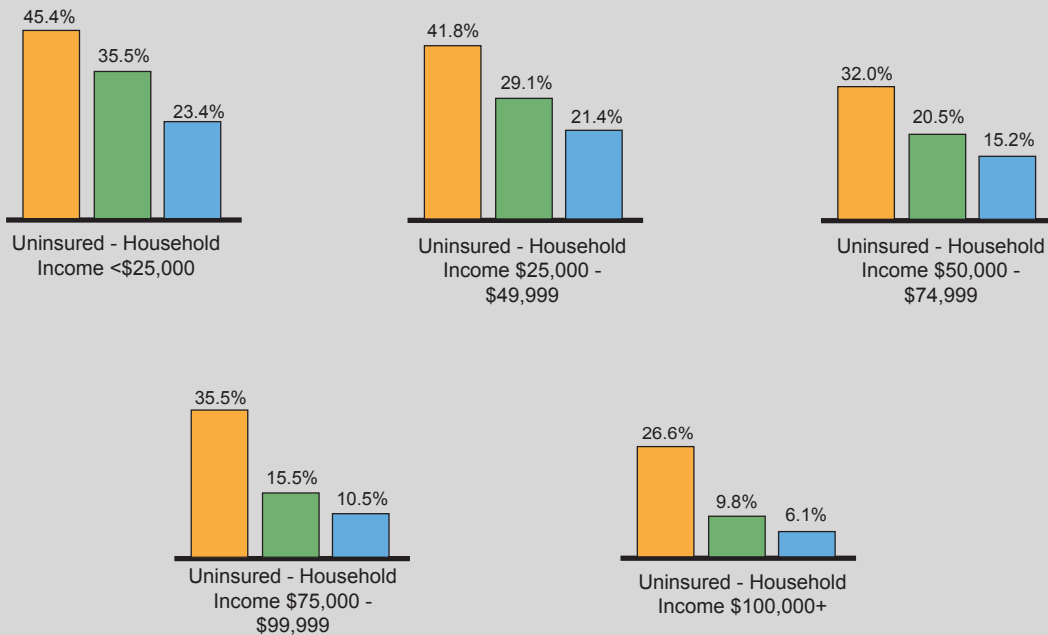
## Health Insurance by Employment Status

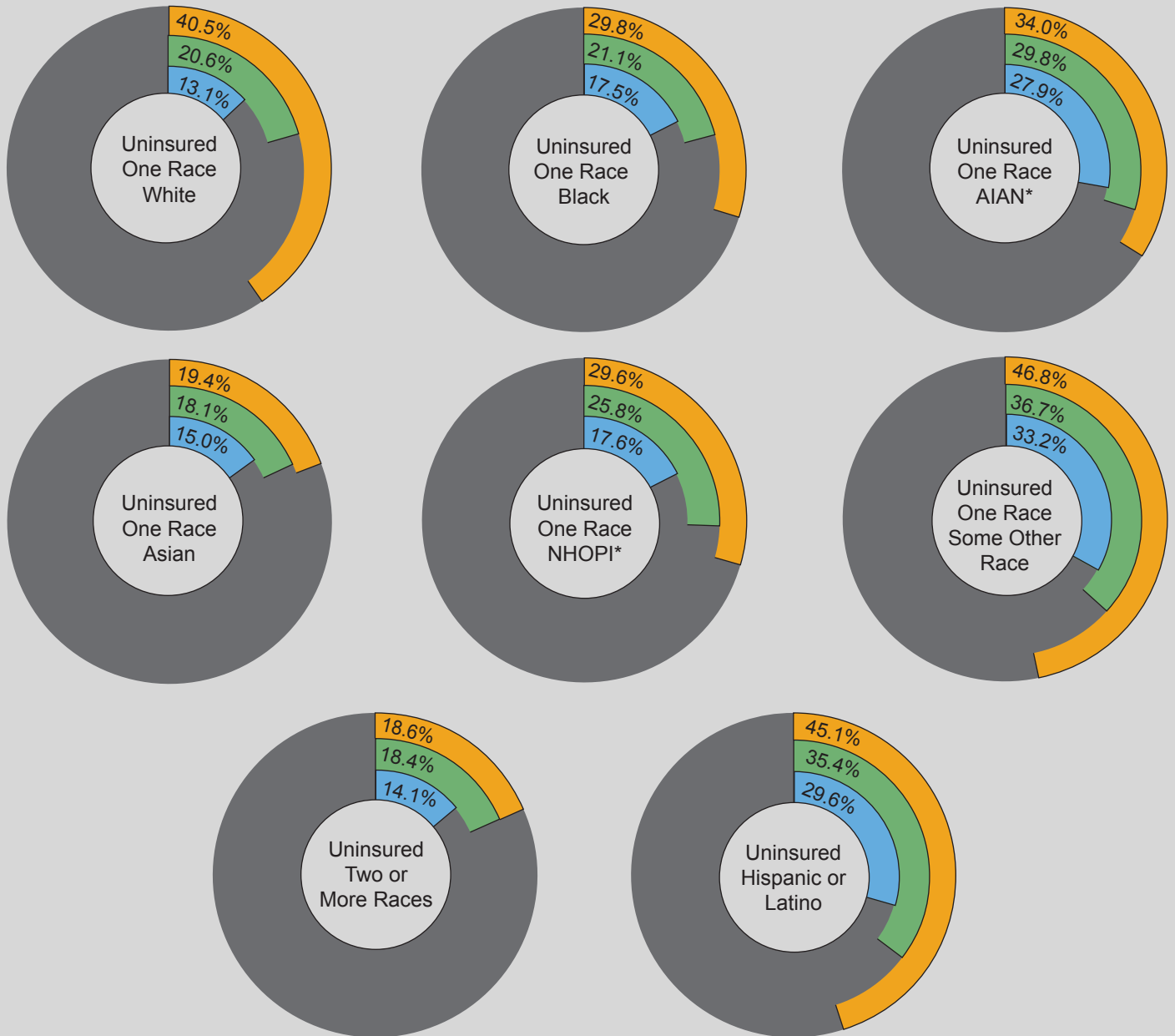

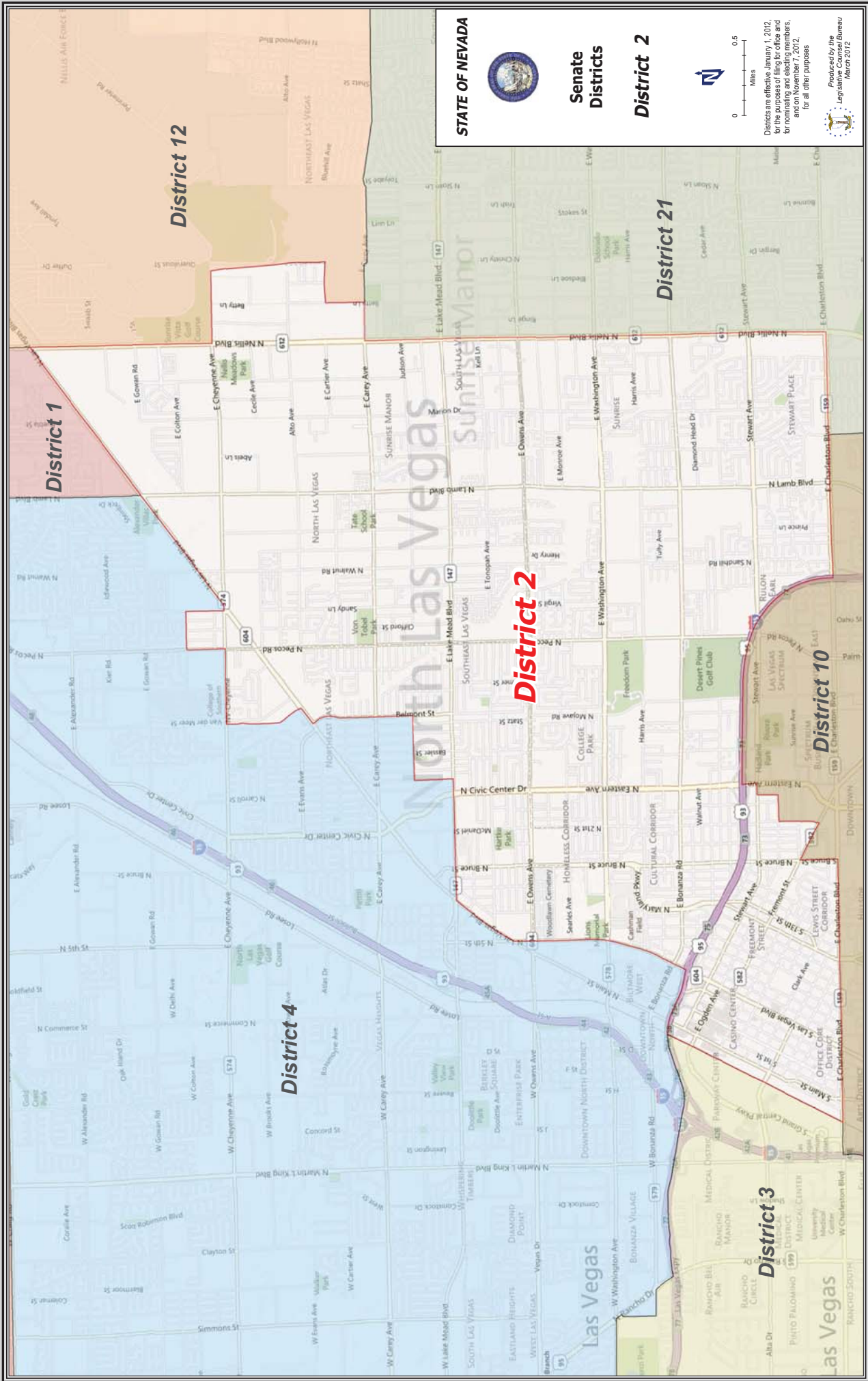
