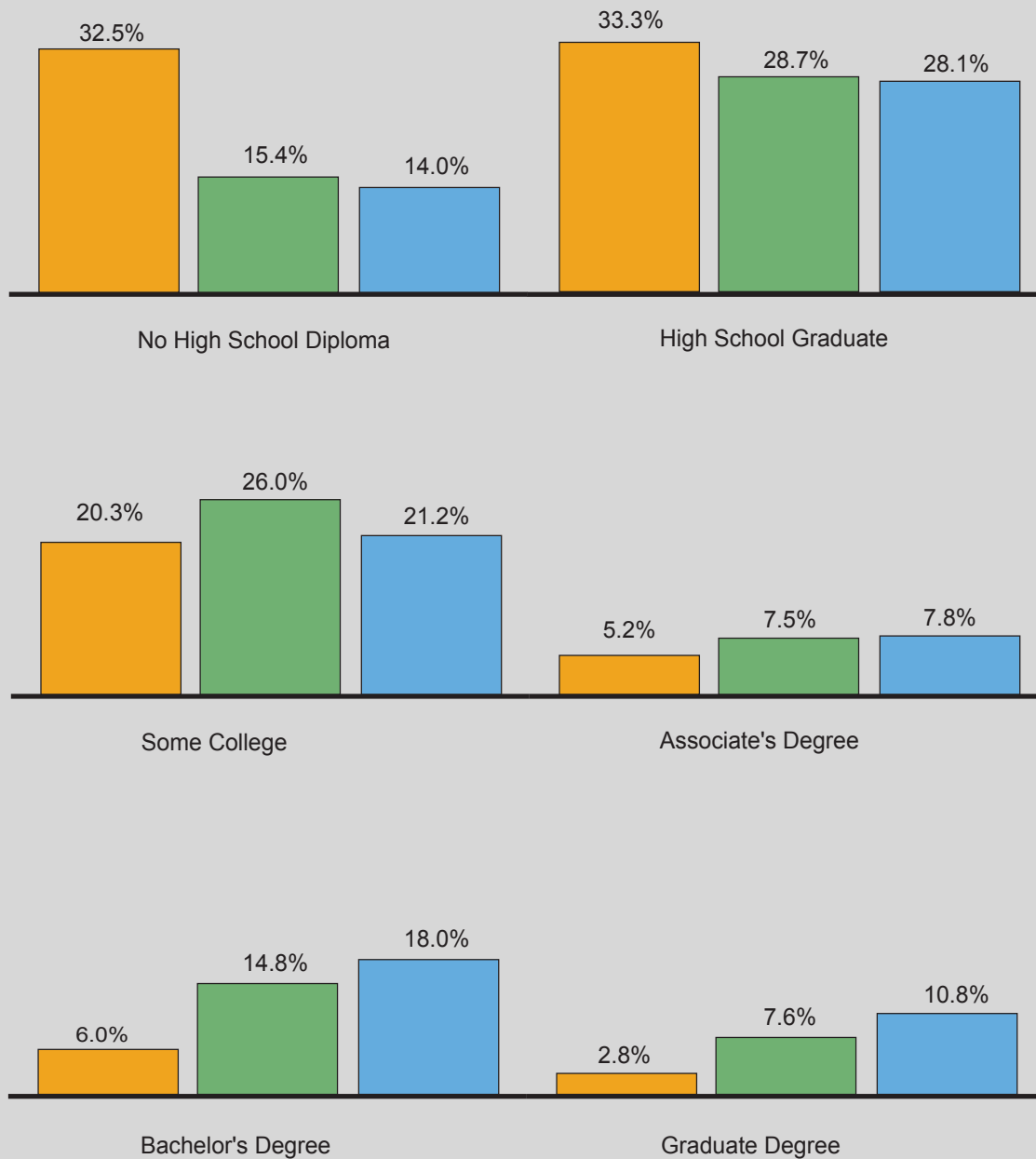

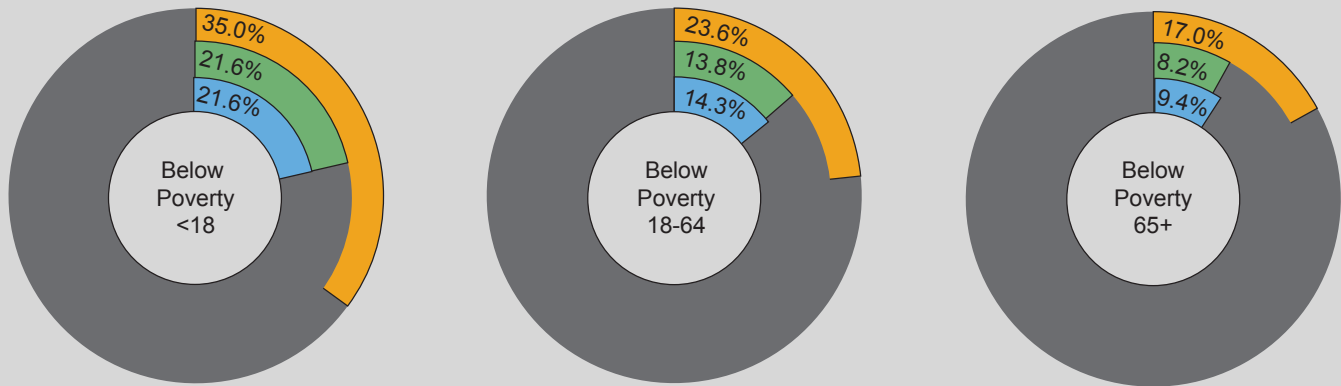

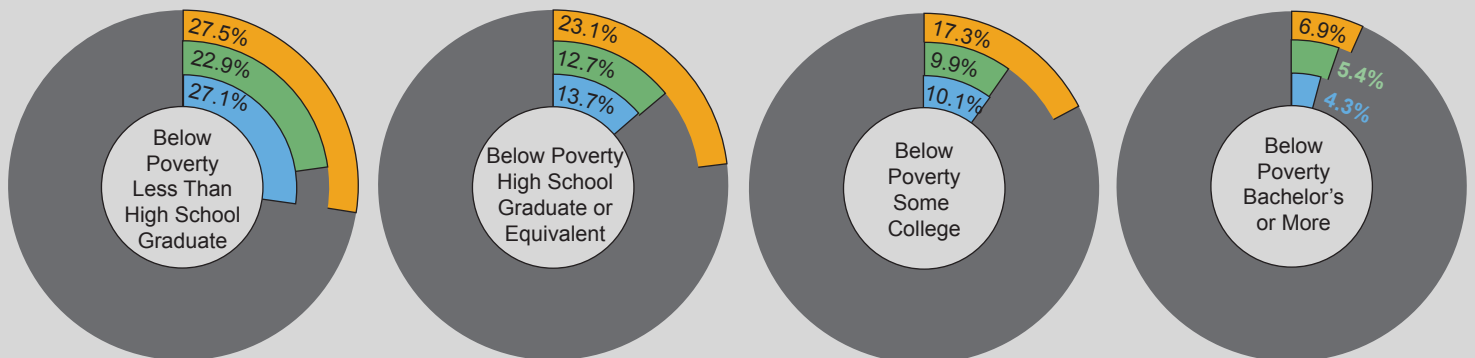

## Poverty Level by Education



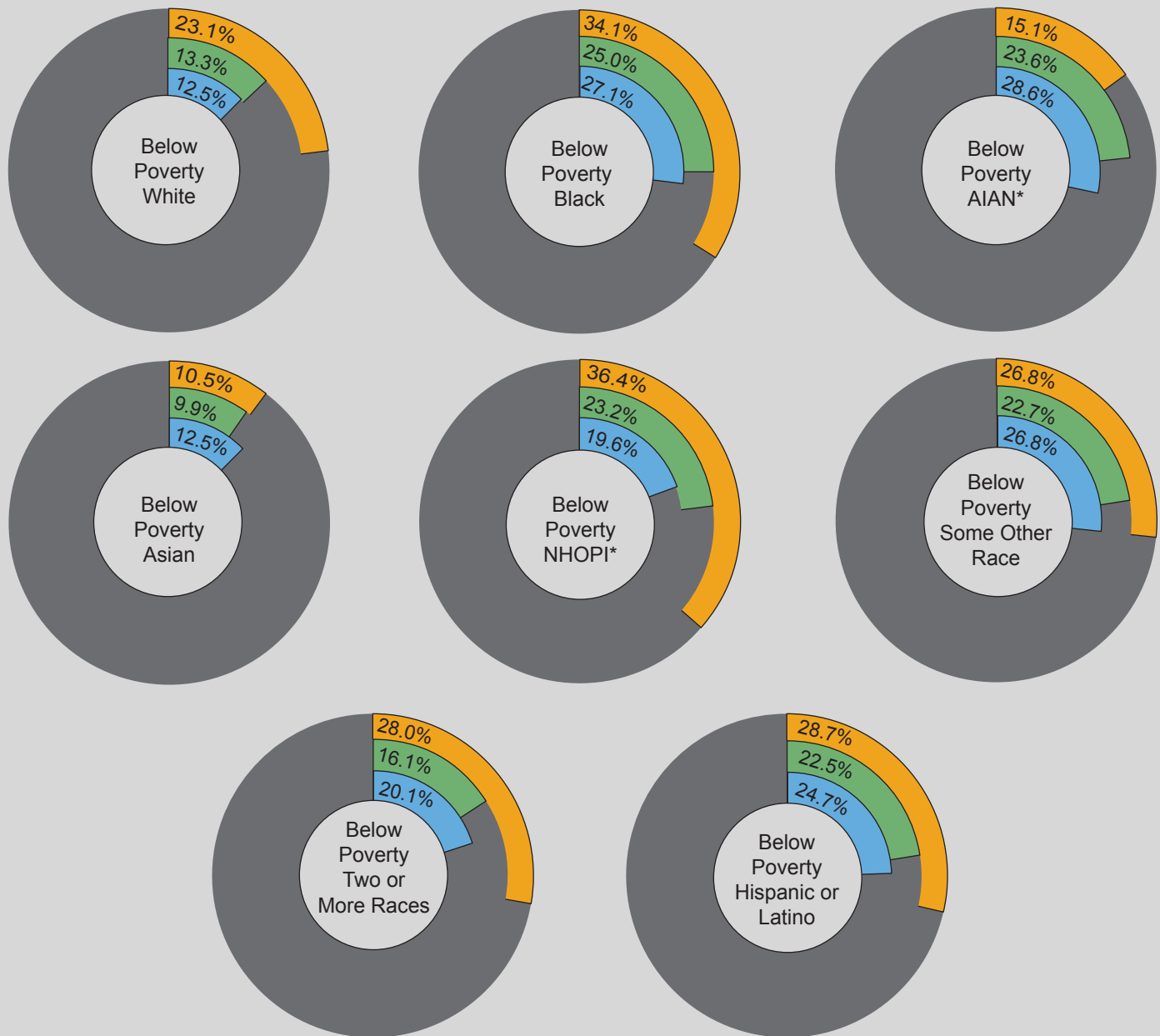

## Health Insurance by Age



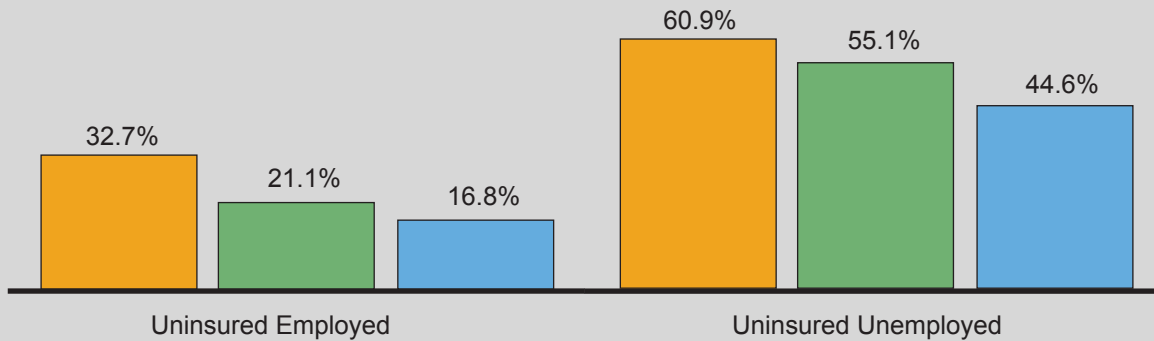

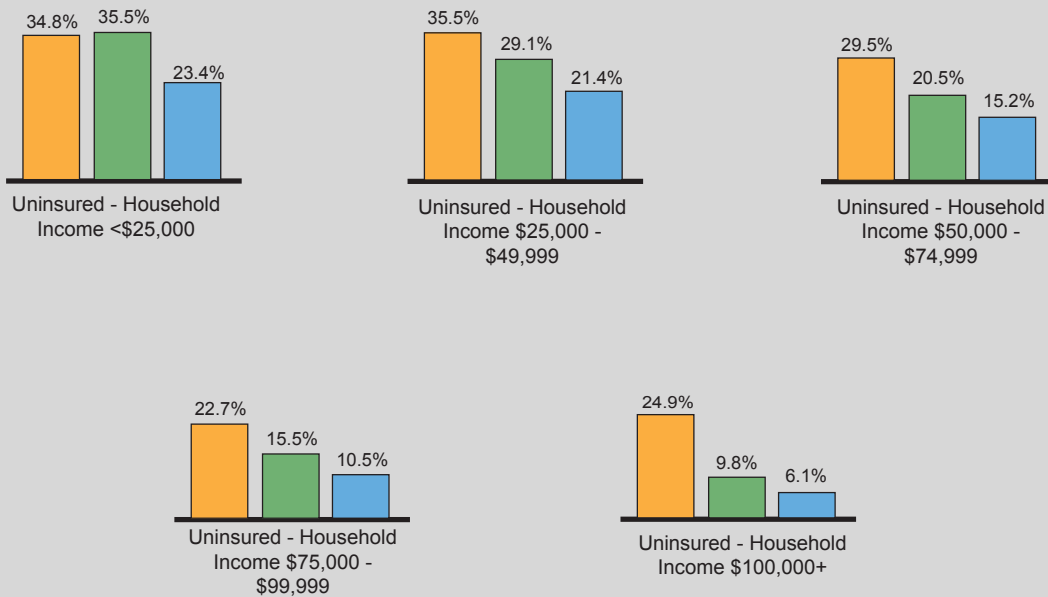
## Health Insurance by Employment Status

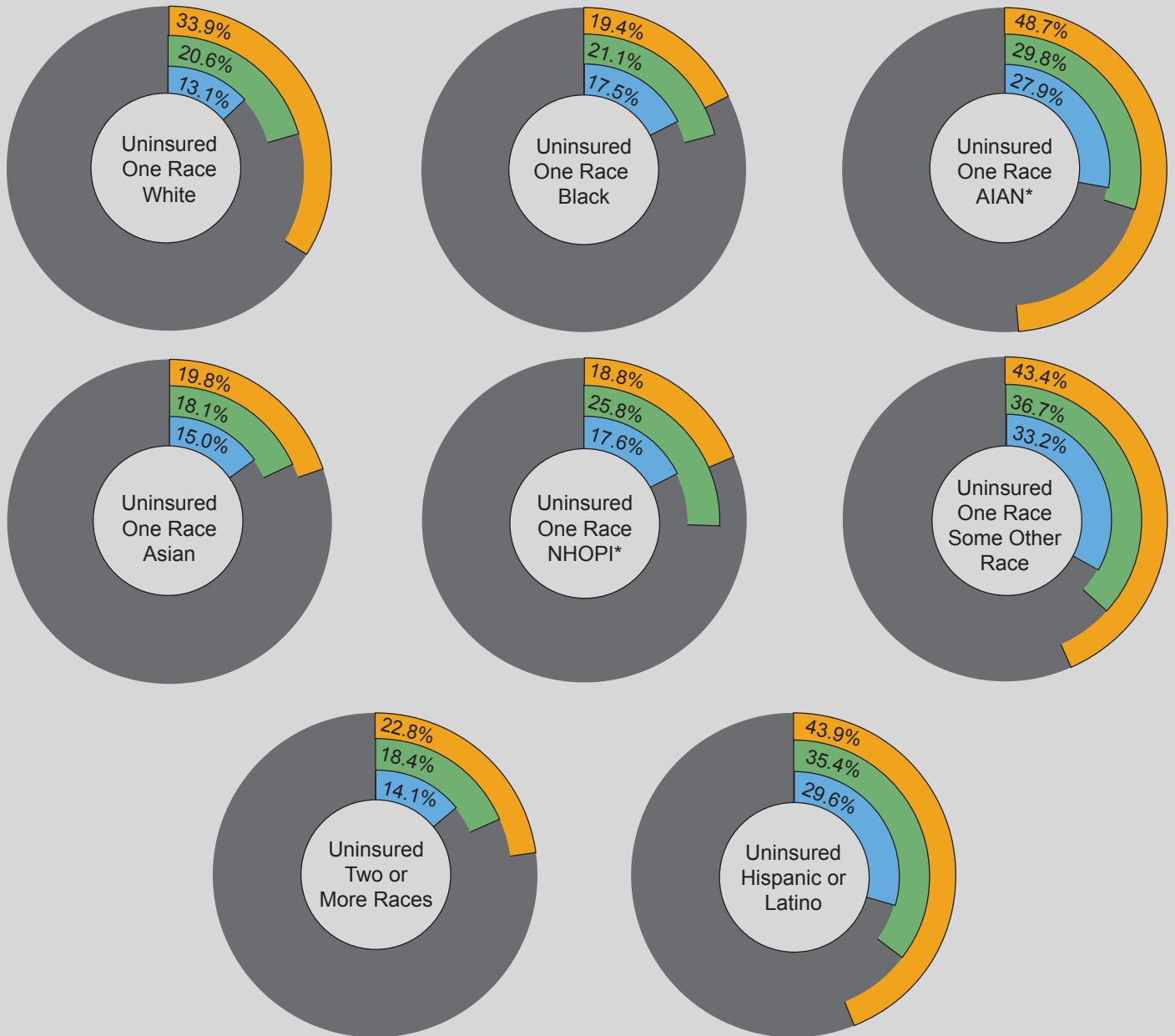

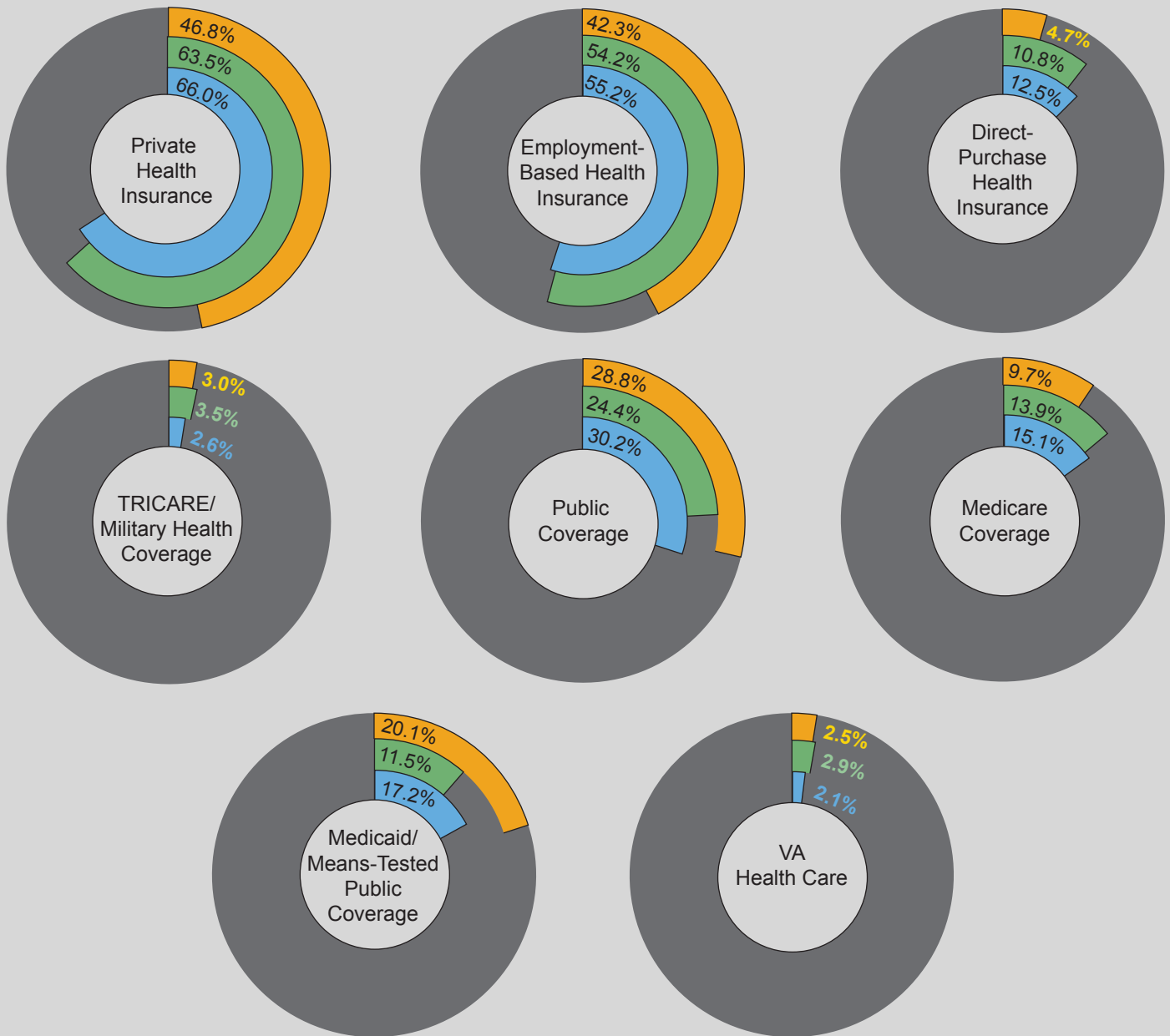

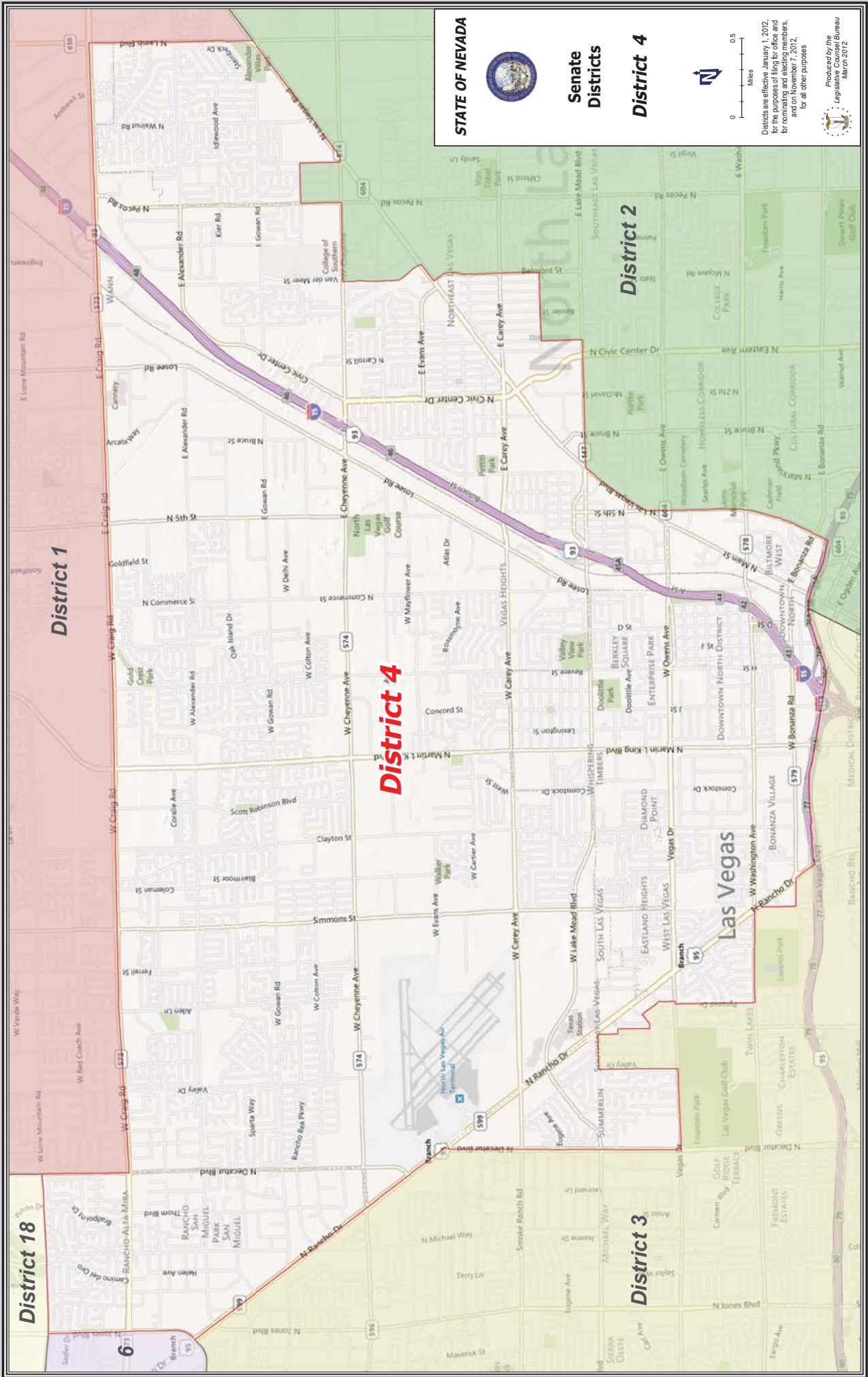
