INFORMATIONAL STATEMENT

LCB File No. R061-19 & R116-19

1. The purpose of these regulations (LCB File No. R061-19) is to provide a process for the Nevada State Museum (NSM), in consultation with the closest affiliated tribe(s), to permit excavations of Known Indian Burial sites on private land in the State of Nevada. The regulations (LCB File No. R116-19) also provide the agencies within the Division of Museums and History (DMH), a process for the repatriation of Native American human remains or other NAGPRA related cultural items, defined in 25 U.S.C. § 3001(3)(D), deemed abandoned property. The NSM was mandated by the State to write these regulations in consultation with the 27 Federally recognized tribes in Nevada, and any tribes located in neighboring states such as California, Arizona, Utah, and Oregon.

LCB File No. R061-19 and R116-19 was distributed to the public through the NSM Tribal and Antiquities Permit listservs, and the Nevada Indian Commission's (NIC) listserv. The regulations were posted in accordance with the Nevada's Open Meeting Law (NRS Chapter 241) along with Public Workshop and Public Hearing announcements and agendas were submitted to the Legislative Council Bureau, the State's official website, the DMH, and NSM webpages.

2. Public comment was solicited throughout the regulation drafting process, through planned meetings with tribal members and government, and the distribution of the regulations through two Anthropology listservs (Tribal and Antiquities Permit holders). One listserv includes Tribal Chairs, THPOs, and Tribal Cultural representatives for the 27 Federally recognized Nevada tribes, federally recognized tribes in adjacent states (i.e., Arizona, California, Oregon, and Utah) and interested members of the public. The second listserv includes all individuals and Cultural Resource Management companies who have a Nevada Antiquities permit. Meeting announcements and regulations were also distributed through the Nevada Indian Commission's (NIC) tribal listserv. Public comment was gathered throughout the regulation process, and when possible, comments were incorporated into the amended regulations.

Comments were received in writing during and following the Public Hearing on March 14, 2022. Comments were read during the public comment section by Mervin Wright Jr., Pyramid Lake Paiute tribal member and Environmental Manager. Mervin's comments included statements regarding issues of ownership of Native American human remains and cultural items as related to the Native American Graves Protection and Repatriation Act (NAGPRA), and a statement regarding how these objects should be respectfully treated. Other comments were received from Marla McDade Williams (Nevada tribal member and past Reno Sparks Indian Colony [RSIC] lobbyist) and in summary, seeks tribal input before a permit is issued. Her written comments also suggested the consulting tribe be notified early in the decision to revoke a permit and notified of any hearings where a private property owner can appeal this decision.

3. Consultation between Nevada's 27 federally recognized tribes, the DMH, and NSM was initiated in June 2018. Key Input and Comments:

Tribes asked the museum to take time and do more outreach and consultation with the tribes. We were asked to get out and visit the tribes, not just tribal leaders, and ask for input. Following this meeting NSM staff began a plan of action to initiate consultation and input for the Nevada Administrative Code (NAC).

June 19, 2018:

Anna Camp met with Darrel Cruz (THPO, Washoe Tribe).

Key Input and Comments:

Consultation can sometimes be one-on-one discussions. Mr. Cruz provided a map of Washoe tribal territory and Declaration of Washoe Descendance and Cultural Affiliation.

June 25, 2018:

Anna Camp and Gene Hattori met with Michon Eben (THPO, RSIC), Marla McDade Williams (Lobbyist, RSIC, Strategies 360), and RSIC Cultural Committee, at Ms. Eben's office

Key Input Comments:

NSM needs to better understand the Tribal worldview. NSM needs to listen more and not speak, especially to tribal elders. RSIC would like all objects returned to the tribes. RSIC objects to science, archaeology, Federal Cultural Resources laws, and SB 244 limitations. RSIC represents all Nevada Tribes. Every object is sacred to Native people. The regulations need to incorporate the values, beliefs, and traditions of the tribes.

June 28, 2018:

Anna Camp and Myron Freedman met with Pyramid Lake Paiute Tribal (PLPT) members, Betty Aleck (THPO) and Mervin Wright, Jr. (Environmental Manager) at Tribal headquarters in Nixon, NV.

Key Input and Comments:

Consultation may mean government to government contact, and some affiliated tribes might not want to engage. We need to meet with each tribe to determine consultation preferences. The PLPT prefer that the THPO be contacted first and then the Chairman/woman if necessary. Several or all tribes should be notified of findings. There was some concern that property owners will excavate without obtaining a permit. There is a need for a research design before the excavation. There should be some best practices for excavation of Known Indian Burial Sites.

July 26, 2018:

Anna Camp met with Ely Shoshone Tribal representatives, Jill Perez (Environmental Grant Administrator), Brianna Hedges (Environmental Protection Specialist), Synthia Stark (Student Intern/Ely Tribal Member) at Environmental office in Ely, NV.

Consultation is government to government interactions. The Ely Shoshone Tribe prefers to receive notification by mail. The notification of a permit should be sent to all the tribes in the area. DNA can be useful for determining lineal descent.

August 9, 2018:

Key Input and Comments:

Katherine, Judy, and Misty believe that consultation is a back-and-forth conversation between the museum and the tribes. They had concern that excavation without a burial permit is only a misdemeanor. They suggested having a meeting with law enforcement. They mentioned that Winnemucca Indian Colony does not have the ability to rebury remains at this time, due to the lack of tribal organization.

August 16, 2018:

The tribal attendees wanted to know why all the tribes had not heard of SB 244 before it passed in the legislature. They believe there is a lack of respect between government agencies and tribes during consultation. There was a concern that SB 244 only represents the concerns of urban rather than rural tribes that work with mining companies. They believe that private landowners should register known burial sites. There was concern with what a known burial sites means. The tribal attendees think that landowners will avoid informing authorities and will excavate without a permit. They think that the research plan should include a

respectful way to move burials. They think that Tribal Monitors should be called Cultural Specialists. They think there needs to be two points of contact for each tribe, and that all tribes should be notified before issuing a permit.

August 27, 2018:

She suggested the regulations state "the State will request guidance on the disposition of dealing with human remains". She also mentioned that tribes do not have the time or staffing to write regulations, and that they deal with multiple government agencies daily.

Key Input and Comments:

Reno Sparks Indian Colony (RSIC) expressed that the Regulations did not include the values, belief, and traditions of the tribes. RSIC expressed that human remains should not be excavated despite the desire of property owner. There was general tribal concern with the use of the word "Indian" in the Regulations. RSIC expressed that tribes need to be involved in Antiquities Permit processing. RSIC expressed that the draft Regulations were not good enough and more time was needed before they become law. RSIC suggested more time was needed to consult with tribes, not just tribal leadership, but also tribal members.

RSIC stated Regulations did not include tribal values, belief, and traditions. RSIC thought the State was more concerned with the rights of private property owners than of the tribes. RSIC took issue with definitions (e.g., Abandoned Property). Washoe Tribe stated that "Aboriginal Territory" should determine Cultural Affiliation. RSIC wants Known Burial Site permit to be the last resort. RSIC would like to be included before a Permit is issued. There was confusion about who is exempt from the Known Burial Site Permit. RSIC again expressed the need for more time to write Regulations.

January 31, 2019:

May 23, 2019:

Public Workshop held at the Nevada State Museum, Carson City with video conferencing at the Nevada State Museum, Las Vegas. Workshop was to solicit input on Regulations.

Key Input and Comments:

RSIC was still unhappy with several aspects of the regulations, including how values, beliefs, and traditions would be upheld. Also concern for the definition of Cultural items. They plan to provide written comments for the next draft.

Comments were provided by email from Darrel Cruz on April 2, 2019, and included:

• Provision 20, we support the affiliated tribe statement for joint use area.

- #3 Observer costs: Why would the landowner be responsible for the observer? Would the tribe share costs to have an observer?
- #5 communication between landowner and tribe; will the tribe be given the private property landowner contact information?
- #7 excavation: who is the responsible party, the permit holder, landowner, coroner? Who will hold the items until tribe is ready to receive?
- Who pays for the work if located on private land?
- Provision #2: What if there is emergency work and human remains are discovered? Does the 10-day rule apply?

June 10, 2019: The amended Draft Regulations were redistributed through the Tribal Listsery.

<u>Key Input and Comments</u>: See attachment of comments from Betty Aleck (THPO, PLPT) on July 22, 2019

August 13, 2019: Draft Regulations were amended and submitted to LCB

<u>January 15, 2020</u>: The NSM received Draft Regulations from LCB and made them available for review.

November 10, 2020: Email was sent through Tribal Listserv describing how the regulations had been split by LCB. The Abandoned Property portion of the regulations would become the responsibility of DMH and the Burial Site permitting would be the responsibility of the NSM.

December 2020: Regulations were sent back to LCB for edits

February 8, 2021: AB 103 was passed during the 2021 Legislative session, amended NRS 381.196 to include subsection 2, "A person is not required to obtain a permit pursuant to subsection 1 to engage in lawful activity on private lands, including, without limitation, construction, mining, mineral exploration, logging, farming, ranching or a federally authorized activity conducted in compliance with the National Historic Preservation Act, 54 U.S.C. §§ 300101 et seq., if that activity is engaged in exclusively for purposes other than the excavation of prehistoric Indian burial site[.] and the activity occurs only on a portion of the private lands that does not contain the known prehistoric burial site."

October 9, 2021: Revised regulations received by NSM & DMH from LCB

October 26, 2021: Revised regulations sent out through Listservs for comments. NO COMMENTS RECEIVED

<u>December 21, 2021</u>: Legislative Commission Meeting NSM & DMH asked for extension for Public Hearing.

February 14, 2022: Public Hearing notice posted

February 15, 2021: Hearing Announcement sent through Listservs

4. Pursuant to NRS 233B.0608(2)(a), the NSM solicited information regarding the impacts on small businesses in Nevada that may be negatively affected by the regulations. Currently the NSM has received no response that indicates negative impacts on small businesses.

The Nevada State Museum solicited information about the impacts of this regulations on small businesses in several ways. We determined that Cultural Resources Management (CRM) companies permitted to do archaeology in Nevada are considered small businesses. The regulations require that private property owners who have knowledge of burial sites on their property would first obtain an Indian Burial Site Permit before legally doing groundbreaking work on their property. The regulations also uphold the rights of the private property owner during this process. To obtain an Indian Burial Site permit, the property owner must first apply with the Museum Director and demonstrate that the person(s) conducting work on the private property owner's land, possesses sufficient knowledge and scientific training to excavate a prehistoric burial site. In turn, the property owner is required to hire a CRM company to meet these requirements.

To further our outreach to private property owners potentially affected by these regulations, we contacted Rebecca Palmer, Administrator/State Historic Preservation Officer (SHPO) on October 26, 2021, to inquire about a list of private property owners with known burial sites on their land. According to Ms. Palmer while SHPO maintains a geographical database (i.e., Nevada Cultural Resource Information System [NVCRIS]) containing archaeological site locations, NVCRIS does not contain burial site locations, therefore no list of private property containing known burial sites exists.

A Small Business Impact Questionnaire was provided along with a copy of the proposed regulations and was sent through the Nevada State Museum's listsery, which includes 72 active Nevada Antiquities Permit holders. The response period for the questionnaire was from December 17, 2021, to December 27, 2021. The Questionnaire asked:

- 1. Have you reviewed and do you understand the Indian Burial Site permit regulations?
- 2. Do you think these regulations will have an impact on your business?

3. Do you believe the impact of these regulations will be positive or negative? Please explain.

We received three returned surveys, all stating that the regulations would have no negative impact on their businesses, but instead positive impacts due to the requirement that property owners would hire CRM companies or individuals with required credentials and knowledge. One survey expressed concern about the costs to the private property owners. On December 29, 2021, we contacted the U.S. Small Business Administration. Deputy District Director for the Nevada District Office, Saul Ramos responded, and referred us to Elizabeth Hill, Native American Liaison. I have not been contacted since this initial email.

- 5. After consideration of public comment, Myron Freedman (DMS Administrator/Acting Director of NSM) determined that the regulations would be adopted without changing any part of the proposed regulations. Written and verbal comment was received during the public comment portion of the Public Hearing, on March 4, 2022, from Mervin Wright Jr. (Environmental Planner, Pyramid Lake Paiute Tribe). His comments addressed issues on ownership of Native American human remains and cultural items as related to the Native American Graves Protection and Repatriation Act (NAGPRA), and a statement regarding how these objects should be respectfully treated. DMH and NSM staff determined that the Nevada Burial Law (NRS 383.150-190), which was passed by the Nevada legislature in 1989, protects Native American graves on all public and private land in Nevada. Under Nevada law it is illegal to find a Native American burial and not report it, even if on private property. It is also illegal to possess or sell a Native American burial or artifact from a Native American grave (https://shpo.nv.gov/welcome-to-review-and-compliance/indian-buriallaws). Comments were also received from Marla McDade William (former RSIC Lobbyist, Strategies 360). These comments were minor and were determined to have overlap with other portions of the regulations. RSIC was not interested in prolonging the process any further, and therefore DMH and NSM staff decided to exclude these changes from the final adoption.
- 6. There are no estimated economic effects of the regulations for the DMH or NSM. We also determined there are no estimated economic effects of the regulations on the public. There are no adverse or beneficial effects for the DMH or NSM, and there are no adverse or beneficial effects on the public. There are no immediate and/or long-term effects for DMH or NSM, and there are no immediate and/or long-term effects on the public.
- 7. There are no estimated costs to DMH or NSM for the enforcement of the proposed regulations.

8. The proposed regulation (LCB File No. R116-19), which includes the treatment of Abandoned Property does not include provisions which duplicate or are more stringent then federal, state, or local standards.

The proposed regulations (LCB File No. R061-19), which includes the treatment of Native American burial sites on private land, does include provisions that duplicate the Native American Graves Protection and Repatriation Act (NAGPRA). The difference is, NAGPRA applies only to federal lands. State and private lands in Nevada are exempt from NAGPRA compliance. These regulations require a NAGPRA-like process for excavation of known burial sites on private and state lands.

The proposed regulations also include provisions that duplicate or overlap NRS 383.150 – 383.190. While the NSM regulations include a process for the excavation of known burial sites on private land in Nevada, if however, any unanticipated discoveries of human remains made, then NRS 383.150 – 383.190 goes into effect.

- 9. The regulations (LCB File No. R116-19 and LCB File No. R061-19) do not include provisions that are more stringent than federal regulations which regulates the same activity.
- 10. The regulations (LCB File No. R116-19 and LCB File No. R061-19) does not establish a new fee or increase an existing fee.
