LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY NRS 233b.066

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 656.

LCB FILE R193-22

- 1. This regulation is necessary to update the regulations and keep consistent with statutory language and provide clarification to court reporters and designated representatives of court reporting firms.
- 2. Copies of the proposed regulations, notice of workshop and notice of intent to act upon the regulation were sent by email to persons who were known to have an interest in the subject of court reporting as well as any persons who had specifically requested such notice. - 3. The number of persons who:

Notices of the workshop and adoption hearing to solicit comments were sent out to each active court reporter and designated firm representative registered with the State of Nevada Certified Court Reporters Board. The notice instructed interested persons to contact the Executive Secretary to submit their comments or request a copy of the materials. No comments were submitted.
- 6. The regulation was adopted on October 25, 2023 without change because the Board was not made aware of any information or comments that would indicate a need for changing the language of the proposed regulation.

- 7. The Board does not anticipate any adverse economic effect on the amended regulations. The immediate and long-term effects will keep NAC Chapter 656 consistent with NRS Chapter 656 and provide clarification for court reporters and court reporting firms in the state of Nevada.

- 9. There are no other state or governmental agency regulations that the regulation duplicates.
- 10. There are no federal regulations that apply.
- 11. This regulation does not provide a new fee or increase an existing fee.
