INFORMATIONAL STATEMENT

R006-23

1. A clear and concise explanation of the need for the adopted regulation:

Existing law requires the Peace Officer Standards and Training Commission to adopt regulations establishing minimum standards for the certification and decertification, recruitment, selection and training of peace officers. (NRS 289.510)

NAC289.200(4)(a) requires an officer to complete the physical fitness exam not later than 16 weeks after the first day of the officer's basic academy. This proposed regulation (R006-23) will require the physical fitness exam to be completed during the academy, removing the 16-week requirement. This will allow for better conditioning of cadets without the additional pressure of the 16-week deadline, and will produce better, overall scores with less injuries. This will allow for retention of cadets that would have otherwise been dismissed as they will have the full length of the academy to successfully complete the physical fitness examination.

A workshop was held February 9, 2023, where public comment was accepted during the workshop and regularly scheduled meeting. There will be less funds spent on new recruiting and backgrounds because they've been able to condition and train cadets throughout the academy, therefore retaining these officers who previously would have been dismissed.
