

## INFORMATIONAL STATEMENT

R007-23

### **A clear and concise explanation of the need for the adopted regulation:**

Existing law requires the Peace Officer Standards and Training Commission to adopt regulations establishing minimum standards for the certification and decertification, recruitment, selection and training of peace officers. (NRS 289.510)

NAC289.200(8) requires a person to be a full-time officer in order to be re-employed and maintain their basic certificate. In order to aid in the hiring and retention of officers, we will remove the full-time requirement. This will allow officers to pursue part time law enforcement employment, especially after retirement, utilizing a large, certified employment base for agencies.

The benefit is two-fold - Nevada law enforcement agencies will be able to save money by hiring part time, experienced, certified officers and Nevada officers will be able to maintain their certification without mandated full-time employment.

A workshop was held February 9, 2023, where public comment was accepted during the workshop and regularly scheduled meeting.
