

## INFORMATIONAL STATEMENT

### R031-23

#### **A clear and concise explanation of the need for the adopted regulation:**

Existing law requires the Peace Officer Standards and Training Commission to adopt regulations establishing minimum standards for the certification and decertification, recruitment, selection and training of peace officers. (NRS 289.510).

R031-23 will establish a Command Level Basic Certificate, awarded only to Executive Level Staff. Recruitment of executive level staff can be difficult, especially around elections. An elected official may have been certified but their basic certificate has expired. This certificate will assist in the recruitment and retention of Executive Level positions, including, but not limited to elected and/or appointed officials. In other instances, the certified elected official prefers to appoint an individual that has been out of law enforcement for more than 5 years. This new level of basic certificate and the process to achieve it will assist agencies in hiring personnel that can provide valuable insight, experience and knowledge. The process to achieve the certification is consistent with the reciprocity process, therefore allowing the individual to work while completing the online course and not having to complete a full, in person, basic academy, saving the agency valuable time and money.

**Summary Public Response:**

Public response was supportive. Mr. Reshaw was to support the idea that a Command Level basic certificate would be beneficial to agencies.

Sheriff Furlong felt there should not be a restriction of two (2) certificates per agency, and felt the physical fitness test should be mandatory.

Undersheriff Bill Becht was supportive of the certification, and this would be a way for him to be certified again.

Sheriff Joe McGill was in support of the physical fitness test being based on the agency requirement.

Because this regulation amends Nevada Administrative Code Chapter 289, the proposed amendment to NAC 289 will have no impact on small business.

This regulation meets the requirements and was adopted with no changes.

Adverse- a fee of \$200.00 to the employing agency payable upon enrollment.

Beneficial – Agencies will save time and money by having their staff attend the online course instead of paying for a full basic academy and losing a much-needed officer while they attend a full basic academy.

**2)Both immediate and long-term effects**

Immediate effect – This change will shorten the hiring process for Nevada agencies. This will allow agencies to hire experienced staff who will be on the job during the process of certification.

Long Term effect – Agencies will have the ability to hire executive level staff that will bring knowledge and experience to their agencies.
