The regulation was adopted after discussion at one Commission Meeting and was adopted with three small changes as discussed during the meeting. The first change on page 5 clarifies a deadline, the second change on page 6 also clarifies a deadline. The third change removes section 6, as that section is currently being dealt with in a different regulation.
