**Legislative Review of Adopted Regulations as Required by NRS 233B.066**  
LCB File #R054-23

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 388:

**1. A clear and concise explanation of the need for the adopted regulation.**

AB400 (2023) allows for cities and counties to become charter school authorizers, thus changing the charter landscape and requiring some changes to authorizing processes.

Public comment was solicited through both the regulation workshop and public hearing. The attached workshop agenda and notice was posted 15 days prior to the workshop. The attached public hearing agenda and notice was posted 30 days prior to the public hearing. A description of how members of the public could provide comment is included in both items.

There was no public comment at either the workshop or the public hearing.

The Nevada Department of Education adopted the proposed regulation language at the public hearing held on March 29, 2024. No changes were requested, so it was adopted without change.
