#### Informational Statement for LCB File No. R068-23

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 630.

#### 1. A Clear and Concise Explanation of the Need for the Adopted Regulation.

The proposed regulation is necessary to update NAC Chapter 630 to comport with changes made to NRS Chapter 630 and to ensure consistency between NAC Chapter 630 and NRS Chapter 630, to add provisions that will better protect the public by defining a license that is in good standing, adding specificity to obtaining informed consent from patients prior to providing medical treatment in certain situations, and ensuring that advanced practice registered nurses are limited to prescribing the same substances as their collaborating physicians, and to clarify existing NAC Chapter 630 provisions that may not have been clear prior to these changes.

# 6. If the Regulation Was Adopted Without Changing Any Part of the Proposed Regulation, A Summary of the Reasons for Adopting the Regulation Without Change.

This regulation was adopted by the Board at a public meeting held on Friday, June 7, 2024. It was adopted with necessary changes that were identified after review of the LCB RP1 draft. These changes were reviewed and discussed with members of the public at the May 7, 2024 public regulation hearing and prior to the June 7, 2024 adoption hearing. It was adopted with the changes shown in the enclosed memorandum dated June 21, 2024.

7. The Estimated Economic Effect of the Adopted Regulation on the Businesses Which It Is to Regulate and on the Public. These Must Be Stated Separately, And Each Case Must Include: (a) Both Adverse and Beneficial Effects; and (b) Both Immediate and Long-Term Effects.

#### (a) Both Adverse and Beneficial Effects.

The proposed regulation does not impose a direct and significant economic burden upon a small business or directly restrict the formation, operation, or expansion of a small business. The proposed regulation clarifies existing law and regulations and adds regulations regarding continuing medical education as directed by the Nevada Legislature. Adding clarity to existing law and regulations should be beneficial to businesses and licensees. The proposed regulation will not have an economic effect on the public.

#### (b) Both Immediate and Long-Term Effects.

The Board believes that the proposed regulation will not have immediate or long-term direct economic benefit on the business of the practice of medicine. The proposed regulation clarifies existing law and regulations and adds regulations regarding continuing medical education as directed by the

Nevada Legislature. Adding clarity to existing law and regulations should be beneficial to businesses and licensees.

There is no additional cost to the Board to enforce the proposed regulations.
