The following informational statement is provided pursuant to NRS 233B.066

This regulation is needed to streamline the application process and increase or establish the following fees: renewal of a license or certificate; fee for an examination; and approval of all courses of continuing education.

(b) A description of how public comment was solicited, a summary of the public response and an explanation of how other interested persons may obtain a copy of the summary.

Public comment was solicited by public notice and by email when the Board submitted the proposed changes to the licensing community and other potentially affected parties to survey their thoughts regarding the proposed revisions. The Board also noticed and conducted a public workshop and then noticed and conducted a public hearing on this matter.

Public comment was supportive of the regulation.

The regulation was adopted without any changes. The industry is supportive of the changes.

- (g) The estimated economic effect of the regulation on the business which it is to regulate and on the public. These must be stated separately, and in each case must include:
 - (1) Both adverse and beneficial effects:

Adverse effects: There are no adverse effects of this regulation on the businesses it regulates nor on the public.

Beneficial effects: This will allow the Board to streamline the process for applications and with the increase in fees it will help the Board continue its operations.

Immediate effects: Streamlined application process and increased fees for the continuation of the operations of the Board.

Long-term effects: Streamlined application process and continuation of Board operations.

- (h) The estimated cost to the agency for enforcement of the proposed regulation. There is no cost to the Board for enforcement of this regulation.
- (i) A description of any regulations of other state or government agencies which the proposed regulation overlaps or duplicates and a statement explaining why the cuplication or overlapping is necessary. There are no other state or government agencies that overlap this regulation.

This regulation does not contain any provisions which are more stringent than a federal regulation that regulates the same activity.

There is an increase to a fee. The Board anticipates that it will raise an additional \$4,800 with the increase to the costs of the continuing education, an additional \$17,600 with the cost of the increase to the renewal fees. These increases will help the Board offset increased cost associated with salaries for staff and fees charged the Board for Board operations.
