Legislative Review of Adopted Regulations as Required by NRS 233B.066
LCB File #R099-23

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 388:

1. A clear and concise explanation of the need for the adopted regulation.

This regulation is necessary because updates to the standard high school diploma and adult graduation requirements are overdue and the criteria needs to be revised.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

Public comment was solicited through both the regulation workshop and public hearing. The attached workshop agenda and notice was posted 15 days prior to the workshop. The attached public hearing agenda and notice was posted 30 days prior to the public hearing. A description of how members of the public could provide comment is included in both items.

Two workshops were held. The first was on September 21, 2023 and the second was February 9, 2024. A copy of the summary of public responses to the proposed regulation may be obtained from the NDE by contacting Alicia Briancon at 775-443-5519 or alicia.briancon@doe.nv.gov.

February 9, 2024 workshop: In summary, there was concern about the timeline for changes to the standard diploma.

April 15, 2024 hearing: In summary, the concern was over the impact on the 2025 graduating class and reducing connection between students and school as related to removing subjects that spark passion, which makes students want to attend school.

July 31, 2024 hearing: In summary, public comment asked for consideration of the graduating class of 2029 and keeping the arts/humanities/CTE credit requirements for the standard diploma.

October 2, 2024 hearing: Public comment was in favor of the 2029 change.

The Nevada State Board of Education, adopted the proposed regulation language with no changes at the public hearing held on July 31, 2024 from the June 12, 2024 hearing as a result of extensive changes throughout the regulation process. It was not passed at the Legislative Commission meeting on 9/13/24 and language was changed to address concerns regarding the implementation date. The new date is for the graduating class of 2029. The language change was resolved prior to the adoption hearing and was sharing with the districts for feedback. The districts approved the changes. On October 2, 2024 the regulation was adopted with no changes.

Notice of Intent to Act Upon a Regulation

Notice of Hearing for the Adoption of Regulations of the Nevada State Board of Education as proposed in LCB File #R099-23.

The STATE BOARD will hold a public hearing at **2:00 PM** on Wednesday, October 2nd, 2024, via [Livestream Link](#). The purpose of the hearing is to receive comments from all interested persons regarding the amendment of regulations pertaining to NAC 388.XXX and of the Nevada Administrative Code (NAC), pursuant to NRS 385.080 sections 1, 3, 2, and 9, NRS 385.080, NRS 385.11, NRS 388.360, NRS 389.021, NRS 390.600, NRS 385.080, NRS 385.114, NRS 389.021, NRS 390.021, NRS 39.600, NRS 385.080, and NRS 385.114 regarding course of study required for graduation from a public high school.
