PROPOSED REGULATION OF THE BOARD OF WILDLIFE COMMISSIONERS COMMISSION GENERAL REGULATION 514

EXPLANATION - Matter in *italics* is new; matter in brackets [omitted material] is material to be omitted.

AUTHORITY: §§1-4, NRS 501.105, 501.181, 502.103, 502.160 and 502.250; §5, NRS 501.105, 501.181, 502.160, 502.219 and 502.250.

Newly requested NAC 502-"Antlered moose" defined. Any moose having at least one antler that is visible above the hairline of the skull of the moose.

Newly requested NAC 502-"Antlerless moose" defined. Any moose without antlers.

Newly requested NAC 502-"Antlered moose only" defined. "Antlered moose only" means in a designation of moose that may be taken during an open season, only moose having at least one antler.

Newly requested NAC 502 "Antlerless moose only" defined. "Antlerless moose only" means in a designation of moose that may be taken during an open season, only moose without antlers.

Newly Requested NAC 502 - Moose: Tags; fees; inspection.

- 1. Before a person may hunt a moose, he or she must obtain a tag from the Department. Except as otherwise provided by a regulation of the Commission or title 45 of NRS, or unless his or her privilege is limited or revoked pursuant to law, a resident of Nevada or nonresident is eligible to apply for a tag to hunt a moose in a year if he or she did not receive a tag or a replacement tag to hunt moose within their lifetime.
 - 2. The fee for:
 - (a) A resident antlered moose tag is \$120.
 - (b) A nonresident antlered moose tag is \$1200.
 - (c) A resident antlerless moose tag is \$120.
 - (d) A nonresident antlerless moose tag is \$1200.
- 3. A person who harvests a moose shall, within 5 days after harvesting it, personally present the skull and horns of the moose to a representative of the Department for inspection.

NAC 503.173 Maintenance of cape or scalp and antlers or horns with carcass of wildlife. (NRS 501.105, 501.181) Except as otherwise provided in NAC 502.403, any person who kills a deer, elk, mountain goat, antelope, *moose*, or bighorn sheep shall, until the carcass is frozen, smoked, dried, consumed or accepted by a commercial processing plant for processing, maintain possession of at least that portion of the cape

or scalp that includes the ears to the base of the muzzle and any antlers or horns. The cape or scalp and any antlers or horns from the animal must be possessed in such a manner that they remain or are kept together with the carcass of the animal.
