Commission General Regulation 511**

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapters 504.

1. A clear and concise explanation of the need for the adopted regulation:

This regulation is necessary for updating regulations on Wildlife Management Areas after the acquisition of additional properties.

2. Description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary:

How comments were solicited:

Public comment was solicited during one regulation workshop of the Nevada Board of Wildlife Commissioners (NBWC) on September 23, 2023.

There was one public comment from the Clark County Advisory Board.

Public comment was solicited for the permanent regulation during one adoption hearing with the Nevada Board of Wildlife Commissioners (NBWC) on March 9, 2024.

There was one public comment from the Clark County Advisory Board.

Summary:

The public comments at both meetings surrounded accessibility on the wildlife management area. The Department addressed that concern with the Chairman of the Clark County Advisory Board.

6. **If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change:**

The regulation was adopted after discussion at one Commission Meeting and was adopted with two changes as discussed during the meeting. The first change on page 3 clarifies guide services on the WMA, the second change on page 4 removes Section 4(2)(b).
