LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY NRS 233B.066 LCB FILE R002-24

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 641.

1. A clear and concise explanation of the need for the adopted regulation.

This regulation was prepared to revise some of the Board's regulations regarding the supervision of psychological assistants, psychological interns, and psychological trainees in order to ensure they align with best practices in supervision and create more efficiency, clarity, and consistency in the Board's registration of psychological assistants, psychological interns, and psychological trainees. Included in the revisions to some of the Board's regulations that govern supervision of psychological assistants, psychological interns, and psychological trainees were, for example:

- Aligning training programs with current models,
- eliminating an arbitrary qualification for supervisors in favor of a more competency-based qualification,
- stating how many supervisees and supervisor can supervise,
- specifying the amount of supervision to be employed for each level of training, and
- addressing the availability of supervisors to their supervisees.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

Notice of a public workshop and notices of intent to act upon the regulation were sent to persons who were known to have interest in the requirements for supervision of psychological assistants, psychological interns, and psychological trainees in the state of Nevada, to the Board's licensees, and to any specific person who requested notification regarding regulation changes. That distribution included further information on how to receive a free copy of the proposed regulation. These documents were also made available through the website of the Board of Psychological Examiners (psyexam.nv.gov) or by directly emailing the Board office (NBOP@govmail.state.nv.us), and were posted at the following locations:

The Board held a workshop on November 3, 2023, to discuss the proposed changes to the current NAC Chapter 641. The Board received verbal public comment from one member of the public in attendance. That member of the public requested that the Board's regulation avoid binary language in the proposed provisions, sought clarification of several provisions, and made suggestions for revisions. The minutes of that meeting, which can be obtained through contacting the Board office or locating them on the Board's website (psyexam.nv.gov), contain a summary of the discussion regarding the proposed changes.

The Board held a second workshop on December 15, 2023, for further discussion on the proposed changes to the current NAC Chapter 641. The Board received verbal public comment from one member of the public in attendance, who agreed with a revision to the proposed language, sought clarification about a provision, and made a suggestion for clarification. The minutes of that meeting, which can be obtained through contacting the Board office or locating them on the Board's website (psyexam.nv.gov), contain a summary of the discussion regarding the proposed changes.

On March 12, 2024, the Board issued and posted a Notice of Intent to Act Upon a Regulation, which incorporated the proposed regulation changes that the Board discussed at its November 3, 2023, and December 15, 2023, regulation workshops. That notice included a request for submission of public comment regarding adoption of the regulation.

On April 12, 2024, the Board conducted a public hearing on R0002-24 during its regular Board meeting. The Board received written inquiry/comment from one member of the public and verbal public inquiry from one other member of the public in attendance at the meeting, but no opposition to the adoption of the regulation. The public member that commented sought clarification about one of the regulation provisions. As a result of its workshop and hearing discussions, the Board revised the R002-24 draft and submitted those revisions to the Legislative Counsel Bureau (LCB) for review and approval.

On May 6, 2024, the Board issued and posted a Notice of Intent to Act Upon a Regulation, which incorporated the proposed regulation changes that the Board discussed at its April 12, 2024, regulations hearing. That notice included a request for submission

of public comment regarding adoption of the regulation.

On June 7, 2024, after the Board received an approved, revised R002-24 draft from the LCB, the Board conducted a public hearing on R002-24 during its regular Board meeting. The Board received verbal public inquiry/comment from one member of the public in attendance at the meeting, but no opposition to the adoption of the regulation. The public member that commented sought clarification about one of the regulation provisions. The Board approved the adoption of proposed regulation R002-24 at the conclusion of the hearing on that regulation.

5. A description of how comment was solicited from affected business, a summary of their response, and an explanation of how other interested persons may obtain a copy of the summary.

The Board solicited comments from affected businesses in the same manner as they were solicited from the public. Notice of a public workshop and notice of intent to act upon the regulation were sent to persons who were known to have interest in supervision and the registration of psychological assistants, psychological interns, and psychological trainees, to the Board's licensees, and to any specific person who requested notification regarding regulation changes. The summary of the Board's discussion may be obtained through the minutes, which will be provided and/or made available by contacting the Board office or locating them on the Board's website (psyexam.nv.gov). The Board received written and verbal public comment/inquiry as noted and outlined above.

As explained above, the regulation was revised more than once based on public comment and feedback, as well as a misunderstanding by the Legislative Counsel Bureau of the intent of the regulation in one of the drafts it provided to the Board.
