Legislative Review of Adopted Regulations as Required by NRS 233B.066
LCB File #R008-24

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 391:

1. A clear and concise explanation of the need for the adopted regulation.

This regulation is necessary to comply with Senate Bill 442 (2023) codified in NRS 391B. This regulation is also necessary to raise the fees for application of an educator license to keep the Department of Education Licensure Office solvent due to increased operating and labor costs. Fees have not been raised since April 2018.

2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.

Public comment was solicited through both the regulation workshop and public hearing. The attached workshop agenda and notice was posted 15 days prior to the workshop. This regulation was adopted without any changes on 07/31/24 because the agency and Commission engage stakeholders in workgroups to draft agreed upon language prior to the Workshop & Hearing.

7. The estimated economic effect of the adopted regulation on the business which is to regulate and on the public. These must be stated separately and each case must include:

There will be no economic effect of the regulation on the business that it regulates. There is no estimated economic effect on the general public. There will be an estimated economic effect for educators of an additional \$20.00 for an initial, renewal, retiree, or additional endorsement application upon passage and smaller incremental increases of \$5.00 annually on July 1 of each year through 2028. There is no adverse or beneficial effect or immediate or long-term effect on the business that it regulates. There is no adverse or beneficial effect or immediate or long-term effect to the general public. There is no adverse immediate or long-term effect on educators other than the incremental fee increase. The immediate or long-term beneficial effect for educators will be maintaining shorter customer service response time and decreased application processing time.

8. The estimated cost to the agency for enforcement of the adopted regulation.

There is no additional cost to the agency for enforcement of this regulation.

9. **A description of any regulations of other state or government agencies which the proposed regulation overlaps or duplicates and a statement explaining why the duplication or overlapping is necessary. If the regulation overlaps or duplicates a federal regulation, the name of the regulating federal agency.**

No other state or governmental agency regulations will be overlapped or duplicated by the above noted regulation. There is no duplication or overlap of federal regulations.

This regulation does not provide for a new fee. This regulation does increase an existing fee for an application for an educator license as follows:

Upon Passage:

Initial application \$180 > \$200

Renewal application \$150 > \$170

Additional endorsement application \$50 > \$70

July 1, 2025:

Initial application \$200 > \$205

Renewal application \$170 > \$175

Additional endorsement application \$70 > \$75.

July 1, 2026:

Initial application \$205 > \$210

Renewal application \$175 > \$180

Additional endorsement application \$75 > \$80

July 1, 2027:

Initial application \$210 > \$215

Renewal application \$180 > \$185

Additional endorsement application \$80 > \$85

July 1, 2028:

Initial application \$215 > \$220

Renewal application \$185 > \$190

Additional endorsement application \$85 > \$90

There will be no further fee increases after July 1, 2028, unless acted upon through regulation.

The total average amount the agency collected annually from 2019-2023 was \$2,581,200.

The total amount the agency expects to collect upon passage through June 30, 2025, assuming effective date of regulation to be September 16, 2024 – \$2,560,610.

July 1, 2025 through June 30, 2026 - \$3,012,675.

July 1, 2026 through June 30, 2027 - \$3,098,970.

July 1, 2027 through June 30, 2028 - \$3,185,265.

July 1, 2028 through June 30, 2029 - \$3,271,560.

The collected fees will be used to pay for increased overhead, operations, and labor costs for Budget Account 2705.

- *Prescribing the qualifications for licensing teachers and other educational personnel and the procedures for the issuance and renewal of those licenses.*

NRS 391.040, the Commission on Professional Standards in Education shall adopt regulations:

- *Prescribing fees for issuance and renewal of licenses; fee for duplicate license; waiver of fees for certain persons affiliated with Armed Forces.*

2. Description of the proposed regulation, or the subjects and issues involved: The proposed regulation is relating to educational personnel; revising requirements for endorsements to teach certain subjects; revising the subjects recognized for an endorsement to teach middle school or junior high school; increasing the fees for the issuance or renewal of certain licenses; and providing other matters properly relating thereto. This regulation will change the Parent Involvement and Family Engagement course from an initial provision to a renewal requirement, require a special education course for initial preparation programs, increase application fees, and add computer science as a middle school endorsement area.
