The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapters 504.

1. A clear and concise explanation of the need for the adopted regulation:

This regulation is designed to help define and regulate the big game tag deferral option within the extenuating circumstances regulation adopted in LCB File #R022-19. This regulation also clarifies provisions of NRS 502.104

2. Description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary:

How comments were solicited:

Public comment was solicited at the Tag Allocation and Application Hunt Committee Meeting on January 25, 2024.

Public comment was solicited during one regulation workshop of the Nevada Board of Wildlife Commissioners (NBWC) on March 9, 2024.

There was one public comment from the Clark County Advisory Board.

Public comment was solicited for the permanent regulation during one adoption hearing with the Nevada Board of Wildlife Commissioners (NBWC) on May 4, 2024.

There was no public comment.

Summary:

The public comment at the workshop solely addressed what happens to a deferred tag when the unit closes. The department worked with the Deputy Attorney General to address this concern and the adopted version of the regulation.
