#### Informational Statement for LCB File No. R033-24

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 630.

1. A Clear and Concise Explanation of the Need for the Adopted Regulation.

The proposed regulation is necessary to protect the public by requiring physicians to designate their medical specialty area to the Board and limiting their practice and that of any physician assistants to the area that they have designated, determine the supervisor of a certified nurse anesthetist in critical access hospitals to be the treating physician of the patient, require the Board to notify applicants of deficiencies in their applications, authorizes applicants to appeal the denial of their applications, prohibit licenses of the Board from engaging in sexual impropriety with their patients, update the procedure for submission and consideration of certain petitions or requests, abolish locum tenens licensure for physician assistants, and abolish the physician assistant advisory committee and practitioner of respiratory care advisory committee because they are no longer needed.

# 6. If the Regulation Was Adopted Without Changing Any Part of the Proposed Regulation, A Summary of the Reasons for Adopting the Regulation Without Change.

This regulation was adopted by the Board at a public meeting held on Friday, June 7, 2024. It was adopted with changes that were identified. These changes were reviewed and discussed with members of the public at the May 16, 2024 public workshop, the May 29, 2024 public regulation hearing, and the June 7, 2024 adoption hearing. It was adopted with the changes shown in the enclosed memorandum dated June 21, 2024.

7. The Estimated Economic Effect of the Adopted Regulation on the Businesses Which It Is to Regulate and on the Public. These Must Be Stated Separately, And Each Case Must Include: (a) Both Adverse and Beneficial Effects; and (b) Both Immediate and Long-Term Effects.

#### (a) Both Adverse and Beneficial Effects.

The proposed regulation does not impose a direct and significant economic burden upon a small business or directly restrict the formation, operation, or expansion of a small business. The proposed regulation clarifies existing law and regulations and adds regulations that are necessary to protect the public. Adding clarity to existing law and regulations should be beneficial to businesses and licensees.

### (b) Both Immediate and Long-Term Effects.

The Board believes that the proposed regulation will not have immediate or long-term direct economic benefit on the business of the practice of medicine. The proposed regulation clarifies existing law and regulations and adds regulations that are necessary to protect the public. Adding clarity to existing law and regulations should be beneficial to businesses and licensees.

There is no additional cost to the Board to enforce the proposed regulations.
