The regulation is necessary to comply with the requirement that the Commissioner of Insurance issue network adequacy standards required of all network plans. See Nevada Revised Statutes ("NRS") 687B.490 and NAC 687B.750 to 687B.784. The purpose of the regulation is to establish adequacy standards for network plans for plan year 2025.
