

**NRS 233B.066 Informational Statement  
LCB File No. R187-24**

**1. A clear and concise explanation of the need for the adopted regulation.**

The regulation repeals and/or amends existing regulations governing pay phones, telephone directories, and renewable energy programs that are ending or have ended; in accordance with the mandate in Governor Lombardo’s Executive Order 2023-003 to promote government efficiency, clarity, transparency, and to eliminate outdated regulations.

**2. Description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.**

(a) Copies of the proposed regulation, notice of intent to act upon the regulation, and notice of workshop and hearing were sent by U.S. mail and email to persons who were known to have an interest in the subjects of noticing and interventions, as well as to all county libraries in Nevada. (b) The Commission opened this rulemaking docket on November 8, 2023, to repeal and/or amend certain regulations. The revised and newly proposed regulation resulting from the opening of this rulemaking docket is LCB File No. R187-24. The Commission filed a draft proposed regulation on July 18, 2024, that was sent to the Legislative Counsel Bureau (“LCB”) for review. Following LCB review, there was a workshop held on November 25, 2024, and a hearing held on November 26, 2024, to discuss public comments and the draft regulation language returned from LCB. LCB further reviewed the Commission’s proposed regulation and returned the final regulation to the Commission on October 18, 2024.

(c) **A summary of public response.** All participants in this rulemaking provided written comments and/or statements during the workshop and hearing reflecting general agreement upon the draft regulation.

5. **A description of how comment was solicited from affected businesses, a summary of their response and an explanation of how other interested persons may obtain a copy of the summary.**

The Commission finds that the regulation language, as returned from LCB, is in the public interest and conforms with Governor Lombardo's Executive Order 2023-003. The proposed regulation amends, repeals, and clarifies regulations surrounding pay phones, telephone directories, and renewable energy programs that have ended or are ending.

- (a) **Estimated economic effect on the businesses which the regulation is to regulate.**

The regulation helps clarify the winding up of the renewable energy programs contained therein, and eliminates outdated regulations regarding those energy programs, pay phones, and telephone directories. The regulation is not expected to negatively affect the businesses which the regulation is to regulate, and any positive effect would be de minimus.

- (b) **Estimated economic effect on the public which the regulation is to regulate.**

The regulation does not regulate the public.

The agency will not incur additional costs from enforcing the regulation.

- 12. If the proposed regulation is likely to impose a direct and significant burden upon a small business or directly restrict the formation, operation or expansion of a small business, what methods did the agency use in determining the impact of the regulation on a small business?**

The independent Regulatory Operations Staff of the Commission (“Staff”) conducted a Delphi Method exercise to determine the impact of this proposed regulation on small businesses. The Delphi Method is a systematic, interactive forecasting method based on independent inputs of selected experts. In this instance, the participants were members of Staff. The participants in the exercise used their background and expertise to reflect upon and analyze the impact of the proposed regulation on small businesses. Based upon Staff’s analysis, Staff recommended to the Commission that the Commission find that the proposed regulation will not impose a direct and significant economic burden on small businesses or directly restrict the formation, operation or expansion of a small business. The Commission accepted Staff’s recommendation and found that the proposed regulation does not impose a direct or significant economic burden upon small businesses, nor does it directly restrict the formation, operation, or expansion of a small business, therefore concluding that a small business impact statement pursuant to NRS 233B.0608(2) is not required. This finding was memorialized in an order issued in Docket No. 23-11008 on September 11, 2024.
