### Informational Statement Form

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 706.

## 1. A clear and concise explanation of the need for the adopted regulations.

The revision changing in the language in NRS 706.440 from 48 hours to 96 hours, allows the public additional time to collect their personal belongings from a vehicle that was towed, allowing further protection for the public.

# 2. A description of how public comment was solicited, a summary of public response, and an explanation how other interested persons may obtain a copy of the summary.

A workshop was held on April 21, 2023, prior to this meeting to solicit information from the public and tow carrier community to ascertain what revisions were needed and how to most fairly implement them.

A summary of the public response at the April 21, 2023 workshop: several members of the public spoke and submitted forms for proposed revisions to the regulations. The members of the public called for the revisions to the regulations and were pleased that the Authority was holding a workshop to solicit comments as to the type of revisions the public wanted.

On June 21, 2024 a publication was sent for Notice of Hearing for Adoption of Regulations.

A summary of the June 21, 2024 public response: the public was pleased with the revisions made to the regulations. The public approved of the revisions and believed the authority took their comments and concerns into account when making the revisions.

Comments were solicited from affected businesses in the same manner as they were solicited from the public. A workshop was held on April 21, 2023 to allow the affected businesses and they public to provide the Authority with their wishes for the revision. The effected businesses understood the need to allow the public a greater time frame to collect their personal belongings from a towed vehicle. A summary of the public response can be found in the same manner as the summary from Question #2.

The permanent regulations were adopted on July 23, 2024 and included all the changes suggested at the workshop meeting held on April 21, 2023. The regulations were adopted without change as they were in line with the comments solicited from the public and the goals of the agency in amending the regulations.
