LCB FILE NO. R048-24 Small Business Impact Statement pursuant to NRS233.0608:

(a) **A description of the manner in which comment was solicited from affected small business, a summary of their response and an explanation of the manner in which other interested persons may obtain a copy of the summary.** to NRS 233B.0609 (1), The division posted the proposed regulation on the Division's website as well as hard copies sent to interested parties for comment. No comments were received by the division for review.). Other interested parties may obtain a copy of the summary by either visiting the state fire marshal website to download the summary or request a copy of the summary directly to the State Fire Marshal.

(b) **The manner in which the small business analysis was conducted for LCB file No. R048-24.**

1. The State Fire Marshal has been working with industry constituents who represent fire and smoke damper system testing and inspections as statutorily directed by NRS477.030(1). The methodology used to determine that a significant impact to small business will not occur was a result and meetings with the fire protection industry. During these workshops and meetings, we identified our intent to adopt regulations relating to the maintenance and testing of fire dampers, smoke dampers and combination fire and smoke damper or smoke control systems. Notices were sent to all fire protection businesses of our specific intent to increase fees.
