These proposed regulations are not controversial; they merely implement updated versions of the building codes, eliminate redundancies, update terminology, and dollar limits for formal consultant selection. Certain proposed regulations were made in response to the Governor's Executive Order 2023-003. Minor revisions were made after the Workshop clarifying intent. Minor revisions were also made in response to the Legislative Counsel Bureau's due diligence, which provided clarity and accuracy, but did not change the intent of the initial proposed regulations.
