### **(a) A description of the manner in which comment was solicited from affected small business, a summary of their response and an explanation of the manner in which other interested persons may obtain a copy of the summary.**

The Nevada State Board of Dental Examiners (NSBDE) received one (1) public comments during the one workshop it held on April 20, 2022 regarding the proposed regulations; neither comment was from any small businesses. The NSBDE posted proposed changes to NAC 631 on the NSBDE's website for the public to review and comment and held multiple public hearings as well as a public hearing on the intent to adopt regulations on May 16, 2024.

In addition to written public comments submitted for reading during any of the NSBDE's open meetings, interested persons were invited to submit Statements of Impact to: Executive Director, Nevada State Board of Dental Examiners, 2651 N Green Valley Pkwy, Ste 104, Henderson, NV 89014; email [nsbde@dental.nv.gov](mailto:nsbde@dental.nv.gov); or fax (702) 486-7046.

### **(b) Method used to determine the impact on small businesses.**

Public notices of the workshop and of upcoming hearings were posted as required by Open Meeting Law (NRS 241) and the Administrative Procedure Act (NRS 233B). Mailings of said notices were also sent, upon request, to any interested parties, including affected practitioner associations within Nevada. Notices were also posted on the website maintained by the NSBDE, <http://www.dental.nv.gov>. Comments were recorded at each meeting, if offered, and are available for inspection at the NSBDE office and upon request.

The comments from the public meetings and any Statements of Impact sent directly to the NSBDE were taken into consideration when drafting the economic effect/estimated cost statement that will be included in the Public Notice of Hearing and Intent To Act Upon Regulations, which was posted, pursuant to NRS 233B.060, no less than thirty (30) days prior to the hearing.

Based on the input received, the NSBDE determined that the proposed regulations would not have an adverse economic effect on small business as said proposed regulations would simply further ensure confidentiality and due process of the disciplinary proceedings conducted by the NSBDE without any increase in expense to licensees. Therefore, the NSBDE concluded that the proposed regulations would not impose a direct and significant economic burden upon a small business.
