Informational Statement

Notice of Adoption of Regulation

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter **242**.

- A clear and concise explanation of the need for the adopted regulation: This regulation is
 necessary to update the regulations to comply with recent statutory changes, specifically those
 brought about by Senate Bill No. 431 from the 2023 Legislative Session, which reorganized the
 responsibilities of the Office of the Chief Information Officer.
- 2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary: Copies of the proposed regulations, notices of the workshop, and notices of intent to act upon the regulation were sent by email to individuals and entities known to have an interest in information services regulations, as well as those who had specifically requested such notice. These documents were also made available on the Office of the Chief Information Officer's website and posted at various public locations, including the Nevada State Library and Archives, the Legislative Building, and the Grant Sawyer Building. A public hearing was held on August 7, 2024. No public responses were received during the solicitation process. The Minutes of the public response can be obtained from https://it.nv.gov/Governance/Meetings/.

- 70 A description of how comment was solicited from affected businesses, a summary of their response, and an explanation of how other interested persons may obtain a copy of the summary: Comments were solicited from affected businesses in the same manner as they were from the public. No responses were received from affected businesses. The summary may be obtained as instructed in the response to item #2.
- 80 If the regulation was adopted without changing any part of the proposed regulation, a summary of the reasons for adopting the regulation without change: The regulation was adopted on August 14, 2024, as proposed, without changes, as no substantive feedback was received that necessitated amendments.

 - **10** On Businesses: There are no impacts on businesses, as these regulations govern IT policies specifically for executive branch agencies.
