

**LEGISLATIVE REVIEW OF ADOPTED REGULATIONS AS REQUIRED BY  
NRS 233B.066  
LCB FILE R095-23**

The following statement is submitted for adopted amendments to Nevada Administrative Code (NAC) Chapter 641.

**1. A clear and concise explanation of the need for the adopted regulation.**

This regulation was in response to 2023 AB244, which, as enacted, violates ethics codes for licensed Psychologists as it relates to psychological examinations and testing. [See the Nevada Board of Psychological Examiners' Statement in Response to 2023 AB244](#). The Nevada Board of Psychological Examiners (Board) considered and adopted the regulation revisions in order to address the impact that 2023 AB244 had on Nevada's Psychologists who undertake psychological examinations and administer standardized measures.

**2. A description of how public comment was solicited, a summary of public response, and an explanation of how other interested persons may obtain a copy of the summary.**

Notice of a public workshop and notices of intent to act upon the regulation were sent to persons who were known to have interest in the impact of 2023 AB244 on Nevada's licensed Psychologists in the context of their ethical obligations, to the Board's licensees, and to any specific person who requested notification regarding regulation changes. That distribution included further information on how to receive a free copy of the proposed regulation. These documents were also made available through the website of the Board of Psychological Examiners ([psyexam.nv.gov](http://psyexam.nv.gov)) or by directly emailing the Board office ([NBOP@govmail.state.nv.us](mailto:NBOP@govmail.state.nv.us)), and were posted at the following locations:

The Board held a workshop on October 13, 2023, to discuss the proposed changes to the current NAC Chapter 641. The minutes of that meeting, which can be obtained through contacting the Board office or locating them on the Board's website ([psyexam.nv.gov](http://psyexam.nv.gov)), contain a summary of the discussion regarding the proposed changes. There was no written or verbal public comment related to the regulation revisions at that workshop.

On February 6, 2024, after the Board received the LCB's draft of the Board's proposed regulation changes in response to 2023 AB244, the Board issued and posted a Notice of Intent to Act Upon a Regulation, which incorporated the proposed regulation changes that the Board discussed at its October 13, 2023, regulations workshop. That notice included a request for submission of public comment regarding adoption of the regulation.

On March 8, 2024, the Board conducted a public hearing on R095-23 during its regular Board meeting. The minutes of that meeting, which can be obtained through contacting the Board office or locating them on the Board's website ([psyexam.nv.gov](https://psyexam.nv.gov)), contain a summary of the discussion regarding the proposed changes. The Board received verbal public comment from four members of the public in attendance at the meeting, but no opposition to the adoption of the regulation. The public comments generally concerned regulation wording to ensure clarity, distinctions in and/or definition of terms included in the regulation, the relationship between the regulation and NRS Chapter 629, and references to applicable standards and how those standards address protected psychological test information. As a result of that public comment, the Board continued the hearing until a future Board meeting so that the proposed regulation could be further revised.

On March 12, 2024, the Board issued and posted a Notice of Intent to Act Upon a Regulation, which incorporated the proposed regulation changes that the Board discussed at its March 8, 2024, regulations hearing. That notice included a request for submission of public comment regarding adoption of the regulation.

On April 12, 2024, the Board conducted a public hearing on R095-23 during its regular Board meeting. The minutes of that meeting, which can be obtained through contacting the Board office or locating them on the Board's website ([psyexam.nv.gov](https://psyexam.nv.gov)), contain a summary of the discussion regarding the proposed changes. The Board had received two written comments prior to the hearing and received verbal public comment from three members of the public in attendance at the meeting, including inquiries regarding the regulation revisions, but no opposition to the adoption of the regulation. The verbal public comments and inquiries concerned how the regulation relates to the requirements in NRS Chapter 629 (a client's access to data), reference to the source that addresses where test data becomes test material, and the fact that psychologists are not the only ones who can buy and use testing from test publishers. The written public comment provided suggestions for regulation wording and how the proposed regulation relates to the relevant provisions of the APA code of conduct. As a result of that public comment, the Board revised the R095-23 draft and submitted those revisions to the Legislative Counsel Bureau (LCB) for review and approval.

On May 6, 2024, the Board issued and posted a Notice of Intent to Act Upon a Regulation, which incorporated the proposed regulation changes that the Board discussed at its April 12, 2024, regulations hearing. That notice included a request for submission of public comment regarding adoption of the regulation.

On June 7, 2024, after the Board received an approved, revised R095-23 draft from the LCB, the Board conducted a public hearing on R095-23 during its regular Board meeting. The minutes of that meeting, which can be obtained through contacting the Board office or locating them on the Board's website ([psyexam.nv.gov](https://psyexam.nv.gov)), contain a summary of the discussion regarding the proposed changes. The Board did not receive any written or verbal public comment related to the proposed, revised changes. The Board approved the adoption of proposed regulation R095-23 at the conclusion of that hearing.
