Small Business Impact Statement

EFFECTIVE DATE OF REGULATION: Upon filing with the Nevada Secretary of State **Proposed Regulation R119-23**

1. Background

The Commission on Construction Education (CCE) proposes amendments to the Administrative Code to define types of entities that can apply for grants.

2. Description of Solicitation:

Pursuant to NRS 2338.0608, the CCE made a concerted effort to determine whether the proposed regulation was likely to: 1) impose a direct and significant economic burden upon a small business, or 2) directly restrict the formation, operation, or expansion of a small business.

The CCE has determined that the proposed regulation change should not have an adverse financial impact upon a small business. To confirm the Board's analysis, it sent notice of workshop and notice of hearing to solicit comments on the proposed regulation was posted on the agency's website and on the Nevada Public Notice Website, State Library and Archives, both offices of the Nevada State Contractors Board. Additionally, the notice of workshop and hearing, and the proposed regulation were e-mailed electronically to approximately 501 individuals and organizations who have expressed interest in being kept informed of the Board's meetings. Public comment was solicited in the Notice of Workshop and Hearing which included the proposed regulation and small business impact statement.

Public comment was also solicited at the workshop held on February 1, 2024 and at the hearing held on February 15, 2024. The public workshop and hearing took place at the Board's offices at 8400 West Sunset Road, Suite 150, Las Vegas, Nevada 89113 with simultaneous videoconferencing with the Board's office at 5390 Kietzke Lane, Suite 102, Reno, Nevada 89511.

No public comments were received.

3. <u>Does the proposed regulation impose a direct and significant economic burden upon a small business or directly restrict the formation, operation or expansion of a small business?</u>

The regulation should not result in any adverse economic effect in either the immediate term or in the long-term on businesses.

The proposed regulation will not result in any cost to the Board. The regulation does not establish a new fee or increase an existing fee. There are no federal regulations that apply.

Ultimately, after its own analysis, public comment, public hearing, and consideration of economic impacts, no adverse economic effects were identified because the proposed regulation does not affect NRS Chapter 624 licensees or those who may seek to become a licensee.

4. How was that conclusion reached?

To reach its conclusion, the CCE has determined this change to who may apply for a grant will positively impact applicants by providing necessary clarification.

Ultimately, no adverse economic effects were identified because the proposed regulation changes do not adversely affect NRS Chapter 624 licensee or those who may seek to become a licensee. These changes should have no impact on small business.
