### INFORMATIONAL STATEMENT

### LCB File Number R126-23, relating to professional land surveying

The following information is provided pursuant to the requirements of NRS 233B.066.

### A. Need and Purpose of the Proposed Regulations.

The Nevada Board of Professional Engineers and Land Surveyors proposes amendments and repeals to Nevada Administrative Code in response to Governor Lombardo's Executive Order 2023-003 and 2023-004 which required streamlining, clarification, reduction, or improvement of existing regulations.

### LCB file number R126-23, related to professional land surveying.

NAC 625.651 is amended to remove reference to NAC 625.795 as it is proposed for repeal.

NAC 625.655 is amended to remove reference to NAC 625.795 as it is proposed for repeal.

NAC 625.664 is amended to remove reference to NAC 625.795 as it is proposed for repeal.

NAC 625.660 is proposed for repeal. A licensed professional should not need to be reminded in regulation that being in responsible charge of work means adhering to the statutes and regulations relating to their profession and the work performed.

NAC 625.668 is proposed for repeal. The regulation essentially restates what is written in NAC 625.666 – which is redundant/unnecessary.

NAC 625.690 is proposed for repeal. It is not necessary for section 1 to be stated in regulation, and section 2 is already stated in NRS 625.380.

NAC 625.795 is proposed for repeal. This regulation is outdated and no longer necessary.

### B. <u>Description of How Public Comment was Solicited</u>, <u>Response Summary</u>, <u>and Explanation of How Interested Parties May Obtain a Copy of Summary</u>.

In accordance with the requirements of NRS 233B.061 public workshops were held on March 27, 2023. Notice was given in excess of 15 days for the workshops, and e-mails were sent to 18,588 addresses of interested parties notifying them of the workshops and with direct links to relevant documentation. Public comment was received at the workshops. The minutes of the workshops are available to view at the Nevada Board of Professional Engineers and Land Surveyors website, <a href="https://nvbpels.org/board/meetings">https://nvbpels.org/board/meetings</a>.

An Interim Board Meeting relating to the regulation changes was held virtually on April 13, 2023, and was noticed according to NRS 241.020. Public comment was received at the board meeting. A Public Hearing was held virtually on April 20, 2023. The hearing was noticed in excess of the 30-day public posting requirement, and e-mails were sent to 18,588 addresses of interested parties notifying them of the hearing and with direct links to relevant documentation. Public comment was received before and during the hearing. An Intent to Act Upon Regulations Public Hearing was held in-person and virtually on March 14, 2024. The hearing was noticed in excess of the 30-day public posting requirement, and e-mails were sent to 16,054 addresses of interested parties notifying them of the hearing and with direct links to relevant documentation. Public comment was received during the hearing. Referencing the requirements of NRS 233B.0608, the Nevada Board of Professional Engineers and Land Surveyors requested input from owners and officers of professional engineering and land surveying small businesses via e-mailed survey link that was sent to 18,572 interested parties.
