SUMMARY—Requires a funeral director to report the names of certain deceased persons to the Office of Veterans’ Services. (BDR 54-162)

AN ACT relating to funeral directors; requiring a funeral director who obtains possession of the unclaimed human remains of a deceased person whom the funeral director knows, has reason to know or reasonably believes is a veteran to report the name of the deceased person to the Office of Veterans’ Services; requiring the Office to determine whether certain deceased persons are veterans who are eligible for interment at a national or veterans’ cemetery; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 **Section 1** of this bill requires a funeral director who obtains possession of the
2 unclaimed human remains of a deceased person whom the funeral director knows,
3 has reason to know or reasonably believes is a veteran to report the name of the
4 deceased person to the Office of Veterans’ Services not later than 1 year after
5 obtaining possession of the unclaimed human remains of the deceased person.
6 **Section 1** requires the Office of Veterans’ Services to determine whether a
7 deceased person whose name has been reported to the Office is a veteran who is
8 eligible for interment in a national cemetery or veterans’ cemetery and further
9 requires the Office to provide notice of such a determination to the funeral director.
10 **Section 1** provides that, if a deceased person is a veteran who is eligible for
11 interment in a national cemetery or veterans’ cemetery, a funeral director is
12 required to arrange for the proper disposition of the veteran’s remains.

13 **Section 1** additionally provides that a funeral director is not liable for any act or
14 omission with respect to complying with the requirements of **section 1**.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 642 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. A funeral director who obtains custody of the unclaimed
4 human remains of a deceased person whom the funeral director
5 knows, has reason to know or reasonably believes is a veteran
6 shall report the name of the deceased person to the Office of
7 Veterans' Services not later than 1 year after obtaining custody of
8 the unclaimed human remains of the deceased person.*

9 *2. Upon receipt of a report made pursuant to subsection 1,
10 the Office of Veterans' Services shall determine whether the
11 deceased person is a veteran who is eligible for interment at a
12 national cemetery pursuant to 38 U.S.C. § 2402 or a veterans'
13 cemetery pursuant to NRS 417.210. The Office of Veterans'
14 Services shall provide notice of the determination to the funeral
15 director.*

16 *3. If the Office of Veterans' Services provides notice to a
17 funeral director of a determination that a deceased person is a
18 veteran who is eligible for interment at a national cemetery or
19 a veterans' cemetery, the funeral director shall arrange for the
20 proper disposition of the veteran's remains with:*

21 *(a) A national cemetery or veterans' cemetery; or
22 (b) The Office of Veterans' Services.*

23 *4. A funeral director is immune from civil or criminal
24 liability for any act or omission with respect to complying with the
25 provisions of this section.*

26 *5. As used in this section, "veteran" has the meaning
27 ascribed to it in NRS 176A.090.*

28 **Sec. 2.** If, on October 1, 2011, a funeral director has in his or
29 her custody the unclaimed human remains of a deceased person
30 whom the funeral director knows, has reason to know or reasonably
31 believes is a veteran, the funeral director shall report the name of the
32 deceased person to the Office of Veterans' Services not later than
33 September 30, 2012.
