SUMMARY—Makes various changes concerning the Fund for Hospital Care to Indigent Persons. (BDR 38-282)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to indigent persons; revising provisions governing the Fund for Hospital Care to Indigent Persons; revising the membership of the Board of Trustees of the Fund; requiring the Nevada Association of Counties to provide administrative support to the Board; authorizing payment for certain administrative expenses; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law establishes the Fund for Hospital Care to Indigent Persons to pay certain costs of hospital care provided to persons injured in motor vehicle accidents who are indigent. The Fund is composed of money collected or recovered from certain taxes and from certain charges against a county for unpaid charges for hospital care not greater than \$3,000. (NRS 428.115-428.255)

Section 2 of this bill changes the membership of the Board of Trustees of the Fund to authorize the Governor to appoint a director of a social services agency of a county as one of the five members of the Board.

Section 3 of this bill requires the Nevada Association of Counties to provide administrative support to the Board in carrying out the duties of the Board in administering the Fund. **Section 3** also authorizes the Nevada Association of Counties to be reimbursed from the Fund for the costs associated with providing administrative support to the Board. The Board is required to determine the costs for which the Nevada Association of Counties is entitled to be reimbursed.

Sections 1 and 4 of this bill require the money deposited in the Fund by a county for unpaid hospital charges not exceeding \$3,000 to be accounted for separately in the Fund and used to reimburse the Nevada Association of Counties

18 for the costs associated with providing administrative support to the Board and for
19 the reimbursement of unpaid hospital charges.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 428.175 is hereby amended to read as follows:
2 428.175 1. The Fund for Hospital Care to Indigent Persons is
3 hereby created as a special revenue fund for the purposes described
4 in NRS 428.115 to 428.255, inclusive.

5 2. ~~[All]~~ *Except as otherwise provided in subsection 3*, money
6 collected or recovered pursuant to NRS 428.115 to 428.255,
7 inclusive, and the interest earned on the money in the Fund must be
8 deposited for credit to the Fund.

9 3. *Any money paid by a county pursuant to NRS 428.255
10 must be accounted for separately in the Fund and must be used to
11 reimburse the Nevada Association of Counties for costs associated
12 with providing administrative support to the Board to carry out the
13 provisions of NRS 428.115 to 428.255, inclusive. Any money
14 remaining after the Nevada Association of Counties has been
15 reimbursed for administrative costs may be used to reimburse or
16 partially reimburse a hospital for unpaid charges for hospital care
17 pursuant to NRS 428.115 to 428.255, inclusive, as other claims
18 against the Fund are paid.*

19 4. Claims against the Fund must be paid on claims approved by
20 the Board.

21 **Sec. 2.** NRS 428.195 is hereby amended to read as follows:
22 428.195 1. The Fund must be administered by a Board of
23 Trustees composed of five *members appointed by the Governor as
24 follows:*

25 (a) *Five county commissioners ; or*
26 (b) *Four county commissioners and one director of a social
27 services agency of a county.*

28 2. *The members of the Board of Trustees must be* appointed
29 by the Governor from a list of ~~[ten]~~ nominees submitted by the
30 Board of Directors of the Nevada Association of Counties.

31 ~~[2.]~~ *The list of nominees must include six nominees who are
32 county commissioners and three nominees who are directors of a
33 social services agency of a county.*

34 3. Each member of the Board of Trustees shall serve a term of
35 1 year or until a successor has been appointed and has qualified.

36 ~~[3.]~~ 4. The position of a member of the Board of Trustees shall
37 be considered vacated upon the loss of any of the qualifications
38 required for the appointment of the member and in that event the
39 Governor shall appoint a successor from a list of ~~[two]~~ nominees

1 submitted by the Board of Directors of the Nevada Association of
2 Counties. ***The list of nominees must include two county
3 commissioners and, if one member of the Board is not a director
4 of a social services agency, one nominee who is the director of a
5 social services agency of a county.***

6 ***5. As used in this section, "social services agency" means any
7 public agency or organization that provides social services in this
8 State, including, without limitation, providing welfare and health
9 care services.***

10 **Sec. 3.** NRS 428.205 is hereby amended to read as follows:

11 428.205 **1.** The Board shall administer the Fund and for that
12 purpose may:

13 **[4.] (a)** Enter into all necessary contracts and agreements.

14 **[2.] (b)** Purchase appropriate insurance to cover that portion of
15 a claim for which the Fund is liable and which exceeds an amount
16 agreed upon by the Board and the insurer.

17 **[3.] (c)** Employ personnel as necessary and prescribe their
18 compensation and working conditions.

19 **[4.] (d)** Enter into agreements with the Department of
20 Administration to obtain the services of consultants, attorneys,
21 auditors, accountants, actuaries and managers of risk.

22 **[5.] (e)** Rent, lease, purchase or otherwise procure or receive
23 real or personal property.

24 **[6.] (f)** Adopt regulations necessary for carrying out the
25 provisions of NRS 428.115 to 428.255, inclusive.

26 ***2. The Nevada Association of Counties shall provide
27 administrative support for the Board and may be reimbursed from
28 the Fund pursuant to this section and NRS 428.175 for the costs
29 associated with providing such administrative support. The Board
30 shall determine the expenses related to the provision of
31 administrative support for which the Nevada Association of
32 Counties may be reimbursed.***

33 **Sec. 4.** NRS 428.255 is hereby amended to read as follows:

34 428.255 **1.** Any reimbursement or partial reimbursement
35 made from the Fund for unpaid charges for hospital care furnished
36 to a person which are not greater than \$3,000, is a charge upon the
37 county in which:

38 **[4.] (a)** The accident occurred, if the person is not a resident of
39 this state and the accident occurred in this state; or

40 **[2.] (b)** The person resides, if the person is a resident of this
41 state,

42 ➔ and must be paid ***to the Fund*** upon a claim presented by the
43 Board as other claims against the county are paid.

1 **2. Money paid by a county pursuant to this section must be**
2 **accounted for separately and expended in accordance with the**
3 **provisions of subsection 3 of NRS 428.175.**

4 **Sec. 5.** This act becomes effective on July 1, 2011.
