AN ACT making appropriations to the Legislative Fund for dues to national organizations; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the Legislative Fund for Fiscal Year 2010-2011 the  
3 sum of \$349,446 for dues to national organizations.  
4     2. Any remaining balance of the appropriation made by  
5 subsection 1 must not be committed for expenditure after June 30,  
6 2011, by the entity to which the appropriation is made or any entity  
7 to which money from the appropriation is granted or otherwise  
8 transferred in any manner, and any portion of the appropriated  
9 money remaining must not be spent for any purpose after  
10 September 16, 2011, by either the entity to which the money was  
11 appropriated or the entity to which the money was subsequently  
12 granted or transferred, and must be reverted to the State General  
13 Fund on or before September 16, 2011.  
14     **Sec. 2.** 1. There is hereby appropriated from the State  
15 General Fund to the Legislative Fund the sum of \$711,066 for dues  
16 to national organizations to be allocated as follows:



1 For Fiscal Year 2011-2012.....\$355,083  
2 For Fiscal Year 2012-2013.....\$355,983

3 2. Any remaining balance of the appropriations made by  
4 subsection 1 must not be committed for expenditure after June 30,  
5 2013, by the entity to which the appropriation is made or any entity  
6 to which money from the appropriation is granted or otherwise  
7 transferred in any manner, and any portion of the appropriated  
8 money remaining must not be spent for any purpose after  
9 September 20, 2013, by either the entity to which the money was  
10 appropriated or the entity to which the money was subsequently  
11 granted or transferred, and must be reverted to the State General  
12 Fund on or before September 20, 2013.

13 **Sec. 3.** 1. This section and section 1 of this act become  
14 effective upon passage and approval.

15 2. Section 2 of this act becomes effective on July 1, 2011.
