SUMMARY—Revises the authority of the Department of Health and Human Services to contract for transportation services for the recipients of services under the Children’s Health Insurance Program. (BDR 38-1197)

AN ACT relating to the Children’s Health Insurance Program; revising provisions relating to the authority of the Department of Health and Human Services to contract for transportation services for the recipients of services under the Program; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Under existing law, the Department of Health and Human Services is required,
2 to the extent authorized by federal law, to contract with certain motor carriers or
3 others to provide transportation services to certain recipients of services pursuant to
4 the Children’s Health Insurance Program when those recipients are traveling to and
5 from providers of services under those programs. (NRS 422.2705) This bill makes
6 contracting by the Department for such transportation services discretionary.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 422.2705 is hereby amended to read as
2 follows:
3 422.2705 1. The Department shall, to the extent authorized
4 by federal law, contract with a common motor carrier, a contract

16 (a) Require each motor carrier that has contracted with the
17 Department to provide transportation services pursuant to this
18 section to submit proof to the Department of a liability insurance
19 policy, certificate of insurance or surety which is substantially
20 equivalent in form to and is in the same amount or in a greater
21 amount than the policy, certificate or surety required by the
22 Department of Motor Vehicles pursuant to NRS 706.291 for a
23 similarly situated motor carrier; and

24 (b) Establish a program, with the assistance of the Nevada
25 Transportation Authority of the Department of Business and
26 Industry, to inspect the vehicles which are used to provide
27 transportation services pursuant to this section to ensure that the
28 vehicles and their operation are safe.

30 (a) "Broker" has the meaning ascribed to it in NRS 706.021.

31 (b) "Common motor carrier" has the meaning ascribed to it in
32 NRS 706.036.

33 (c) "Contract motor carrier" has the meaning ascribed to it in
34 NRS 706.051.

35 **Sec. 2.** This act becomes effective upon passage and approval.
