IMPACTS

- Excessive harassment of animals on winter range
 - Actually chase animals in an effort to cause antler drop
 - Causing wildlife in feeding in area move to less desirable forage areas
 - Preclude wildlife from the area all together

IMPACTS (cont)

- Force wildlife to deplete energy reserves
- Off road travel = habitat destruction
- Flying for sheds

Nevada

- White Pine & Lincoln County sportsmen expressed concern about impacts of shed antler hunting in 1987
- Together we explored options

Nevada

Current Legal Status:

NRS 503.010 Manner of hunting or trapping: Unlawful use of aircraft, helicopter, motor-driven vehicle or boat.

1. Except as otherwise provided in this section or subsection 2 of <u>NRS 503.005</u>, it is unlawful to molest, rally, stir up or drive any game mammals or game birds with an aircraft, helicopter or motor-driven vehicle, including a motorboat or sailboat.

SPECIAL SHED OPERATION

- During Spring 2008, four extended patrol operations conducted in Lincoln and White Pine counties
- Ground patrol with air support, to maximize contacts with shed hunters
- Educational component with advance radio spots, OGT trailer deployment, informational flyers, giveaways

PROJECT GOALS

- Limit resource damage
- Document and minimize negative impacts to wintering big game (intentional harassment)
- Increase public awareness to habitat damage through irresponsible use of ATV's
- Increase public awareness of stress on wintering big game due to human activity





Hunt Shed Antlers Responsibly

Shed hunting is a great way to get outdoors, appreciate nature and spend time with friends and family, but like every activity, there is a right and a wrong way to hunt shed antiers.

- Tread lightly on animal habitat, respect the animal's space
- Stay clear of sick, injured, cornered wildlife
- Report injured animals and wildlife harassment to NDOW
- Wait for antlers to shed naturally
- Stay on designated roads and trails



Don't

- Do not chase animals on foot or with any motorized vehicles
- Do not allow your dog to chase wildlife -- it is a crime
- Do not operate off road vehicles in wilderness areas
- Do not harass wildlife to get their antiers to drop off prematurely
- Do not litter, destroy or harm the habitat of the animals

Chasing, harassing or disturbing wildlife can harm the animals. High stress can cause pregnant does and cows to lose their young, and poor body conditioning and nutrition can stunt future antler growth on males. Harassing wildlife is a crime in the State of Nevada. Responsible shed hunters give animals the space, solitude and respect they need to be healthy. Be patient—those antlers will drop naturally in time.







RESULTS

 - \$28,460.65


TIME SPENT SHED HUNTING
