AN ACT relating to personal care services; providing immunity from civil liability to persons employed by an agency to provide personal care services in the home in certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing laws provide immunity from certain tort liability to governmental
2 entities and persons under various circumstances. (Chapter 41 of NRS) This bill
3 provides immunity from civil liability for the rendering of emergency care or
4 assistance to an elderly person or a person with a disability by a person employed
5 by an agency to provide personal care services in the home if that person: (1) has
6 completed certain courses or training in cardiopulmonary resuscitation or first aid;
7 (2) rendered the care or assistance in the course of his or her regular employment or
8 profession; and (3) rendered the care or assistance in good faith and in accordance
9 with his or her training.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 449 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *Any person who is employed by an agency to provide personal
4 care services in the home who:*

- 1 *1. Has successfully completed a course in cardiopulmonary*
2 *resuscitation according to the guidelines of the American National*
3 *Red Cross or American Heart Association;*
- 4 *2. Has successfully completed the training requirements of a*
5 *course in basic emergency care of a person in cardiac arrest*
6 *conducted in accordance with the standards of the American*
7 *Heart Association; or*
- 8 *3. Has successfully completed the training requirements of a*
9 *course in the use and administration of first aid, including*
10 *cardiopulmonary resuscitation,*
11 *→ and who in good faith renders emergency care or assistance in*
12 *accordance with the person's training, in the course of his or her*
13 *regular employment or profession, to an elderly person or a*
14 *person with a disability, is not liable for any civil damages as a*
15 *result of any act or omission, not amounting to gross negligence,*
16 *by that person in rendering that care.*

17 Sec. 2. This act becomes effective on July 1, 2013.
