ASSEMBLY JOINT RESOLUTION—Recognizing the strategic partnership and bond of friendship with, and expressing the Nevada Legislature’s support for, the State of Israel.

- 1        WHEREAS, The United States of America, having been the first  
2 country to recognize the State of Israel as an independent nation and  
3 as the principal ally of the State of Israel, has enjoyed a close and  
4 mutually beneficial relationship with the State of Israel and her  
5 people; and  
6        WHEREAS, The State of Israel is the United States of America’s  
7 closest ally in the Middle East; and  
8        WHEREAS, The State of Israel is currently facing significant  
9 threats, including the possibility of Iran developing nuclear  
10 weapons; and



1 WHEREAS, These threats also pose a substantial risk to the  
2 United States of America and the other democratic countries of the  
3 world; and

4 WHEREAS, The State of Nevada and the State of Israel enjoy a  
5 cordial and mutually beneficial relationship; and

6 WHEREAS, The Jewish community in the State of Nevada  
7 continues to make important contributions to the history and culture  
8 of the State of Nevada and supports the State of Israel; now,  
9 therefore, be it

10 RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF  
11 NEVADA, JOINTLY, That the members of the 77th Session of the  
12 Nevada Legislature hereby recognize the strategic partnership and  
13 bond of friendship between the State of Nevada and the State of  
14 Israel; and be it further

15 RESOLVED, That the Nevada Legislature hereby expresses its  
16 support for Governor Brian Sandoval's upcoming trade mission to  
17 the State of Israel; and be it further

20 RESOLVED, That the Chief Clerk of the Assembly prepare and  
21 transmit a copy of this resolution to the Ambassador of Israel to the

24 of the Jewish Federation of Las Vegas.
