1 WHEREAS, The Assembly appointed the members of the Select  
2 Committee on the Assembly to consider and investigate matters  
3 within the jurisdiction of Section 6 of Article 4 of the Nevada  
4 Constitution; and

5 WHEREAS, The Select Committee on the Assembly reports that  
6 it has commenced its proceedings to consider and investigate  
7 matters within the jurisdiction of Section 6 of Article 4 of the  
8 Nevada Constitution; and

9 WHEREAS, The Select Committee on the Assembly reports that  
10 it has adopted committee rules that are necessary, just and  
11 appropriate to preserve order and protect the integrity and decorum  
12 of the Legislature and the legislative process and to conduct the  
13 Committee’s proceedings to consider and investigate matters within  
14 the jurisdiction of Section 6 of Article 4 of the Nevada Constitution;

8 hereby determined to be necessary, just and appropriate to preserve  
9 order and protect the integrity and decorum of the Legislature and  
10 the legislative process and to conduct the Committee's proceedings  
11 to consider and investigate matters within the jurisdiction of Section  
12 6 of Article 4 of the Nevada Constitution; and be it further

13 RESOLVED, That the committee rules of the Select Committee  
14 on the Assembly are hereby approved and ratified; and be it further

15 RESOLVED, That the orders of the Chair of the Select Committee  
16 on the Assembly that have been issued pursuant to its committee  
17 rules are determined to be necessary, just and appropriate to  
18 preserve order and protect the integrity and decorum of the  
19 Legislature and the legislative process and to conduct the  
20 Committee's proceedings to consider and investigate matters within  
21 the jurisdiction of Section 6 of Article 4 of the Nevada Constitution;  
22 and be it further

23 RESOLVED, That the orders of the Chair of the Select Committee  
24 on the Assembly that have been issued pursuant to its committee  
25 rules are hereby approved and ratified; and be it further

26 RESOLVED, That the Select Committee on the Assembly is  
27 hereby instructed to continue its proceedings to consider and  
28 investigate matters within the jurisdiction of Section 6 of Article 4  
29 of the Nevada Constitution; and be it further

30 RESOLVED, That the Select Committee on the Assembly is  
31 hereby authorized to adopt or amend any committee rules that are  
32 necessary, just and appropriate to preserve order and protect the  
33 integrity and decorum of the Legislature and the legislative process  
34 and to conduct the Committee's proceedings to consider and  
35 investigate matters within the jurisdiction of Section 6 of Article 4  
36 of the Nevada Constitution; and be it further

37 RESOLVED, That the Select Committee on the Assembly and its  
38 Chair are hereby authorized to issue any orders pursuant to its  
39 committee rules that are necessary, just and appropriate to preserve  
40 order and protect the integrity and decorum of the Legislature and  
41 the legislative process and to conduct the Committee's proceedings  
42 to consider and investigate matters within the jurisdiction of Section  
43 6 of Article 4 of the Nevada Constitution; and be it further

44 RESOLVED, That the Select Committee on the Assembly shall  
45 make reports and recommendations to the Assembly, at such times



1 as the Committee deems advisable, regarding its proceedings to  
2 consider and investigate matters within the jurisdiction of Section 6  
3 of Article 4 of the Nevada Constitution; and be it further  
4 RESOLVED, That this resolution shall be entered upon the  
5 Journal of the Assembly.
