SUMMARY—Requires the Legislative Committee on Health Care to consider the manner in which certain provisions relating to licensing of certain offices of physicians and facilities that provide health care have been carried out. (BDR S-441)

AN ACT relating to health care; requiring the Legislative Committee on Health Care to consider the manner in which certain provisions relating to the licensing of certain offices of physicians and facilities that provide health care have been carried out; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Assembly Bill No. 123 of the 75th Session of the Nevada Legislature, codified
2 at NRS 449.435 to 449.448, inclusive, requires an office of a physician or a facility
3 that provides health care, other than a medical facility, to obtain a permit before
4 offering services of general anesthesia, conscious sedation or deep sedation. (NRS
5 449.442, 630.373, 633.694) To obtain such a permit, an office of a physician or a
6 facility that provides health care is required to submit an application, pay a fee and
7 undergo an on-site inspection. (NRS 449.443, 449.446) To continue providing
8 services of general anesthesia, conscious sedation or deep sedation, an office of a
9 physician or a facility that provides health care, other than a medical facility, is
10 required to renew its permit annually. (NRS 449.443, 449.444) The Health Division
11 of the Department of Health and Human Services is required to conduct annual
12 inspections of each office of a physician and facility that provides health care and is
13 authorized to take certain disciplinary actions for violations. (NRS 449.446,
14 449.447) The State Board of Health is required to adopt regulations to carry out
15 these provisions. (NRS 449.448) This bill requires the Legislative Committee on
16 Health Care to consider the manner in which these provisions have been carried out
17 as part of its review of health care during the 2013-2015 legislative interim.
