SUMMARY—Transfers authority over programs of nutrition from the Department of Education to the Director of the State Department of Agriculture. (BDR 34-1146)

AN ACT relating to programs of nutrition; transferring authority over programs of nutrition from the Department of Education to the Director of the State Department of Agriculture; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Under existing law, the Department of Education administers certain programs which provide food or nutritional education and assistance to persons in this State. (NRS 385.109, 387.070-387.105) This bill transfers authority over such programs from the Department of Education to the Director of the State Department of Agriculture.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 385.109 is hereby amended to read as follows:
2 385.109 The ~~State Board~~ **Director of the State Department**
3 **of Agriculture** shall:
4 1. Cooperate with the Aging and Disability Services Division
5 of the Department of Health and Human Services in the planning of
6 programs whereby the school districts may prepare hot lunches for
7 persons 60 years of age or older and their spouses or any group of

1 such persons by utilizing the systems and procedures already
2 developed for use in the operation of school lunch programs; and

3 2. Adopt regulations containing guidelines for boards of
4 trustees of school districts entering into such agreements.

5 **Sec. 2.** Chapter 387 of NRS is hereby amended by adding
6 thereto the provisions set forth as sections 3, 4 and 5 of this act.

7 **Sec. 3.** *As used in NRS 387.070 to 387.105, inclusive, and
8 sections 3, 4 and 5 of this act, unless the context otherwise
9 requires, the words and terms defined in NRS 387.070 and section
10 4 of this act have the meanings ascribed to them in those sections.*

11 **Sec. 4.** *"Director" means the Director of the State
12 Department of Agriculture.*

13 **Sec. 5.** (Deleted by amendment.)

14 **Sec. 6.** NRS 387.070 is hereby amended to read as follows:

15 387.070 ~~As used in NRS 387.070 to 387.105, inclusive,~~
16 ~~program~~ **Program** of nutrition" means a program under which
17 food is served to or nutritional education and assistance are provided
18 for children and adults by any public school, private school or
19 public or private institution on a nonprofit basis, including any such
20 program for which assistance may be made available out of money
21 appropriated by the Congress of the United States. The term
22 includes, but is not limited to, a school lunch program.

23 **Sec. 7.** NRS 387.075 is hereby amended to read as follows:

24 387.075 1. The ~~State Board of Education~~ **Director** may
25 accept and adopt regulations or establish policies for the
26 disbursement of money appropriated by any Act of Congress and
27 apportioned to the State of Nevada for use in connection with
28 programs of nutrition.

29 2. The ~~Superintendent of Public Instruction~~ **Director** shall
30 deposit with the State Treasurer all money received from the Federal
31 Government or from other sources for programs of nutrition.

32 **Sec. 8.** NRS 387.080 is hereby amended to read as follows:

33 387.080 1. The ~~State Board~~ **Director** may enter into
34 agreements with any agency of the Federal Government, **the
35 Department, the State Board**, any board of trustees of a school
36 district, any governing body of a charter school or any other entity
37 or person. The ~~State Board~~ **Director** may establish policies and
38 prescribe regulations, authorize the employment of such personnel
39 and take such other action as it considers necessary to provide for
40 the establishment, maintenance, operation and expansion of any
41 program of nutrition operated by a school district or of any other
42 such program for which state or federal assistance is provided.

43 2. The State Treasurer shall disburse federal, state and other
44 money designated for a program of nutrition on warrants of the State
45 Controller issued upon the order of the ~~Superintendent of Public~~

1 ~~Instruction~~ **Director** pursuant to regulations or policies of the State
2 ~~Board.~~ **Department of Agriculture.**

3 3. The ~~Superintendent of Public Instruction~~ **Director** may:
4 (a) Give technical advice and assistance to any person or entity
5 in connection with the establishment and operation of any program
6 of nutrition.

7 (b) Assist in training personnel engaged in the operation of any
8 program of nutrition.

9 **Sec. 9.** NRS 387.090 is hereby amended to read as follows:

10 387.090 The board of trustees of each school district and the
11 governing body of each charter school may:

12 1. Operate or provide for the operation of programs of nutrition
13 in the public schools under their jurisdiction.

14 2. Use therefor money disbursed to them pursuant to the
15 provisions of NRS 387.070 to 387.105, inclusive, **and sections 3, 4**
16 **and 5 of this act**, gifts, donations and other money received from
17 the sale of food under those programs.

18 3. Deposit the money in one or more accounts in one or more
19 banks or credit unions within the State.

20 4. Contract with respect to food, services, supplies, equipment
21 and facilities for the operation of the programs.

22 **Sec. 10.** NRS 387.100 is hereby amended to read as follows:

23 387.100 The ~~State Board of Education~~ **Director** may, to the
24 extent that money is available for that purpose, and in cooperation
25 with other appropriate agencies and organizations:

26 1. Conduct studies of methods of improving and expanding
27 programs of nutrition and promoting nutritional education in the
28 public schools.

29 2. Conduct appraisals of the nutritive benefits of programs of
30 nutrition.

31 **Sec. 11.** NRS 387.105 is hereby amended to read as follows:

32 387.105 1. To enable the ~~State Board~~ **Director** to provide
33 for the establishment, maintenance, operation and expansion of
34 programs of nutrition, money must be provided by legislative
35 appropriation from the General Fund as a budgeted part of the
36 appropriation for the support of the **State Department of Agriculture**
37 and must be paid out on claims as other claims against the State are
38 paid.

39 2. In addition to the amounts provided pursuant to subsection
40 1, money must be provided by legislative appropriation in an
41 amount that satisfies the amount required as a matching grant from
42 this State for participation in the National School Lunch Program,
43 U.S.C. §§ 1751 et seq., which must be designated as the
44 “Nutrition State Match.” ~~For those school districts that participate~~
45 ~~in the National School Lunch Program, the amount appropriated~~

1 ~~must be a reduction in the total amount of basic support calculated
2 for those school districts pursuant to NRS 387.1233 and must be
3 distributed in accordance with NRS 387.124.~~ Each school district
4 receiving money that is designated as a "Nutrition State Match"
5 shall verify that the money is used to support the National School
6 Lunch Program in the public schools located within the school
7 district.

8 **Sec. 12.** (Deleted by amendment.)

9 **Sec. 13.** 1. Notwithstanding the amendatory provisions of
10 sections 1, 7 and 8 of this act transferring authority to adopt
11 regulations from the State Board of Education to the Director of the
12 State Department of Agriculture, any regulations adopted by the
13 State Board of Education pursuant to NRS 385.109, 387.075 and
14 387.080 before July 1, 2013, remain in effect and may be enforced
15 by the State Department of Agriculture until the Director of the
16 Department adopts regulations to repeal or replace those regulations.

17 2. Notwithstanding the amendatory provisions of section 8 of
18 this act transferring authority to enter into agreements from the State
19 Board of Education to the Director of the State Department of
20 Agriculture, any agreement entered into by the State Board of
21 Education pursuant to NRS 387.080 before July 1, 2013, remains in
22 effect and may be enforced by the State Department of Agriculture.

23 **Sec. 14.** Any balance of money appropriated to the
24 Department of Education pursuant to NRS 387.105 that remains on
25 June 30, 2013, must be transferred on July 1, 2013, to an account in
26 the State General Fund administered by the Director of the State
27 Department of Agriculture for the purposes of carrying out the
28 provisions of NRS 387.105, as amended by section 11 of this act.

29 **Sec. 15.** The Legislative Counsel shall, in preparing
30 supplements to the Nevada Administrative Code, appropriately
31 change any references to an officer, agency or other entity whose
32 name is changed or whose responsibilities are transferred pursuant
33 to the provisions of this act to refer to the appropriate officer,
34 agency or other entity.

35 **Sec. 16.** This act becomes effective on July 1, 2013.
