SUMMARY—Revises provisions relating to services for persons with intellectual disabilities and persons with related conditions. (BDR 39-416)

AN ACT relating to public welfare; requiring the Aging and Disability Services Division of the Department of Health and Human Services to enter into an agreement with the Rehabilitation Division of the Department of Employment, Training and Rehabilitation to provide long-term support to persons with intellectual disabilities and persons with related conditions; requiring the Aging and Disability Services Division to provide preferences for potential providers of jobs and day training services in issuing certificates authorizing the provision of such services and in entering into agreements concerning the provision of such services; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires the Rehabilitation Division of the Department of
2 Employment, Training and Rehabilitation to administer certain programs
3 concerning employment and independent living for persons with disabilities. (NRS
4 232.945) Existing law also requires the Aging and Disability Services Division of
5 the Department of Health and Human Services to regulate the provision of jobs and
6 day training services and supported living arrangement services to persons with
7 disabilities and persons with related conditions. (NRS 435.130-435.339) **Section 1**
8 of this bill requires the Aging and Disability Services Division to enter into a

9 cooperative agreement with the Rehabilitation Division to provide long-term
10 support to persons with intellectual disabilities and persons with related conditions.

11 Existing law requires a natural person and certain entities to obtain a certificate
12 from the Aging and Disability Services Division before providing jobs and day
13 training services in this State, which are services provided to persons with
14 intellectual disabilities or persons with related conditions to enhance self-
15 sufficiency and success in employment. (NRS 435.176, 435.225) Existing law also
16 authorizes the Aging and Disability Services Division to enter into agreements with
17 public and private agencies as it deems necessary for the provision of jobs and day
18 training services. (NRS 435.220)

19 **Sections 1.5 and 2** of this bill require the Aging and Disability Services
20 Division to give preference to potential providers of jobs and day training services
21 who will provide persons with intellectual disabilities or persons with related
22 conditions with training and experience leading to employment that: (1) is
23 comparable to employment for persons without intellectual disabilities and persons
24 without related conditions; and (2) pays at or above the state minimum wage. The
25 Aging and Disability Services Division is required to give such a preference when:
26 (1) issuing certificates which authorize the provisions of jobs and day training
27 services; and (2) entering into agreements with public and private agencies for the
28 provision of jobs and day training services. **Sections 1.5 and 2** also require each
29 application for the issuance or renewal of such a certificate and each such
30 agreement to include a provision that employment is the primary service option for
31 all adults of working age.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 435 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *The Division shall enter into a cooperative agreement with the*
4 *Rehabilitation Division of the Department of Employment,*
5 *Training and Rehabilitation to provide long-term support to*
6 *persons with intellectual disabilities and persons with related*
7 *conditions, including, without limitation, jobs and day training*
8 *services and supported living arrangement services. The*
9 *agreement must include a provision stating that employment is the*
10 *preferred service option for all adults of working age.*

11 **Sec. 1.5.** NRS 435.220 is hereby amended to read as follows:

12 435.220 1. The Division shall adopt regulations governing
13 jobs and day training services, including, without limitation,
14 regulations that set forth:

15 (a) Standards for the provision of quality care and training by
16 providers of jobs and day training services;

17 (b) The requirements for the issuance and renewal of a
18 certificate; and

19 (c) The rights of consumers of jobs and day training services,
20 including, without limitation, the right of a consumer to file a
21 complaint and the procedure for filing the complaint.



1 2. The Division may enter into such agreements with public
2 and private agencies as it deems necessary for the provision of jobs
3 and day training services. *Any such agreements must include a*
4 *provision stating that employment is the preferred service option*
5 *for all adults of working age.*

6 3. *For the purpose of entering into an agreement described in*
7 *subsection 2, if the qualifications of more than one agency are*
8 *equal, the Division shall give preference to the agency that will*
9 *provide persons with intellectual disabilities or persons with*
10 *related conditions with training and experience that demonstrates*
11 *a progression of measurable skills that is likely to lead to*
12 *competitive employment outcomes that provide employment that:*

13 (a) *Is comparable to employment of persons without*
14 *intellectual disabilities and persons without related conditions;*
15 *and*

16 (b) *Pays at or above the minimum wage prescribed by*
17 *regulation of the Labor Commissioner pursuant to NRS 608.250.*

18 **Sec. 2.** NRS 435.225 is hereby amended to read as follows:

19 435.225 1. A nonprofit organization, state or local
20 government or agency thereof shall not provide jobs and day
21 training services in this State without first obtaining a certificate
22 from the Division.

23 2. A natural person other than a person who is employed by an
24 entity listed in subsection 1 shall not provide jobs and day training
25 services in this State without first obtaining a certificate from the
26 Division.

27 3. *For the purpose of issuing a certificate pursuant to this*
28 *section, if the qualifications of more than one applicant are equal,*
29 *the Division shall give preference to the natural person who, or*
30 *the nonprofit organization, state or local government or agency*
31 *thereof that, will provide persons with intellectual disabilities or*
32 *persons with related conditions with training and experience that*
33 *demonstrates a progression of measurable skills that is likely to*
34 *lead to competitive employment outcomes that provide employment*
35 *that:*

36 (a) *Is comparable to employment of persons without*
37 *intellectual disabilities and persons without related conditions;*
38 *and*

39 (b) *Pays at or above the minimum wage prescribed by*
40 *regulation of the Labor Commissioner pursuant to NRS 608.250.*

41 4. *Each application for the issuance or renewal of a*
42 *certificate issued pursuant to this section must include a provision*
43 *stating that employment is the preferred service option for all*
44 *adults of working age.*
