SUMMARY—Revises provisions governing motor vehicles. (BDR 43-718)

AN ACT relating to motor vehicles; revising the definition of a trimobile; revising provisions governing the Account for the Program for the Education of Motorcycle Riders; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law defines a trimobile to mean a motor vehicle designed to travel with three wheels on the ground, two of which are power driven. (NRS 482.129, 486.057) Sections 3.3 and 3.7 of this bill revise the definition of a trimobile to provide that at least one of the wheels must be power driven and excludes from the definition a motorcycle with a sidecar. Existing law provides for an Account for the Program for the Education of Motorcycle Riders and authorizes the use of money from the Account to pay the expenses of the Program for the Education of Motorcycle Riders or for any other

6 Existing law provides for an Account for the Program for the Education of 7 Motorcycle Riders and authorizes the use of money from the Account to pay the 8 expenses of the Program for the Education of Motorcycle Riders or for any other 9 purpose authorized by the Legislature. (NRS 486.372) **Section 4.5** of this bill 10 removes the provision allowing money from the Account to be used for any other 11 purpose authorized by the Legislature.

13 Sec. 4.5. NRS 486.372 is hereby amended to read as follows:

486.372 1. The Director shall:

(a) Establish the Program for the Education of MotorcycleRiders.

(b) Appoint an Administrator to carry out the Program.

(c) Consult regularly with the Advisory Board on MotorcycleSafety concerning the content and implementation of the Program.

20 (d) Approve courses of instruction provided by public or private 21 organizations which comply with the requirements established for 22 the Program.

(e) Adopt rules and regulations which are necessary to carry outthe Program.

- 25 2. The Director may contract for the provision of services 26 necessary for the Program.
- 3. The Account for the Program for the Education of

5. The interest and income earned on the money in the Account, after deducting any applicable charges, must be credited to the Account.

6. Any money remaining in the Account for the Program for
the Education of Motorcycle Riders at the end of a fiscal year does
not revert to the State General Fund, and the balance in the Account
must be carried forward to the next fiscal year.
