SUMMARY—Revises provisions relating to organ donation. (BDR 43-215)

EXPLANATION - Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to anatomical gifts; revising provisions governing the election by the holder of a driver's license, a driver authorization card or an identification card as to whether the holder wishes to be a donor of all or part of his or her body; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Under existing law, upon the issuance and renewal of a driver's license or an 23456789 identification card issued by the Department of Motor Vehicles, the Department is required to give the holder of the driver's license or identification card the opportunity to have indicated on the license or card that the holder wishes to be a donor of all or part of his or her body, or to refuse to make an anatomical gift of his or her body or part thereof. (NRS 483.340, 483.840) Sections 1 and 2 of this bill provide that, upon the issuance of a driver's license or identification card, the Department is required to give the holder the opportunity to have indicated on his or her driver's license or identification card that the holder wishes to be a donor, or 10 does not at this time wish to be a donor. Sections 1 and 2 also provide that upon 11 the renewal of a driver's license or identification card the Department is required to 12 give a holder who indicated at the issuance of the license or card that he or she 13 wished to be a donor notice that, unless the holder affirmatively indicates upon 14 renewal that he or she wishes to change that indication, the indication will remain 15 on his or her driver's license or identification card. For a holder who indicated at 16 the issuance of his or her driver's license or identification card that the holder did 17 not at that time wish to be a donor, the Department is required to give the holder an 18 opportunity to change that indication to indicate that the holder wishes to be a 19 donor. Existing law deems certain provisions relating to drivers' licenses, including 20 21 the provisions amended by this bill, applicable also to driver authorization cards and certain instruction permits. (NRS 483.291) Thus, the provisions of section 2 22 23 are applicable to such cards and permits. Sections 4.5 and 5 of this bill provide that this bill becomes effective upon passage and approval for preparatory





administrative tasks and for all other purposes when the Director of the Department

24 25 26 27 has determined that sufficient resources are available to enable the Department to

carry out the provisions of this bill and the Director has thereafter made specified

notifications.

THE PEOPLE OF THE STATE OF NEVADA. REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 483.340 is hereby amended to read as follows: 2 The Department shall, upon payment of the 483.340 1. 3 required fee, issue to every qualified applicant a driver's license indicating the type or class of vehicles the licensee may drive. 4

The Department may issue a driver's license for purposes of 7 8 identification only for use by officers of local police and sheriffs' departments, agents of the Investigation Division of the Department 9 10 of Public Safety while engaged in special undercover investigations relating to narcotics or prostitution or for other undercover 11 investigations requiring the establishment of a fictitious identity, 12 13 federal agents while engaged in undercover investigations, investigators employed by the Attorney General while engaged in 14 15 undercover investigations, criminal investigators employed by the Secretary of State while engaged in undercover investigations and 16 17 agents of the State Gaming Control Board while engaged in investigations pursuant to NRS 463.140. An application for such a 18 19 license must be made through the head of the police or sheriff's department, the Chief of the Investigation Division of the 20 21 Department of Public Safety, the director of the appropriate federal agency, the Attorney General, the Secretary of State or his or her 22 23 designee or the Chair of the State Gaming Control Board. Such a license is exempt from the fees required by NRS 483.410. The 24 Department, by regulation, shall provide for the cancellation of any 25 such driver's license upon the completion of the special 26 27 investigation for which it was issued.

Except as otherwise provided in NRS 239.0115, information 28 4. 29 pertaining to the issuance of a driver's license pursuant to 30 subsection 3 is confidential.

5. It is unlawful for any person to use a driver's license issued 31 pursuant to subsection 3 for any purpose other than the special 32 33 investigation for which it was issued.

34 At the time of the issuance [or renewal] of the driver's 6. 35 license, the Department shall:

(a) Give the holder the opportunity to have indicated on his or 36 37 her driver's license that the holder [wishes]:

(d) If the Department has established a program for imprinting a

license pursuant to NRS 483.3485, give the holder the opportunity
to have a symbol or other indicator of a medical condition imprinted
on his or her driver's license.

The Department shall adopt regulations to 16 carry out the provisions of this subsection.

As soon as practicable, upon determining that sufficient resources are available to enable the Department of Motor Vehicles to carry out the amendatory provisions of this act, the Director of the Department shall notify the Governor and the Director of the Legislative Counsel Bureau of that fact, and shall publish on the Internet website of the Department notice to the public of that fact.

Upon passage and approval for the purposes of adopting any
 regulations and performing any other preparatory administrative
 tasks necessary to carry out the provisions of this act; and

2. For all other purposes, on the date on which the Director of the Department of Motor Vehicles, pursuant to section 4.5 of this act, notifies the Governor and the Director of the Legislative Counsel Bureau that sufficient resources are available to enable the Department to carry out the amendatory provisions of this act.
