

ASSEMBLY BILL NO. 425—ASSEMBLYMAN SPRINKLE

MARCH 27, 2017

Referred to Committee on Commerce and Labor

SUMMARY—Revises provisions governing alcohol, drug and problem gambling counselors. (BDR 54-1031)

AN ACT relating to counselors; authorizing certain holders of licenses and certificates issued by the Board of Examiners for Alcohol, Drug and Gambling Counselors to place those licenses and certificates on inactive status; authorizing the Board to impose administrative sanctions against a person who engages in certain activity without a license or certificate; authorizing certain certified alcohol and drug abuse counselors to supervise a certified alcohol and drug abuse counselor intern; revising the required training for a certified alcohol and drug abuse counselor intern; authorizing the Board to impose disciplinary action in certain circumstances; providing a penalty; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law provides for the Board of Examiners for Alcohol, Drug and  
2 Gambling Counselors to: (1) license clinical alcohol and drug abuse counselors and  
3 alcohol and drug abuse counselors who have received a master’s or doctoral degree  
4 in an approved field of social science; and (2) certify alcohol and drug abuse  
5 counselors who have received a bachelor’s degree in an approved field of social  
6 science, problem gambling counselors, clinical alcohol and drug abuse counselor  
7 interns, alcohol and drug abuse counselor interns and problem gambling counselor  
8 interns. (NRS 641C.330, 641C.340, 641C.350, 641C.390, 641C.420, 641C.430,  
9 641C.440) **Section 2** of this bill authorizes the holder of a license or certificate  
10 issued by the Board, other than a certificate as an intern, to place the license or  
11 certificate on inactive status if the license or certificate is in good standing and the  
12 holder of the license or certificate has met all requirements for the issuance or

13 renewal of the license or certificate. **Section 2** prohibits a person whose license is  
14 inactive from engaging in any work or activity that requires a license or certificate  
15 issued by the Board in this State unless the license or certificate is returned to active  
16 status. Violation of this provision is a misdemeanor. (NRS 641C.950) **Section 6** of  
17 this bill authorizes the Board to impose disciplinary action against a person who:  
18 (1) violates this provision; or (2) engages in the practice of counseling problem  
19 gamblers with an expired, suspended or revoked certificate.

20 **Section 3** of this bill authorizes the Board to impose certain sanctions,  
21 including an administrative penalty, against a person who: (1) provides services for  
22 which a license or certificate issued by the Board is required without such a license  
23 or certificate; or (2) falsely represents or implies that he or she has such a license or  
24 certificate.

25 Under existing law, only a licensed alcohol and drug abuse counselor is  
26 authorized to supervise a certified alcohol and drug abuse counselor intern. (NRS  
27 641C.420) **Sections 4 and 5** of this bill additionally authorize a certified alcohol  
28 and drug abuse counselor who has been certified for at least 3 years and meets any  
29 other requirements prescribed by the Board to supervise such an intern.

30 Existing law requires an applicant for a certificate as an alcohol and drug abuse  
31 counselor intern to have completed not less than 30 hours of training specific to  
32 alcohol and drug abuse, which must include at least 6 hours of instruction relating  
33 to confidentiality and 6 hours of instruction relating to ethics. (NRS 641C.420)  
34 **Section 5** of this bill removes the requirement that an applicant must have  
35 completed not less than 30 hours of training specific to alcohol and drug abuse, but  
36 leaves in place the requirement that the applicant must have received at least 6  
37 hours of instruction relating to confidentiality and 6 hours of instruction relating to  
38 ethics.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 641C of NRS is hereby amended by adding  
2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2. 1.** *The holder of a license or certificate issued by the*  
4 *Board, other than a certified intern, may apply to the Board to*  
5 *have his or her license or certificate placed on inactive status. The*  
6 *Board may grant the application if the license or certificate is in*  
7 *good standing and the holder of the license or certificate has met*  
8 *all requirements for the issuance or renewal of the license or*  
9 *certificate as of the date of the application.*

10 **2.** *If an application is granted pursuant to subsection 1, the*  
11 *holder of the license or certificate shall not engage in any work or*  
12 *activities that require a license or certificate issued by the Board in*  
13 *this State unless the license or certificate is first returned to active*  
14 *status.*

15 **3.** *The Board shall adopt regulations prescribing the:*  
16 *(a) Procedure for submitting an application pursuant to this*  
17 *section;*



1       ***(b) Procedure and terms upon which a person whose license or***  
2 ***certificate has been placed on inactive status may resume work or***  
3 ***activities that require a license or certificate;***

4       ***(c) Length of time that a license or certificate may remain on***  
5 ***inactive status; and***

6       ***(d) Fees for the renewal of the inactive status of a license or***  
7 ***certificate.***

8       **Sec. 3. In addition to any criminal penalty that may be**  
9 **imposed for a violation of NRS 641C.900 or 641C.910, the Board,**  
10 **after notice and a hearing, may:**

11       ***1. Issue an order against any person who has violated NRS***  
12 ***641C.900 or 641C.910, imposing an administrative penalty of not***  
13 ***more than \$5,000 for each violation. Any administrative penalty***  
14 ***collected pursuant to this subsection must be deposited in the State***  
15 ***General Fund.***

16       ***2. Issue and serve on the person an order to cease and desist***  
17 ***until the person obtains from the Board the proper license or***  
18 ***certificate and otherwise demonstrates that he or she is no longer***  
19 ***in violation of NRS 641C.900 or 641C.910, as applicable. An order***  
20 ***to cease and desist must include a telephone number by which the***  
21 ***person may contact the Board.***

22       ***3. Issue a citation to the person. A citation issued pursuant to***  
23 ***this subsection must be in writing, describe with particularity the***  
24 ***nature of the violation and inform the person of the provisions of***  
25 ***this section. Each activity in which the person is engaged***  
26 ***constitutes a separate offense for which a separate citation may be***  
27 ***issued. To appeal a citation, the person must submit a written***  
28 ***request for a hearing to the Board not later than 30 days after the***  
29 ***date of issuance of the citation.***

30       ***4. Impose any combination of the penalties set forth in***  
31 ***subsections 1, 2 and 3.***

32       **Sec. 4. NRS 641C.390 is hereby amended to read as follows:**

33       **641C.390 1. The Board shall issue a certificate as an alcohol**  
34 **and drug abuse counselor to a person who:**

35       **(a) Is not less than 21 years of age;**

36       **(b) Is a citizen of the United States or is lawfully entitled to**  
37 **remain and work in the United States;**

38       **(c) Except as otherwise provided in subsection 2, has received a**  
39 **bachelor's degree from an accredited college or university in a field**  
40 **of social science approved by the Board;**

41       **(d) Has completed 4,000 hours of supervised counseling of**  
42 **alcohol and drug abusers;**

43       **(e) Passes the written and oral examinations prescribed by the**  
44 **Board pursuant to NRS 641C.290;**

45       **(f) Pays the fees required pursuant to NRS 641C.470; and**



1 (g) Submits all information required to complete an application  
2 for a certificate.

3 2. The Board may waive the educational requirement set forth  
4 in paragraph (c) of subsection 1 if an applicant for a certificate has  
5 contracted with or receives a grant from the Federal Government to  
6 provide services as an alcohol and drug abuse counselor to persons  
7 who are authorized to receive those services pursuant to 25 U.S.C.  
8 §§ ~~1450~~ 5301 et seq. or 25 U.S.C. §§ 1601 et seq. An alcohol and  
9 drug abuse counselor certified pursuant to this section for whom the  
10 educational requirement set forth in paragraph (c) of subsection 1 is  
11 waived may provide services as an alcohol and drug abuse  
12 counselor only to those persons who are authorized to receive those  
13 services pursuant to 25 U.S.C. §§ ~~1450~~ 5301 et seq. or 25 U.S.C. §§  
14 1601 et seq.

15 3. A certificate as an alcohol and drug abuse counselor is valid  
16 for 2 years and may be renewed.

17 4. A certified alcohol and drug abuse counselor may:

18 (a) Engage in the practice of counseling alcohol and drug  
19 abusers; ~~and~~

20 (b) Diagnose or classify a person as an alcoholic or abuser of  
21 drugs ~~;~~ and

22 (c) *If the certified alcohol and drug abuse counselor has been*  
23 *certified for at least 3 years and meets any other requirements*  
24 *prescribed by regulation of the Board for the supervision of*  
25 *interns, supervise certified alcohol and drug abuse counselor*  
26 *interns.*

27 **Sec. 5.** NRS 641C.420 is hereby amended to read as follows:

28 641C.420 1. The Board shall issue a certificate as an alcohol  
29 and drug abuse counselor intern to a person who:

30 (a) Is not less than 21 years of age;

31 (b) Is a citizen of the United States or is lawfully entitled to  
32 remain and work in the United States;

33 (c) Pays the fees required pursuant to NRS 641C.470;

34 (d) Submits proof to the Board that the person:

35 (1) Is enrolled in a program in which he or she has completed  
36 at least 60 hours of credit toward the completion of a bachelor's  
37 degree in a field of social science approved by the Board;

38 (2) Is enrolled in a program from which he or she will  
39 receive a master's degree or doctoral degree in a field of social  
40 science approved by the Board; or

41 (3) Has received an associate's degree, bachelor's degree,  
42 master's degree or doctoral degree that included at least 18 hours of  
43 credit specifically related to the practice of counseling alcohol and  
44 drug abusers in a field of social science approved by the Board;



1 (e) Has ~~completed not less than 30 hours of training specific to~~  
2 ~~alcohol and drug abuse which must:~~

3 ~~— (1) Include~~ *received* at least 6 hours of ~~instructions~~  
4 *instruction* relating to confidentiality and 6 hours of instruction  
5 relating to ethics; and

6 ~~{(2) Be approved by the Board; and}~~

7 (f) Submits all information required to complete an application  
8 for a certificate.

9 2. A certificate as an alcohol and drug abuse counselor intern is  
10 valid for 6 months and may be renewed. The Board may waive any  
11 requirement for the renewal of a certificate upon good cause shown  
12 by the holder of the certificate.

13 3. A certified alcohol and drug abuse counselor intern may,  
14 under the supervision of a licensed alcohol and drug abuse  
15 counselor, ~~or~~ licensed clinical alcohol and drug abuse counselor  
16 ~~or~~ *certified alcohol and drug abuse counselor who meets the*  
17 *requirements of paragraph (c) of subsection 4 of NRS 641C.390:*

18 (a) Engage in the practice of counseling alcohol and drug  
19 abusers; and

20 (b) Diagnose or classify a person as an alcoholic or drug abuser.

21 **Sec. 6.** NRS 641C.700 is hereby amended to read as follows:

22 641C.700 The grounds for initiating disciplinary action  
23 pursuant to the provisions of this chapter include:

24 1. Conviction of:

25 (a) A felony relating to the practice of counseling alcohol and  
26 drug abusers, the clinical practice of counseling alcohol and drug  
27 abusers or the practice of counseling problem gamblers;

28 (b) An offense involving moral turpitude; or

29 (c) A violation of a federal or state law regulating the  
30 possession, distribution or use of a controlled substance or  
31 dangerous drug as defined in chapter 453 of NRS;

32 2. Fraud or deception in:

33 (a) Applying for a license or certificate;

34 (b) Taking an examination for a license or certificate;

35 (c) Documenting the continuing education required to renew or  
36 reinstate a license or certificate;

37 (d) Submitting a claim for payment to an insurer; or

38 (e) The practice of counseling alcohol and drug abusers or the  
39 clinical practice of counseling alcohol and drug abusers;

40 3. Allowing the unauthorized use of a license or certificate  
41 issued pursuant to this chapter;

42 4. Professional incompetence;

43 5. The habitual use of alcohol or any other drug that impairs  
44 the ability of a licensed or certified counselor or certified intern to



- 1 engage in the practice of counseling alcohol and drug abusers or the  
2 clinical practice of counseling alcohol and drug abusers;
- 3 6. Engaging in the practice of counseling alcohol and drug  
4 abusers , *the practice of counseling problem gamblers* or the  
5 clinical practice of counseling alcohol and drug abusers with an  
6 *inactive*, expired, suspended or revoked license or certificate;
- 7 7. Engaging in behavior that is contrary to the ethical standards  
8 as set forth in the regulations of the Board; and
- 9 8. The operation of a medical facility, as defined in NRS  
10 449.0151, at any time during which:
- 11 (a) The license of the facility is suspended or revoked; or  
12 (b) An act or omission occurs which results in the suspension or  
13 revocation of the license pursuant to NRS 449.160.
- 14 ➤ This subsection applies to an owner or other principal responsible  
15 for the operation of the facility.
- 16 **Sec. 7.** This act becomes effective on July 1, 2017.
