SUMMARY—Makes an appropriation for educational leadership training programs. (BDR S-1)

AN ACT making an appropriation for the implementation and operation of educational leadership training programs; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the Department of Administration to contract with  
3 the Clark County Public Education Foundation, Inc. for the  
4 implementation and operation of educational leadership training  
5 programs the following sums:

6 For the Fiscal Year 2017-2018 ..... \$1,000,000  
7 For the Fiscal Year 2018-2019 ..... \$1,000,000

8 2. The money appropriated by subsection 1 is contingent upon  
9 matching money being provided by the Clark County Public  
10 Education Foundation, Inc. or from sources other than the  
11 appropriation made by subsection 1. The Department of  
12 Administration shall not distribute any money from the  
13 appropriation made by subsection 1 until the matching money has  
14 been committed.

15 **Sec. 2.** 1. The Clark County Public Education Foundation,  
16 Inc. shall work in cooperation with the 17 school districts, other  
17 public education foundations in this State and other partners to  
18 design and implement educational leadership training programs.



1       2. The Clark County Public Education Foundation, Inc. shall  
2 use the money it receives from the appropriation made by section 1  
3 of this act to implement and operate educational leadership training  
4 programs, including, without limitation:

5       (a) Personnel for the programs;

6       (b) Resources necessary to facilitate in-person and virtual  
7 instruction;

8       (c) Research related to the design and impact of a curriculum;

9       (d) Communication with education leaders throughout the State;  
10 and

11       (e) Data systems for the reporting of participation and results.

12       **Sec. 3.** Upon acceptance of the money appropriated by section  
13 1 of this act, the Clark County Public Education Foundation, Inc.  
14 shall:

15       1. Prepare and transmit a report to the Interim Finance  
16 Committee on or before December 21, 2018, that describes each  
17 expenditure made from the money appropriated by section 1 of this  
18 act from the date on which the money was received by the Clark  
19 County Public Education Foundation, Inc. through December 1,  
20 2018;

21       2. Prepare and transmit a final report to the Interim Finance  
22 Committee on or before September 20, 2019, that describes each  
23 expenditure made from the money appropriated by section 1 of this  
24 act from the date on which the money was received by the Clark  
25 County Public Education Foundation, Inc. through June 30, 2019;  
26 and

27       3. Upon request of the Legislative Commission, make available  
28 to the Legislative Auditor any of the books, accounts, claims,  
29 reports, vouchers or other records of information, confidential or  
30 otherwise, of the Clark County Public Education Foundation, Inc.,  
31 regardless of their form or location, that the Legislative Auditor  
32 deems necessary to conduct an audit of the use of the money  
33 appropriated by section 1 of this act.

34       **Sec. 4.** Any balance of the sums appropriated by section 1 of  
35 this act remaining at the end of the respective fiscal years must not  
36 be committed for expenditure after June 30 of the respective fiscal  
37 years by the entity to which the appropriation is made or any entity  
38 to which money from the appropriation is granted or otherwise  
39 transferred in any manner, and any portion of the appropriated  
40 money remaining must not be spent for any purpose after  
41 September 21, 2018, and September 20, 2019, respectively, by  
42 either the entity to which the money was appropriated or the entity  
43 to which the money was subsequently granted or transferred, and  
44 must be reverted to the State General Fund on or before  
45 September 21, 2018, and September 20, 2019, respectively.



1       **Sec. 5.** This act becomes effective upon passage and approval  
2 for the purpose of performing any preparatory administrative tasks  
3 necessary to carry out the provisions of this act and on July 1, 2017,  
4 for all other purposes.
