Workshops were held and comments solicited to determine an estimate of the impacts on small business owners.

There will be an increase in the cost to individuals and companies participating in the Allium quarantine inspection program. The additional fees generated will allow the quarantine inspection program to continue as requested by industry. There will be no adverse effect on the public. Local economies may benefit from the sustained value of commodities produced.

The immediate and long term effects of the proposed changes are similar.

There will be no additional cost to the Nevada Department of Agriculture for enforcement of the proposed regulation.

The proposed regulation will not overlap or duplicate any regulations set by federal, state or local governmental agencies.

The proposed regulation is not required by federal law.

The proposed regulation does not include any provisions more stringent than a federal regulation that regulates the same activity.

The proposed regulation establishes a new fee.
