¹ NRS 233B.063(3) An agency may adopt a temporary regulation between August 1 of an even-numbered year and July 1 of the succeeding odd-numbered year without following the procedure required by this section and NRS 233B.064, but any such regulation expires by limitation on November 1 of the odd-numbered year. A substantively identical permanent regulation may be subsequently adopted.

NOTICE OF INTENT TO ACT UPON REGULATION

Notice of Hearing for the Adoption, Amendment or Repeal of Regulations of The Department of Business and Industry, Division of Insurance

The State of Nevada Department of Business and Industry, Division of Insurance ("Division"), (775) 687-0700, will hold a public hearing at **9:30 a.m., on December 6, 2012,** at the Division's office located at 1818 East College Parkway, 1st floor hearing room, Carson City, Nevada 89706. Interested persons may also participate through a simultaneous videoconference conducted at the Bradley Building, 2501 East Sahara Avenue, 2nd floor conference room, Las Vegas, Nevada 89104. The purpose of the hearing is to receive comments from all interested persons regarding the adoption, amendment or repeal of the regulation(s) that pertains to **chapter(s) 681A** of the Nevada Administrative Code ("NAC").

The following information is provided pursuant to the requirements of Nevada Revised Statute ("NRS") 233B.0603 and the directives of the Governor:

LCB File No. R171-12. Inland Marine Insurance.

A regulation relating to insurance; repealing provisions pertaining to coverage of certain property and interests in improvements to property by policies of inland marine insurance; and providing other matters properly relating thereto.

- (1) Why is the regulation necessary and what is its purpose? The purpose of this proposed regulation is to repeal NAC 681A.010 which was adopted in 1972. NAC 681A.010 set forth the type of property that could be covered under an inland marine insurance product at that time. Since 1972, the number of types of property that are now properly eligible for coverage under inland marine products has substantially grown, such that NAC 681A.010 is too restrictive. For example, some of the current language states that inland marine policies must exclude coverage of money and securities. However, this type of inland marine coverage is now commonly available. To list property that could or could not be covered under an inland marine insurance product would be outdated in the near future as market demands change.
- (2) What are the terms or substance of the proposed regulation? The proposed regulation repeals NAC 681A.010 in its entirety because the definition does not apply in today's market.
- (3) What is the anticipated impact of the regulation on the problem(s)? **The proposed** regulation will eliminate an antiquated definition for inland marine insurance that contradicts today's products.

- (4) Do other regulations address the same problem(s)? **No.**

- (6) What value does the regulation have to the public? There will be a broader selection of inland marine products available as dictated by market demands, not by regulation.
