R057-14 1) Relating to single-use medical devices; prohibiting a physician or a physician assistant from using or allowing another person under his or her control or supervision to use a single-use medical device more than once, for more than one patient, or in a manner inconsistent with the manufacturer's instructions; and providing other matters properly relating thereto.

NOTICE OF INTENT TO ACT UPON REGULATION

Notice of Hearing for the Adoption/Amendment of Regulation of the Nevada State Board of Medical Examiners

The Nevada State Board of Medical Examiners will hold a public hearing at 11:00 a.m., on September 17, 2014, at the office of the Nevada State Board of Medical Examiners located at 1105 Terminal Way, Ste. 301, Reno, Nevada, and videoconferenced to the Nevada State Board of Medical Examiners/Dental Examiners conference room, located at 6010 S. Rainbow Blvd., Bldg. A, Ste. 1, Las Vegas, Nevada. The purpose of the hearing is to receive comments from all interested persons regarding the amendment of a regulation that pertains to Chapter 630 of the Nevada Administrative Code.

R057-14 A regulation relating to single-use medical devices; prohibiting a physician or a physician assistant from using or allowing another person under his or her control or supervision to use a single-use medical device more than once, for more than one patient, or in a manner inconsistent with the manufacturer's instructions; and providing other matters properly relating thereto.

The following information is provided pursuant to the requirements of NRS 233B.0603:

- 1. The proposed amendments are necessary to establish Board of Medical Examiners policy and to clarify existing Board of Medical Examiners policy.
- 2. A copy of this notice and the regulation to be amended will be on file at the Nevada State Library and Archives, 100 N. Stewart Street, Carson City, Nevada, for inspection by members of the public during business hours. Additional copies of the notice and the regulation to be amended will be available at the office of the Nevada State Board of Medical Examiners at 1105 Terminal Way, Ste. 301, Reno, Nevada 89502, and in all counties in which an office of the agency is not maintained, at the main public library or alternative location, for inspection and copying by members of the public during business hours. This notice and the text of the proposed regulation are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at http://www.leg.state.nv.us. Copies of this notice and the proposed regulation will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.
- 3. The Board does not believe that the proposed amendment will have a direct economic effect on the business of the practice of medicine or the public.
- 4. Enforcement of the proposed amendment will not result in an increased cost to the Nevada State Board of Medical Examiners.
- 5. To the Board's knowledge, the proposed amendment does not overlap or duplicate the regulations of other state or local governmental agencies or any federal regulations.

6. The proposed regulation does not establish new fees or increase existing fees.

Upon adoption of any regulation, the agency, if requested to do so by an interested person, either before adoption or within 30 days thereafter, will issue a concise statement of the principal reasons for and against its adoption and incorporate therein its reason for overruling the consideration urged against its adoption.
