Rainbow Blvd., Bldg. A., Ste. 1, Las Vegas, Nevada. The purpose of the hearings is to receive comments from all interested persons regarding the adoption of regulations that pertain to Chapter 630 of the Nevada Administrative Code.

This notice and the text of the proposed regulations are also available in the State of Nevada Register of Administrative Regulations, which is prepared and published monthly by the Legislative Counsel Bureau pursuant to NRS 233B.0653, and on the Internet at http://www.leg.state.nv.us. Copies of this notice and the proposed regulations will also be mailed to members of the public upon request. A reasonable fee may be charged for copies if it is deemed necessary.

- 3. The Board does not believe that the proposed amendments will have a direct economic effect on the business of the practice of medicine or the public.
- 4. Enforcement of the proposed amendments will not result in an increased cost to the Board.
- 5. To the Board's knowledge, the proposed amendments do not overlap or duplicate the regulations of other state or local governmental agencies or any federal regulations.
- 6. The proposed regulations do not establish new fees or increase existing fees.
